The Chief's Report We have now

Dear Fellow Tribal Citizens,

I deserve 100 lashes with a wet noodle. Last month I said "times are a changin" citing Bob Dylan's lyrics and their application to the reduction of COVID-19 cases in our four-state area. Well I can't say that this month and instead I am saying deja-vu, meaning it seems that I have experienced this situation before. Due primarily to a variant, we find ourselves experiencing an increase in the area. The Wyandotte area and the Wyandotte Tribe itself has been hard hit. Those of us who have been vaccinated are particularly unsettled as we don't know quite what to do. Do we resume wearing masks everyday; do we once again isolate in our offices; do we shut down? We know the answer, as much as we dislike it-better to be safe than sorry, better to be cautious than rash.

Regardless of the status of COVID-19, we must continue on and that is exactly what we are doing. Our AOA is finally

been closed for over four months. The repair, remodeling is now finished and we are in the stage of washing, cleaning everything and returning it to its rightful place. Plans are to reopen Monday, June 28 at 11 a.m. Hopefully you know we have continued feeding our people throughout this pandemic, but not in an indoor dining setting. Instead vehicles drive through our entry way, pick up their meal or meals and toodle on home. Now they will be able to come inside, sit down, eat and visit with others. So many of our elders have missed the socializing that comes with receiving a meal. We are looking forward to the return of our elders.

We are also in full swing of our Summer Youth Program. We have seven full time students with some working in our Early Childhood Learning Center, our Construction Program, in the library and in Maintenance. These students must be Eastern Shawnee and a minimum of 16 years of age. They work 40 hours a week and are paid \$10.75 per hour. Each Friday we gather together for lunch and talk about out tribe, its history, its programs, its structure, its previous chiefs, its benefits, our people, etc. They are learning a great deal and we enjoy having them. For those of you who will be 16 and up next year, you might think about joining us. Lunch, learn, and make money all at the same time. Sounds like a pretty good deal to me.

We do have some exciting news to share with you. The tribe has purchased some additional property, 121 acres to be exact. This property is known as the Elbert property, with 7 acres of it being east of Indigo Sky on Business 60 and the remaining 114 acres located south of

Dear Eastern Shawnee Tribc of Oklahoma Tribal Members,

The Eastern Shawnee Tribe of Oklahoma recently received federal funding under the American Rescue Plan. As we budget these funds, it is important to know the needs of Tribal Members and health challenges you may have faced during the COVID-19 health crisis. We are interested in continuing to provide essential services to you, but first must know how you have been impacted by this emergency. The following questionnaire is intended for each Eastern Shawnee Tribal Member age 18 and over.

Parents and/or legal guardians of dependents under the age of 18 will need to list each dependent to receive the direct assistance. All Eastern Shawnee Tribal Members affected by COVID-19 will be eligible to receive \$2,500 per tribal member. If your dependent is under the age of 5 and not currently enrolled you have until September 11, 2021, to have them enrolled by the Business Committee. Submitting this questionnaire tells the tribe that you have been affected by COVID-19 for auditing purposes.

All responses to this questionnaire will remain confidential. Please complete and return this questionnaire NO LATER than September 10, 2021. Thank you in advance for your participation.

Business Committee Report Submitted by Justin Barrett, Treasurer

I report every month to the Business Committee the financial status of tribe and those are included in the minutes for the second regularly scheduled meeting of the Business Committee. Here is what the Business Committee has done in FY21.

Here are the balances of committed funds:

The Business Committee has appropriated money to the following areas:

- Resolution 032421-R-05 Transfers \$400,000 from the Tribe to the Eastern Shawnee Housing Authority to complete their infrastructure project. This was needed to cover the increase in anticipated costs due to the rising cost of materials because of COVID-19.
- Resolution 051221-R-03 Transfers \$2,000,000 from the Casino Reserves to the Tribe. This resolution appropriates the money for future housing projects at the Housing Authority.
 - Projects funded with tribal funding instead of grant funding have more flexibility instead of income and family size restrictions.
- Resolution 052621-R-02 Transfers \$5,000,000 from the Casino Reserves to the Tribe. This resolution commits the transferred funds as follows: \$1,000,000 to Land; \$1,000,000 to Economic Development; and \$3,000,000 to Social Services and Education.
- Resolution 052621-R-06 Allocates \$9,250,000 of the ARPA money for a Welfare Assistance Program. All tribal members enrolled before September 11, 2021, who have been affected by COVID-19 will be eligible to receive \$2,500.
- Resolution 052621-R-07 Allocated \$2,500,000 of the ARPA to the Housing Authority. This money is to be used for infrastructure and housing developments prior to funds committed pursuant to Resolution 051221-R-03.

The Business Committee has approved the following budget modifications to the FY21 budget:

 Mod 1 – Carry over Funds \$2,350,634. Approved by Resolution 122020-R-06. This moved all remaining funds from the FY20 budget and committed \$575,883 to Tribal Match, \$43,371 to Home Improvement Program, and \$1,371,430 to Capital Outlay.

- Mod 2 HIP Program Increase \$300,000. Approved by Resolution 120220-R-07. HIP was originally not funded in the FY21 Budget. The Business Committee appropriated \$300,000 to continue the program in FY21.
- Mod 3 Chief's Budget Children's Gift Cards \$10,000. Approved by Resolution 031021-R-01. The Business Committee increased the age of children to receive Christmas gift cards in November to under the age of 18.
- Mod 4 Woodlands Construction \$135,000. Approved by Resolution 031021-R-02. This budget mod allowed for a Woodlands Construction Budget to be created. \$135,000 was moved from the committed Woodlands Reserve. The remaining cost of the project of \$100,000 is funded from the Capital Outlay. This will build one new Elder's Housing duplex in the Woodlands.

I prepare a Gaming Quarterly Summary for our gaming operations and present this in open session. We are in the third quarter so I will provide you with the first quarter (Oct-Dec), second quarter (Jan-Mar), and a YTD ending in March 2021.

- Indigo Sky Casino Revenues are up year over year \$3,051,055 for the first quarter, up year over year \$8,608,281 for the second quarter, and up year over year \$11,659,336 YTD.
- Indigo Sky Casino Expenses are down year over year (\$2,483,964) for the first quarter, down year over year (\$1,136,881) for the second quarter, and down year over year (\$3,620,845) YTD.
- Outpost Casino Revenues are up year over year \$46,264 for the first quarter, up year over year \$912,263 for the second quarter, **and up year over year \$958,528 YTD**.
- Outpost Casino Expenses are down year over year (\$356,179) for the first quarter, down year over year (\$290,883) for the second quarter, and down year over year (\$647,062) YTD.


Kaylee and Kyle White (twins)

Emergency Rental Assistance Program By Shawna Hudson, Executive Administration Assistant

The purpose of the Eastern Shawnee Tribe of Oklahoma Emergency Rental Assistance Program is to provide direct financial assistance, including rent, rental arrears, utilities and home energy costs, utilities and home energy costs arrears, and other expenses related to housing. This program will make available a limited amount of assistance to households that are unable to pay rent and utilities due to the Covid-19 pandemic. This program will serve eligible households and is subject to available program funding. This program will end on December 31, 2021. **Eligibility:**

- Qualifies for unemployment or has experienced a reduction in household income, incurred significant costs, or experienced a financial hardship due, directly or indirectly, to the Covid-19 outbreak;
- Demonstrates a risk of experiencing homelessness (rent) or housing instability (utilities and other expenses); and



EMERGENCY RENTAL ASSISTANCE PROGRAM

 Has a household income at or below 80 percent of your area median (FY 2020).

Assistance Provided:

- 1. Rent
- 2. Rental arrears
- 3. Utilities (electric, gas, water and sewer, fuel oil)
- 4. Utility arrears
- 5. Internet

Eligible households may apply and receive up to three months of assistance at a time, provided funds are available. A maximum of 12 months assistance or \$3,000, whichever should come first. and resolution of personal problems or concerns that may have a negative impact on your personal or professional life. Personal problems or concerns include, but are not limited to : marital, family, alcohol, drug, emotional, stress, anger, depression, relationships, parenting, separation/divorce, job related, grief and any other areas causing concern. All counselors are Master-Level Licensed. In extreme cases, face-toface sessions may be arranged.

For confidential EAP assistance, please call (918) 594-5232 or 800-221-3976 which is a 24 hour crisis line that is answered by a licensed mental health professional 7 days a week, 365 days a year.

Tribal Members, Employees, and their dependents may receive up to six 1-hour sessions per person/per year/per problem identification. The EAP is an employee and tribal benefit that is separate from the health insurance and is already paid for by the Eastern Shawnee Tribe.

Courts "in limbo" as Ottawa County tribes await reservation rulings *By Joe Tomlinson, Monday, June 21, 2021, NonDoc.com*

MIAMI — Over the next six months, the Oklahoma Court of Criminal Appeals is expected to make decisions about whether the landmark McGirt ruling applies to as many as eight tribal nations within Ottawa County, a situation that has left the county court system "in limbo," according to District Attorney Kenny Wright.

Since April, Ottawa County District Court Judges Barry Denney and Becky Baird have each ruled several times that Native American defendants could not be prosecuted by the state of Oklahoma because the crimes in question occurred within the boundaries of historic reservations that have not been disestablished. Located in the northeast corner of Oklahoma, Ottawa County features the headquarters of nine tribal nations. "We're dealing with cases where I anticipate the Court of Criminal Appeals is going to agree with the district court that there's still a reservation there," Wright said.

In July 2020, the McGirt v Oklahoma SCOTUS ruling affirmed the Muscogee Nation as an Indian Country reservation as defined under 18 U.S.C. 1151a. Subsequent decisions from the Oklahoma Court of Criminal Appeals said the federal court ruling also applies to the reservations of the Cherokee Nation, Chickasaw Nation, Choctaw Nation and Seminole Nation in eastern Oklahoma. Only a tribe and the federal government — not the state — have jurisdiction to prosecute major crimes that occur on reservation land.

Now, Ottawa County is waiting for the Court of Criminal Appeals to decide whether the same situation applies to any or all of the Nine Tribes of Ottawa County, including the Peoria, Ottawa, Miami, Modoc, Quapaw, Seneca-Cayuga, Shawnee, Wyandotte and Eastern Shawnee. The county district court has ruled on the reservation question in



cases dealing with all of those tribes, except Modoc. Wright's office has appealed those eight rulings to the Court of Criminal Appeals.

In anticipation of the appellate court ruling, Ottawa County District Court is working with defense attorneys and the Ottawa County Sheriff's Office to lower bonds for defendants or even release them on their own recognizance. The courts will have those defendants return after the OCCA has made their decisions, Wright said.

"It's really just the people that we're absolutely sure are immediate risks to public safety that we're keeping locked up," Wright said.


Denney, who became the district judge for Oklahoma Judicial District 13 in January 2019 after 20 years as an associate district judge, told NonDoc he is worried about the potential jurisdiction change and the capabilities of the tribes and the U.S. Attorney's Office to handle the cases the state currently shoulders.

"Neither the U.S. Attorney's Office or the tribes have been used to dealing with the humongous numbers of cases that are coming their direction from the eastern half of Oklahoma," Denney said. "They're going to have to likely pick and choose what cases they are able to pursue, and many cases will simply just go unprosecuted."

NonDoc left messages for Ottawa County defense attorney Andrew Meloy, who is listed on court records as representing at least three defendants in cases that have been appealed. Meloy did not respond prior to the publication of this article.

Joseph Hallorain, a tribal attorney based in Minnesota whose name ap-

pears on filings for seven of the cases, declined to comment on the situation. Wright said crime rates are climbing in Ottawa County, which he attributed to the jurisdictional confusion surrounding the McGirt ruling. The southern half of Ottawa County south and west of the Neosho River is part of the recently affirmed Cherokee Nation reservation.

"I think we're somewhere around 16 murders this year, which normally, three or four would have been a lot, and that's because the criminal street gangs, the prison gangs are starting to figure this out," Wright said. "There are ways that this system, even once it gets into its final form, can be used to organize crimes."

Wright said he wants to see some sort of legislation — such as U.S. Rep Tom Cole's state compacting proposal — pass in Congress to lighten the caseload on many of the tribes and U.S. attorney offices.

Wright said he wants the state to retain or regain some criminal jurisdiction because he believes only a few tribes are equipped with enough resources to handle large caseloads.

"Maybe the ones that are more equipped like Miami and Quapaw, they could go ahead and compact with the state and just try and handle a little bit of it themselves, then let us deal with all the rest of it," Wright said.

However, Cole's filed compacting legislation only applies to the Cherokee Nation and Chickasaw Nation. Other tribal leaders oppose the bill, such as Choctaw Nation Chief Gary Batton, who called Cole's proposal "unnecessary."

"I don't want to see people intention-

ally victimized because of a hole in the law, because they're tribal members," Wright said. "And that's where this is going to go if Washington, DC can't fix this."

Joseph Byrd, chairman of Quapaw Tribe, said his tribe has been preparing to seek affirmation of its territory as a reservation since the SCOTUS ruling in McGirt v. Oklahoma last summer.

"[That ruling] verified something we've always known to be true, which is the boundaries of our reservations have never been disestablished," Byrd said.

Byrd said the Quapaw Tribe has worked hard to establish a court system that is prepared to ensure public safety for citizens within its jurisdictional boundaries.

"We've taken a very focused approach as to the status of our tribal court system, and the things that we needed to do in order to prepare ourselves for a McGirt decision to uphold our own reservation boundaries," Byrd said.

While Byrd believes that the Quapaw Tribe court system — established in 2017 — is ready to expand its dockets for more cases, he is also open to compacting with the state or coming to a joint agreement with the other eight tribes of Ottawa County to address the massive amount of incoming cases.

"We are open to considering all avenues at this point, whether it means compacting, whether it means doing some type of joint agreement with all of the tribes within Ottawa County. That's definitely something that I would be interested in," Byrd said. "We're going to have to come together and have that conversation pretty soon, because it's here. It's at our doorstep."



FROM THIS CORNER By Chief Glenna J. Wallace NATIVE REFLECTIONS ON CULTURE AND WATER

This month's article features a guest author, Rebecca Jim of the LEAD Agency in Miami, Oklahoma. Rebecca is Director of the LEAD Agency, an organization that promotes environmental awareness and activism in all sectors, often focusing her efforts on events/happenings affecting Native Americans. A Native American herself, Rebecca champions environmental reform, healthy life styles, commitment to preserving and sharing traditions plus making our world a better place by encouraging individuals in their endeavors of support for these concepts. She has often been called the "conscience of Ottawa County." Listen to her words.

We think of Nashville as the South, but San Miguel, Oaxaca, Mexico is really south. Two film makers came to capture the emotions felt for a wounded water by those hoping to stand for the environment, the other came because poetry brought poets to that water and to answer how that came to happen, how bad water can inspire.

If you can reach back to a time when you laid on your back and marveled at the sky and how quickly the clouds change and cover you in shade, the vastness of the sky above, or remember your first firefly, or the gift of holding a baby chick, the times you discovered the world around you, surrounded you and simply filled you with wonder.

A poem, a simple poem did that for me one afternoon as I listened to Angela Helmig read a poem in the setting it was written to depict. The flowing water seemed to rush by, but as she described a leaf on the water, I could see it and then as suddenly I could no longer see it. As her poem about water ends, I simply became that water.

There are magical places and one afternoon I heard a woman tell about when she was a little girl how her family would all go to Tar Creek to swim. I could see them there, I could see the joy water can bring in her eyes as she remembered.

I am the creek, we all are. We all can be. Those moments on the creek with Angela Helmig happened because Glenna Wallace had a vision. That vision was to capture the part of us that makes us Native, that thing that is our culture. Our culture is not our "Indian card" it is the stuff we do, what we make, how we do it, how we gather from our environment the pieces we need to use that our people were taught by their people to do. Culture is not always valued, but it is the stuff people study when our things are discovered 'neath some random earthen mound that sometimes stops the bulldozer long enough to remove a broken pot, a woven item, the things we left behind that told of what we did and who we might have been.

Glenna Wallace, Chief of the Eastern Shawnee believed our tribal cultures are alive and being lived by tribal people in Ottawa County, lived quietly by humble people, none seeking

to be discovered, each carrying forward or finding anew the slivers of what our ancestors born to us. How do you capture those movements of the clouds you saw as a child? You seek out someone who can link the stories of place to people and that is how Chief Wallace came to draw Meredith Ludwig to believe in her dream. During the thirty years she taught at Crowder College, she had heard Meredith speak story to past, engagingly, because if you are capturing culture you have to have someone who doesn't try to put fireflies in a jar, but will muster other ways to gift the future with the talents that are present now.

With the structure of an ANA Grant, Cultural Tourism in a

Nine Tribe County and a 3 year timeline in the midst of the COVID shutdown, Meredith has done it, and reached out to a lifelong friend Suzanne Carter to come with her video skills. It was these 2 women who valued Tar Creek this week and brought poetry to life there. First a Slam by Michael Scruggs, then hearing the true way words can change into art as Angela spoke of water in the last words In her poem,

Journey: Carving destiny Carry onward Open to the sea Become one with her

Aloud, the words with the water flowing as it was, I too became one with the water and more committed to speak for Tar Creek and gather the people who speak for the creek. And Filo Gomez Martinez, the Ayuuk from Quetzaltepec, he heard and filmed misty-eyed grown men who long for justice and clean water.

The list is long, the tribes are all represented, each telling their stories and

many artists like Patty Harjo-Shinn tapped to demonstrate beading, quill work and birch bark basketry. What about Richard Zane Smith's pottery, and of course an inquisitive puppet, how to tap maple trees and make syrup, language, songs. These are our people and they are showing us and the world of tourists way into the future what culture looks like and who is living it.

When you have the vision like this, and the staff to engage and endear the reluctant talent living among us, fireflies don't even know they are captured, they are gently kept for those moments then released unharmed, yet leaving a legacy for the future, say it is for tourists. But it is for us, our grandchildren who will never know these fireflies, but they will see the culture in motion, hear it and learn the past is present for them.

A lot of knot tying was involved in getting the poles ready, and we got them down to the pond without a tangled nest of fishing line.

Some special recognition goes to some of the other departments of the Tribe for a successful event. The Eastern Shawnee CCDF Department generously provided lunch and a rod and reel combo for each child attending. Thanks to Bryce Washington and the Housing Authority Board for allowing us to use the building for lunch and the pond for the morning. Eastern Shawnee Maintenance Department provided some extra help to assist kids with fish and baiting hooks. Thanks, Richard and Ryan! Jennifer Lankford took pictures for us. And thanks to Eastern Shawnee Learning Center teachers for getting the kids there and being organized and involved during the event.

I do not know if it was because it had been so long since we could have an event or because everything really did go so well, but I had a great day, and I hope the kids enjoyed it. And I hope



they were able to go fishing with their families using their new rod and reel to practice what they learned.

9th Annual Tire Collection Event *By Jacob Bachman, Recycling*

On May 20th and 21st, the Eastern Shawnee Environmental Department held the 9th Annual Tire Collection Event. This year with Covid-19 cases on a decline, we were able to assist our customers with unloading their unwanted tires from a safe distance. This event provides a public service for the surrounding communities and tribal members in the 4-state area.

During the two-day event, roughly 115 tribal members/residents dropped off 4,079 tires. On day one, 65 customers dropped off approximately 2,817 tires. On day two, 50 customers dropped off 1,262 tires. These tires will be repurposed to serve an essential role in a variety of projects. These tires will be shredded into several materials, such as playground floors, road surfacing, landscaping, and synthetic turf. As these tires take nearly 80 years to decompose, it is very important to make sure tires are disposed of in the correct manner. That is why the Eastern Shawnee Environmental Department plans to host this event annually to help reduce the number of illegal and unsafe disposal of tires in the surrounding communities.

The Environmental Department would like to thank our Maintenance Department for their help, RTR Environmental for picking up on such short notice, and The Oklahoma Department of Environmental Quality for allowing us to host this event once more.

Program Update:

Hello all –

This early summer has been so busy for our program! We have submitted the FY 21 OVC and OVW grants (to ensure emergency legal services and transitional housing assistance) as well as the FY 21 HHS Family Violence Prevention Grant that does a wonderful job funding our outreach and education as well as services not covered by our other larger grants. Lastly, we found out we were awarded HHS American Rescue Plan Act funding, which will help us think outside the box and meet our clients varying COVID needs.

I'd like to take a moment and let our new Court/Sexual Assault Advocate (Caren Hall) introduce herself.

"I would like to introduce myself. My name is Caren Hall and I have been hired as the new Legal and Sexual Assault Advocate for Haven. I started my career in Public Service in 2004, as an EMT and 911 Dispatcher which lead me to becoming a full-time police officer. As an officer, I have proudly served the Ottawa County community for the past 10 years, most recently with the Quapaw Nation Marshals.

On average, nearly 20 people every 60 seconds are physically abused by an intimate partner in the U.S. This equates to more than 10 million women and men each year. I look forward to using the knowledge and experience I gained working in law enforcement over the past 17 years, to provide survivor-centered advocacy, help them navigate the legal system, and assist in enhancing their safety.

On a personal note, I have 3 amazing children, 2 that are still in the nest, and the oldest is off, making his own path in this crazy world we live in. In my free



time, well honestly, I'm not sure what that is, but my husband and I always enjoy spending time with family and friends".

This month we are going to talk about Elder Abuse to remind everyone that Haven advocacy covers all forms of violence including elder abuse.

What is elder abuse? How can it be recognized?

Elder abuse can take the form of domestic violence, such as psychological and financial abuse. However, elder abuse is often not as readily identified as abuse by other family members and workers.

Physical abuse

- Inappropriate handling
- Taking away or controlling an aid such as moving a wheelchair or walker out of reach
- Using medication to sedate
- Providing care in a cruel or rough manner

Sexual abuse

- Sexual assault
- Force or coercion to take part in unwanted sexual activity
- · Withholding needed care in

exchange for sexual favors

Psychological/emotional abuse

- Denying the right to make decisions due to their cognitive state
- Convincing the older person that they couldn't cope without the caregiver
- Denying access to 'small pleasures'
- Talking about 'how hard it is to provide care' in front of the older person

Financial abuse

- Using a power of attorney to withhold money or misuse finances
- Not allowing the person to keep or carry their own money
- Withholding knowledge of their bank account balance or household bills paid

Neglect

- Poor hygiene or refusing to wash the older person
- Withholding medication, personal or medical care
- · Withdrawing care or equip-

ment that immobilizes or leaves the older person without a way to call for help

- Refusing or delaying assistance following a personal accident or spillage
- Receiving the career's pension without providing the care

I'm worried about someone – what can I do?

If you suspect that a friend, family member, neighbor—or anyone else—is suffering from elder abuse, there are steps you can take to help. As with other forms of family violence, victims/survivors may be unwilling or unable to tell you about their abuse. Ask direct, non-accusing questions, listen and believe what they tell you, and support them to make their own decisions. Respond in a caring manner. You may be the first person they have ever told about the abuse. Understand that it was a difficult decision to do so.

Some questions you could ask:

- Are you afraid of x or anyone else at home?
- Has anyone threatened to put you in a nursing home?
- Are you being mistreated?
- Do you feel safe within your relationship?
- You mentioned that x loses their temper. Can you tell me more about that?
- Do you feel safe in your home?
- You seem to be concerned about x. Does their behavior ever frighten you?
- I see a lot of people with injuries like yours. Sometimes they're a result of a family argument. Has this ever happened to you?
- I've come across several people who are victims of abuse and so now I make it a habit to ask people if they are abused or know anyone who has been abused. Do you

- Both parents must be working or attending school full time.
- Your children are ages 2 weeks to 12 years old or ages 13 to 18 and are not mentally or physically able to care for their self.
- You must live within the following States and counties listed:

ARKANSAS – Benton, Carrol, Crawford, Franklin, Madison & Washington. KANSAS – Allen, Anderson, Bourbon, Cherokee, Crawford, Labette, Linn, Montgomery, Neosho & Wilson.

MISSOURI – Barry, Barton, Cedar, Christian, Dade, Greene, Jasper, Lawrence, McDonald, Newton, Stone & Vernon.

OKLAHOMA – Adair, Cherokee, Craig, Creek, Delaware, Mayes, Muskogee, Nowata, Ottawa, Rogers, Tulsa, Wagoner & Washington.

If you do not live in one of the states and counties listed above, check with the State or Tribal CCDF Programs in your area to see if they can help you.



Meth and Suicide Prevention Initiative



What is MSPI?

The Meth and Suicide Prevention Initiative (MSPI) provides grant funds for innovative tribal programs that focus on methamphetamine and suicide prevention and treatment. The initiative includes research, education, resource management and behavioral health referrats.

We'll be working to develop community-based, culturally sensitive programs. These programs include meth and suicide response teams. We'll coordinate services among law enforcement, medical professionals, our tribal departments, and the community to address the underlying causes of meth abuse and suicide.

A significant component of the initiative will be education programs for children, youth, caregivers and teachers. We'll also be putting into place a method of referring people affected by meth and suicide to facilities which can help them through the recovery process.

VITAL STATISTICS Direct to Vendor Claim Form

There are times when everyone faces a struggle when they can't afford to pay for dental work, get a new pair of glasses or pay a medical bill without having to use Care Credit or take out a personal loan. Instead of placing yourself in debt, you can have Social Services pay for the services directly to your health care provider from your health care or disabled/elder benefit. Complete a Direct to Vendor Payment Expense Claim form and attach your ORIGINAL billing statement.

HOW TO REQUEST REIMBURSEMENT

Use this form to request reimbursement under the Health & Social Service program. Remember, you should first submit health care expenses under your primary health insurance or other health care plan you may have before you request reimbursement. Use this form only to request reimbursement for:

- Allowable expenses covered, but not fully reimbursed by any benefit plan. Attach a copy of the plans Explanation of Benefits (EOB) statement or itemized receipt from your provider
- Allowable expenses not covered by any benefit plan. Attach bills or receipts which indicate the name and address of the provider or service and description of the product or service provided

Step 1: Fill out the form

Please type or print. Complete all areas of "Tribal Information." You will receive an email confirming receipt of your claim.

Step 2: Fill in your expenses – you can use one line to show a total of multiple expenses in the same area

Complete all sections of the form.

Step 3: Attach supporting documentation described under either A or B below:

- A. Explanation of Benefits form (EOB): This is the form you typically receive each time you or a health care provider submit medical, dental or vision claims for payment from your insurance plan. The EOB will show the amount of expenses paid by the plan and the amount you must pay. For expenses that are partially covered by you or your dependents insurance plan, you must attach the EOB.
- **B.** All other expenses: For medical expenses not covered at all by any insurance plan, burial, school expenses and utilities, your claim must include acceptable evidence of your expenses. Acceptable evidence includes receipts which contain the following information:
 - Type of service or product provided
 - Date expense was incurred
 - Person or organization providing the service and product
 - Amount of expense

Step 4: Read the certification, sign and date the form where indicated

Step 5: Submit your form

Place the form and the supporting documentation into an envelope, apply the correct postage and mail to Health & Social Services, 10100 S. Bluejacket Rd., Ste. 1, Wyandotte OK 74370. Keep a copy of your completed form and receipts for your records.

Please remember that Social Services has a minimum reimbursement of \$25.00 Type of Supporting Documentation:

Itemized receipt from your medical, dental or vision provider or pharmacy----Explanation of Benefits (EOB) from your insurance company or health care provider----Prescription receipt that shows the date, name of the patient for whom the item is prescribed & the name of the item----Utility account summary

CHIEF'S REPORT:

THANK YOU NOTES: A thank you note from Wayne and Monica Bettis was received following the recent loss of a family member. And a thank you note from the Wyandotte After Prom Party Committee for the donation of \$100.00.

DONATION REQUESTS: Chief reports she had no large donation requests and was able to handle the ones that she

did receive from her Budget.

OPENING INFORMATION: Buildings were opened one week ago on Monday, May 3, 2021. Masks are still required in all buildings. Tribal members are allowed into the buildings but must wear a mask.

UPCOMING SCHEDULED EVENTS:

The Summer Youth Program will open at the Library each Wednesday at 9:00 a.m. beginning June 1, 2021 thru August 13th, 2021.

The CCDF and ICW Summer Pool Party has been scheduled for June 25th, 2021.

Culture Camp will be held August 4th thru August 6th, 2021.

Children's Pow Wow is scheduled for Saturday, August 7th, 2021. The Culture Camp is scheduled the three days before the Children's Pow Wow so that the children will be here for the Children's Pow Wow.

The Pow Wow will be held at the normal time which is the third weekend in September.

DIRECTOR REPORTS:

Accounting - Karen Allen reports that thru COVID-19 and from the ARPA funds that we already have, altogether we have collected \$20,504,707.00. We have spent and have remaining \$12,000,000 and most of this will go automatically to programs in the tribe based on formula spending. Reporting on Grant Notifications and Release of Funds - CCDF has \$338,981.00 in additional funding, they have \$3,092,855 funding that goes until 2024 so they have three years to spend it. American Rescue Plan CCDF has \$4,882,761 that ends September 2023. There are stipulations on these funds that state that 80% of the funds must go to services to children who are attending various daycares throughout the area and will take 3 million plus of these funds.

Cost of Payroll - \$709,819.00, Overtime - \$571.08, 401K Contribution - \$15,482.00, TOTAL COST OF PAY-ROLL - \$889,324,75 and of this amount 33% was funded through grants.

AOA - The building is still closed, and they are still doing the drive thru pickup. Meals served remain consistent with a low of 101 meals and a high of 147 meals. Car Bingo has resumed on the Bordertown Parking lot. Also, all tribes are going together for a joint party sometime in June. The date and further information will be provided soon. CCDF - Reports they are now serving 210 children in 59 Daycares which will get 80% of the \$4 million previously discussed. A parenting class is scheduled for May 24th, 2021. This class starts at 6:00 p.m. and will be held at Annex. Brandon McCombs, Counselor thru the SAMSA grant will be the speaker. The class lasts until 9:00 p.m. and childcare will be provided. In February 2021, \$132,758.00 was paid for childcare subsidy. Almost \$17,000 of that money was paid to our Early Childhood Learning Center.

Chief Wallace responds to Treasurer Barrett's previous question of "What is the amendment to our major renovations application?". Chief Wallace responds that they have been waiting for an official approval but have been given oral approval for quite some time. States she received the official approval in writing at 9:15 p.m. last night. This is for the Splash Pad and grounds. There will be three shelters built for activities, crafts and classes. The playground will be two tiered with access to the lower tier by use of slides for children and stairs for adults. A Noah's Ark has been donated by a daycare that closed in Miami. The Ark was provided to the Daycare by 3 tribes through their CCDF funds so that Ark must come back to one of those tribes. We are the only tribe with a day care, so we get the Ark. The Ark will be placed on the lower tier of the playground. Water runoff from the entire 10C Campus has created a ditch with a stream running through. A ditch drainage system will be installed and covered up to make it all level. Hoping to have it completed this summer.

EDUCATION – Paid 37 Undergraduate and 1 Graduate tuition fee, 1 Vocational tuition fee. There was one Undergraduate Graduate Award. Total funds spent on Education - \$113,000.

SPECIALIZED PROGRAMS - We funded 5 Hardships, 13 Home Improvement Projects, 1 Temporary Social Security/Disability, 5 Down Payment Home Assistance and 1 Emergency Assistance. The total for these specialized programs was \$79,622.74.

We will be sending representatives from the Education Department to all the area Graduation Exercises that we are aware of where we have tribal members who will be graduating to present their scholarships in person. If you have a family member who will be graduating in the 50- mile radius, please send us their name and information.

ENVIRONMENTAL DEPARTMENT - reported working with the Wyandotte Fire Dept. on Sprinkler System at the AOA and the fire alarm situation at the Charles Enyart Building. Also reports on the things they have been doing with the water quality and how they observed Earth Day. Flower Planters that could be colored and sunflower seeds were presented to the children at the ECLC. They report water quality is tested once a year per guidelines and uploaded for public view. Also reported on the Feral hog grant. Now that deer hunting season is over trapping has resumed for the Feral hogs.

HAVEN – Haven is our Family Violence and Violence - Prevention Program. They reported 98 crisis calls this month. and provided daily advocacy 535 times. They detail all programs and advertising they participate in, the trainings and webinars they participate in. Haven has been offering legal services for roughly six years. These services are extremely important in allowing women to leave their abusive situations, providing legal services to fight for legal custody of their children and to file for divorce and able to begin life again. Eastern Shawnee Tribal members have this service provided for them regardless of where they live. New employee Karen Hall started this week.

HR REPORT for April - Will be hiring an Assistant ECLC Director, have interviewed two candidates and are currently doing background checks. Open Positions - for Summer Youth 16 years of age and up, for ECLC Summer Program Teachers and Teacher Assistants (this is temporary employment), and 1 part time and 1 PRN position for Travel Center Customer. Service/Cashier. Interviews to be conducted this week. An opening for 1 full time surveillance agent. New employees - Sandy Goodman, Cultural Tourism Transcriptionist, Karen Hall, Haven Advocate, Cole Dixon EPA Tribal Youth Initiative Intern and Gracie Brannum, Abigail Long and Matthew Moore for the Summer Youth Program.

George Captain Library Print Shop provided a page of visuals where they will transform the short bus into a bookmobile. They are currently remodeling the inside and will have the bus wrapped indicating the program and travel around this area to provide services. This has been funded by their grant. They also have a summer youth program that begins every Wednesday starting at 9:00 until 10:30 a.m. at the Library. They have an Oklahoma Historical Society Grant, and they would like a picture of everyone who is on the 1938 Base Roll. To be a member of our Tribe you must be able to prove you are related to a member of the 1938 Base Roll. The new printer was delivered this week.

Eastern Shawnee Tribal Police Department – report their K9 service has resumed in several area schools. Officers have been giving yearly Taser Recertifications. Officers calls for services resulted in 19 criminal/civil offenses during the month including larceny, drug offenses, traffic, assault, a stolen vehicle, 1 unattended death and warrant arrests.

Budget wise we have two programs that

might need attention. Unfortunately, one of those is our area program. We have a budget of \$70,000 and we have only \$14,000 remaining. The Elder Crisis Committee has a budget of \$95,000 and they have spent \$65,000. Healthcare has \$922,000 remaining and Utility Assistance has \$967,000 remaining in the program. Tags 51 renewals, 40 new tags, and the revenue for the month was \$13,081.00. Our tribal enrollment is now up to 3,649 people.

WELLNESS CENTER reports almost 4000 visits. (3,994 actual)

About 500 attended the Easter Egg Hunt. They had 8 birthday parties at the Wellness Center. The Horse Event held on the trails had 33 riders participating. 184 Employee memberships, ESTO memberships – 213, Family memberships – 318.

ICCW – 42 children are being treated in the Indian Child Welfare Department. They are 14 parents, and 6 Tribal youth are being seen by our Counselor Brandon McCombs. 9 ICW families are participating in the food basket distribution. The new Administrative Assistant is Brandy Miller. She started April 12, 2021 and she has a Bachelor of Arts Degree in Communication from Texas A & M.

HIP REPORT – 45 jobs have been completed since Oct. 1st. Everything in FY18 and FY19 has been completed. All that remains is FY20 and the current year of 21. In FY 20 there are 7 homes remaining to be completed. In FY21 we have 17 applications that are not finished. There are seven more people who have submitted incomplete applications. If these applications are completed, we will only be able to accept 6 more applications. This work is limited to \$10,000 and you can apply only once in 10 years.

ARPA TREASURY INFORMATION – A conference was scheduled through use of zoom a couple of days ago, providing only a two- hour notice. A formula has been provided to allow for distribution of the \$20 billion. 1 billion

will be equally divided between 574 tribes resulting in a 1.7 million payment to each tribe. 65% of the remaining 19 billion will be distributed according to enrollment data submitted by the tribes. The remaining 35% will be distributed based upon how many employees we have including all our businesses as well as government and administra-Chief Wallace was one of 85 tion. Chiefs that were given the opportunity to speak during one of the conferences. Chief Wallace read a letter to the Business Committee that she wrote to the Honorable Jed Yellin, Secretary of the US Department of Treasury, concerning the error resulting in the underfunding due to the incorrect number of tribal members used to calculate the payment. We received \$660,355.00 based upon the use of Hud's use of IHBG figures which resulted in our tribal membership being reported at 221 instead of 3,554. According to the Harvard Report we should have received approximately \$7 million dollars.

QUESTIONS ABOUT POLICE VE-HICLES – A Dodge Charger tagged 1005 was loaned to the Commerce Police Department in July of 2016, a 2011 Tahoe was given to Indigo Sky Security in Dec. 2016, a 1991 Chevy bus was given to the Print Shop in Sept. 2020, a 2007 Ford Expedition was given to Purchasing around 2016. 12 vehicles were traded in 12-19-16, they were all 2013 Ford Taurus Sedans and were traded to purchase new vehicles.

AOA Update – still unrepaired and the sprinkler system is still unrepaired. Will be at least June 1, 2021 before they reopen.

EAP – This is the Employee Assistance Program to serve the needs of employees, tribal members, and family members who may be dealing with a substance abuse problem, suicide or mental health needs. We have chosen the direction of telehealth. We have contracted with the insurance company that serves the tribe and this employee assisted program is a counseling service that can be utilized in all 50 states of the United States. You can call a number in Tulsa, Oklahoma, and they have licensed counselors that you can contact up to six times in one year free to talk about any problem that you are having with mental health. This is open to all tribal employees and open to all tribal citizens regardless of where you live. It is also open for your family. If you want to do face to face counseling sessions. they will tell you where the Counselor is located or you can do the teleconference. These are 6 one- hour sessions. If you have a different problem arise, and your 6 times have been used you can start a new counseling session for 6 more times. This information will be put in the Shooting Star, the reader board and you can call Sharon Farris who is our Benefits Director, and she can provide you with the information you need.

GRANT INFORMATION -

SAMSA GRANT – James Sullivan, Project Director - Received notification last week that this grant has been increased by an additional \$515,000. This is a grant lasting twelve months and we have until a date in June to send to them how that money will be utilized. Meeting tomorrow to begin plans on how these grant funds will be utilized.

CCDF has been allocated almost \$9M. This money must be spent on children up to the age of 12. Current interest if approved would be to build a new building. The current building does not have the facilities needed. A new building would be built next to the current building and then all services that have to do with the tribe would be consolidated in the existing building.

CDC GRANT - \$211,000 Grant used for making sanitizing liquid that we use to spray our buildings (walls, floors and ceilings). Also have a contract for equipment with Bart & Bart for Hand Sanitizing Gel and we have a contract to purchase equipment to run an electric current through salt water to make

hydrochloric acid that we use in cleaning. It costs 3 cents a gallon compared to \$60.00 a gallon for what we currently use to clean with. Per representative from the company this solution can also be used to treat bedbugs. This grant also paid money for a consultant from Innovative Gaming Solutions to do a complete emergency plan for the Tribe, the Casino and every building is being considered. This will also include any other major pandemics so that next time instead of having to write policy day by day it will already be prepared. This would include active shooters, tornadoes and the railway that runs within feet of our offices here. This grant is up June 9th and we have only \$26,000 remaining in this grant.

CDBG GRANT is a \$900,000 grant that is not due until September.

This is National Police Awareness Week and Chief Wallace thanked the Tribal Police Officer in attendance at this meeting.

Chief Wallace also acknowledged many thanks from tribal employees for their recent raises.

Beginning next week, the Pfizer Vaccine for children 12 and up will be given at Bearskin Clinic.

Chief Wallace announced that the Tribal Administration meetings are held as follows:

1st Thursday each month is the Director's Meeting at 8:30 a.m. in the Annex. 2nd Thursday each month is Think Tank and it is held at 8:30 in the Bluejacket Building.

3rd Thursday is the GRC meeting. An invitation was extended to attend these meetings as they are always open.

The Food Bank Distribution is still occurring until September. Currently serving 80 families and continuing to grow. This is a service for those that are having trouble purchasing food and have an income below \$35,000. But no one is refused food that is a tribal citizen and says that they need food.

Summer Solstice will be observed Sat., June 19th and Sun., June 20th, 2021 at

Serpent Mound in Ohio. A request that all three Shawnee Tribes be present if possible has been sent out from Ohio. Chief will be passing this information on to the Cultural Division of the Tribe. RESOLUTIONS

Grants received in advance - \$133,000. Tribal Administration has not received the additional transfer from the Casino so that will not be reflected on this report. The Casino report has been given by Melanie Heskitt, General Manager. Tribal Accounting:

American Rescue Plan Act money has been received. The tribe received \$18,609,975.43. This was based on the first \$1 billion dollars divided equally among all the tribes and the rest is based on enrollment. 65% of ARPA funding is based on enrollment. 35% will be based on employee count for all tribal entities. The funding will arrive in June.

Indigo Sky on Highway 60. The 7 acres on Business 60 are in our jurisdictional area as is the highway frontage portion of the 114 acres across the street. However the back part further south is located in Wyandotte jurisdiction. We hope to pursue placing the property in trust but first comes acquiring water, sewer. That we are working on as fast as we can.

I remind you that we have implemented several new programs, new benefits during this COVID time period. We have rental assistance, energy assistance, water assistance, a food distribution program, mental health counseling assistance to name a few. I have explained all of them in previous letters with the exception of energy assistance. This program is specifically for tribal elders and the total amount of funds in this program for the entire tribe is limited to \$10,000. We are purchasing fans, window air- conditioners, etc. and will be distributing them soon. Contact Amber Mittag or Stacie Triplett for information regarding this program. For all other programs, contact Shawna Hudson or Chief Wallace.

And of course the benefit you want to hear the most about is the ARPA program where the tribe has voted to distribute its second stimulus check. The Tribe will receive two checks, one based on tribal enrollment data and the second based upon employment data. We have received our first check, a total of 18.6 million which must be used by the end of 2024. Half of that or 9.3 million has been allocated for distribution to tribal citizens, \$2500 to each regardless of age if you have been affected by COVID. A questionnaire has been mailed to each family we have a mailing address for and that questionnaire has also been placed on our website. Many of you have already returned that questionnaire and are awaiting your payment. Please remember the CARES Act and the American Rescue Plan Act commonly referred to as ARPA are two different

Acts, two different guidelines, two different requirements. Unfortunately in ARPA we have had a hiccup regarding dual enrollment. The question has been asked If a person is enrolled in more than one tribe, is that person eligible to receive funds from only one tribe or from both or from three or four tribes, depending upon how many tribes where that person is enrolled. ARPA's interim guidance suggests funds may have to be repaid in certain situations. We simply need to protect the tribe and make sure if funds must be paid back because of receiving them from more than one tribe, it should be the person receiving the funds who must return the funds and not the tribe. Your signed questionnaires with responses will be the documentation we need.

Therefore, because the original questionnaire did not include a question regarding dual enrollment, we have had to prepare a second questionnaire adding that question. If you submitted the original questionnaire, you will need to resubmit. Use the new questionnaire on our website or call and ask that a new one be sent to you.

For those of you who have already submitted questionnaires that had the dual enrollment question on the form, you do not need to resubmit.

We apologize for this error and for the delay it may have caused in receiving your funds. Our interests were totally centered around making funds available to tribal citizens as soon as possible. Tribal administration employees have been authorized to work overtime to process your submissions as quickly as possible. Hopefully we will be able to begin cutting checks by Monday, June 28. If direct deposit is utilized, funds could be in your bank account Tuesday, June 29. Again, we apologize for any inconvenience this has caused you.

Activities continue to be scheduled, including Elders Dinner Friday, July 16 at 5:30 at the AOA on Highway 10C, Children's Cultural Camp scheduled for 3 days, August 4, 5,and 6 followed by the Children's Shawna Stovall Back to School Powwow scheduled for Saturday, August 7. A special event will be held Thursday, September 16 in the evening at the Bordertown Parking lot where a massive outdoor screen will be for showing the videos of the 9 federally recognized tribes in Ottawa County made possible by our ANA Grant. This event will be followed by the Annual Powwow which remains the third weekend in September which is 17, 18, 19 with History Summit following on Monday, September 20. And of course events will be scheduled during Powwow weekend such as the Tecumseh Run, the Saturday morning walk and other offerings. Hope to see you at many of these.

I want to remind everyone that our filing period for being a candidate in the upcoming election ends Friday, June 25. Since that time has not arrived at the time of this writing, I am unable to provide you the names of the candidates. Positions we are voting on this year are Second Chief and Second Council. You will be receiving information regarding the election from the Election Board. Be sure to vote because each vote matters. And to the candidates I urge everyone to conduct a positive race.

I also need to remind everyone that General Council will be held at Indigo Sky Event Center this year and is scheduled for Saturday, September 11. A meal will be served prior to the meeting. Mark your calendars to attend and participate in the business of your tribe. As always, it has been my honor to serve as your Chief. CONSTITUTIONAL REVIEW

In the summer of 2019, a ten-person group of tribal members comprising the Constitutional Review Committee began a year-long review of the current Constitution of the Eastern Shawnee Tribe of Oklahoma. After many discussions and meetings, several suggested revisions were presented to the Business Committee for review. In order to solicit the maximum amount of tribal participation, the proposed revisions, as well as explanations for the proposed revisions, have been placed on the tribal webpage. These revisions can be found by going to www.estoo-nsn. gov, clicking the services tab, then clicking the tribal government tab. All tribal members are encouraged to review the proposed revisions as well as submit additional questions, comments, and suggestions through the tribal webpage.

PATENT AND TRADEMARK

In the fall of 2019, the Business Committee began the process of registering our Name and Seal with the United States Patent and Trademark Office (USPTO). The decision to seek the protection provided by the USPTO came after many discussions regarding misrepresentation and cultural appropriation. Specifically, the Business Committee was committed to preventing the loss of control over our culture and the names and insignia associated with it.

The growth of the internet/technology has presented new opportunities for cultural appropriation and misrepresentation and trademark protections are a proactive measure to deter individuals trying to profit from indigenous cultural property. This protection is in addition to federal statutes already in place to provide recourse, such as the Native American Graves Protection and Repatriation Act and the Indian Arts and Crafts Act.

While the stewardship of protecting the trademarks lies with the Business Committee, it is well understood that we are a proud people and naturally want to display the pride we have for our culture. Therefore, trademark permission requests are available on our Tribal Webpage and can be submitted for limited and specific use of the trademarks.

INTER-TRIBAL COUNCIL FOOD DISTRIBUTION

We are a federal program that provides commodity foods to low-income households residing in approved areas. To be eligible to participate, the household must contain at least one person who is a member of a federally recognized tribe. Eligible households are certified based upon income and resource standards set by the federal government.

The area served by the Inter-Tribal Food Distribution Program is: a portion of Ottawa, including the city limits of Miami east of the Neosho River and a portion of Delaware county in Oklahoma, Cherokee and Labette Counties in Kansas, and Newton, Barton, Jasper and McDonald counties in Missouri.
