

#### § 17.401 PURPOSE AND AUTHORITY

A. The purpose of this Ordinance is to establish and authorize a Security Department for Indigo Sky Casino & Resort and Outpost Casino.

# § 17.402 DEFINITIONS

- A. Business Committee The body of elective officials who make up the Legislative Branch of the Eastern Shawnee Tribe of Oklahoma, consisting of the Second Chief, First Council, Second Council, Third Council, Secretary, and Treasurer.
- B. Chief The elected representative of the Executive Branch of the Eastern Shawnee Tribe of Oklahoma.
- C. Eastern Shawnee Tribe The Eastern Shawnee Tribe of Oklahoma
- D. Elected Officials Representatives of the Eastern Shawnee Tribe of Oklahoma who have been chosen through the election process as outlined in the Constitution of the Eastern Shawnee Tribe of Oklahoma.
- E. Emergency Response Plan The Eastern Shawnee Tribe of Oklahoma Casino Emergency Response Plan as approved by the Eastern Shawnee Tribe of Oklahoma Gaming Commission.
- F. LEO Law enforcement officers.

#### § 17.403 ESTABLISHMENT OF THE SECURITY DEPARTMENT

- A. The Business Committee hereby establishes a Security Department for Indigo Sky Casino & Resort and Outpost Casino that shall be independent and separate from the Eastern Shawnee Tribal Police Department.
- B. The Security Department shall be organized under the General Manager and Director of Security.
- C. The Security Department shall not at any time present themselves as law enforcement officers (LEO).

# § 17.404 DIRECTOR OF SECURITY

A. The Director of Security shall be authorized to adopt policies and procedures in compliance with tribal laws and regulations.

- B. The Director of Security shall be responsible for the Emergency Response Plan for the health and safety of employees and guests at Indigo Sky Casino & Resort and Outpost Casino.
- C. The Director of Security shall be authorized to adopt policies and procedures for the use of force and employee firearms in compliance with tribal laws and regulations.
- D. The Director of Security shall oversee all activities that affect the security and safety of Indigo Sky Casino & Resort and Outpost Casino.

### § 17.405 LIBERAL INTERPRETATION/SEVERABILITY

- A. The provisions of this Ordinance shall be construed liberally to affect the purpose(s) contained herein. Any section or subsection headings contained herein shall not be deemed to govern, limit, modify, or in any manner affect the scope, meaning, or intent of the provisions, of any section or subsection of this Ordinance.
- B. The provisions of this Ordinance are severable and of any part or provision hereof shall be held void by appropriate judicial authority, the decision of the court so holding shall not affect or impair any of the remaining parts or provisions of this Ordinance.

# § 17.406 REPEAL OF PREVIOUS ENACTMENTS

A. This Ordinance hereby repeals all previous resolutions and ordinances that are inconsistent with this Ordinance regarding a security department excluding any Emergency Response Plans.

# § 17.407 EFFECTIVE DATE

A. This Ordinance shall become effective upon the signature of the Chief.
