The Chief's Report . . .

Hatito Fellow Tribal Citizens,

I am writing this letter early this month as I will be leaving Thursday the 16th of June to attend the Darke County Ohio's opening and dedication of its Trail of Art near Greenville, Ohio with the unveiling of the initial artistic piece, a sculpture of Tecumseh. Following two days there I will be going on to Serpent Mound for observance of summer solstice, staying there three or four days and then returning home the 22nd or 23rd. It is likely to be an exhausting seven or eight day trip but so culturally and historically rewarding. I am looking forward to it but keep thinking of all the details I must get taken care of before leaving, including writing this letter for the Shooting Star.

Another cultural happening in Ohio is being developed now. This is the development of an Ohio State Park honoring Tecumseh and the Shawnee tribes. In the Eastern Shawnee Tribe's homeland of Ohio, the state of Ohio has purchased an iconic piece of property housing an old motel known as Tecumseh Motel. This is a motel located in the area where Tecumseh was supposedly born. Several other places in Ohio also claim to be the site of Tecumseh's birth. At the Tecumseh Motel site, however, there are several signs erected many, many years ago by the Ab-

sentee Shawnee Tribe acknowledging Tecumseh as their forefather. The state is in the process of having that property turned into a state park and build a multimillion dollar museum honoring Tecumseh and the three federally recognized Shawnee tribes, all located in Oklahoma. Of course we are one of those tribes. Representatives from the three tribes have been having zoom calls regarding this museum for several months. Currently it is referred to as Old Town Historic Project, located near Xenia.

The director has been named for this project and it is Talon Silverhorn, an Eastern Shawnee citizen originally from Miami who had been employed at Williamsburg. The governor of Ohio is in full support of this project and the plans have grown from a possible two million dollar project to a three storied museum costing eight million or more. Those plans are most exciting. Certainly the history of the Shawnee tribes in Ohio will be covered, as well as focusing on some of the lesser known individuals impacting that history. Various themes will be included. One of the major aspects of the museum will feature tribes as they are today. This is where all of you come in. We need excellent pictures of our departments, our events, our buildings both exterior and interior along with any action shots of people utilizing, experiencing our services. Think about this. We will be looking for pictures, items here but certainly invite any and all of you to share items, information you feel appropriate to represent the Eastern Shawnee.

The same is true for artwork. We have many talented artisans in our tribe. We need examples of artistic creations from our tribal members. It could be beaded moccasins, paintings, drawings, carved flutes, beaded belts, earrings, shawls, sculpture, tribal quilts,

BUSINESS ANNOUNCEMENTS

- The Business Committee has decided to close the Eastern Shawnee
 Travel Center at the end of June.
- We have engaged Klaus Robinson to conduct two feasibility studies for us. One is for Indigo Sky Casino and Resort. The second is for economic development opportunities on the Elbert property. We should have those back for us to review in July.

CASINO OPERATIONS

Our gaming operations continue to do well. We were able to transfer \$14.5 million to the tribe that was not budgeted in May. We committed those funds to a \$10 million Operating Reserve and \$4.5 to a Maintenance Reserve. Based on financial data we are doing better than 2018, 2019, and 2020. 2021 was a recordbreaking year across the country for the gaming industry both tribal and commercial. Some months we are exceeding the 2021 numbers and some we are not.

The Business Committee has taken a proactive step to commit funding to reserves the past two years in anticipation of an economic downturn. In 2021 we committed \$7 million to reserves and this we year we committed \$14.5 million.

ESTE UPDATE

We are continuing to wind down Burggraf Corporation operations. All the N2N companies have been dissolved. Burggraf is transferring \$232,670.80 to ESTE to pay off the loan and interest for the loan ESTE gave Burggraf in July of 2015. ESTE is then transferring this money to the tribe. This money will be

deposited into the tribe's economic development account.

BUDGET MOFICATIONS

The Business Committee approved a \$200,000 budget modification for the HIP Program a few months ago. The last report we received is that there are still open spots in this program. We also approved a \$20,000 budget modification for the Hardship Program since it ran out of funding last month.

ANNOUNCEMENTS

- Elder Crisis.- As most of you know Bobby BlueJacket passed away last month. I want to thank his family for his service and dedication to the tribe for all these years. Shawn King has been appointed by the Business Committee to Chair the Elder and Disabled Criss Committee.
- Pow Wow Committee The Pow Wow Committee has notified the Chief and the Business Committee that they will be getting the flyers out soon. Pow Wow dates are September 16-18.

ACKNOWLEDGEMENTS

Thank you to Rachel Holcomb and the Education/Specialized Services Department for holding a voter registration drive at the beginning of the month. This was held to increase registration for local, state, and federal elections.



PERSONAL INFORMATION

Once again I am asking for your vote to continue being your Chief. My personal information has not changed. I was born in Ottawa County, Oklahoma and have lived within 15 miles of my birthplace my entire life with the exception of 3 years when at age of 9 my family and I were migrant workers on the west coast moving from town to town, field to field, patch to patch, school to school, living in the back of a flatbed truck or an abandoned barn or even sleeping in actual pig sties at a green bean operation. These formative years impacted me greatly, teaching me to set goals, develop a work ethic, work hard, accomplish these goals, accept accountability, treat each person with dignity, be optimistic, strive to be a positive change agent and take pride in my work. The first female in my family to graduate from high school, I attained a BA, MA, EDS and worked at Crowder College for 38 years being promoted from instructor to department chair to division head to interim Academic Dean where I managed multi-million dollar budgets and supervised large staffs annually. Interspersed with those duties was writing/directing grants and director of travel which enabled me to visit more than 70 countries, learning from each country. I have lived on the same farm for more than 50 years, lost my husband almost 35 years ago, have 3 grown children, 7 grandchildren and 11 great grandchildren. I am able to devote my full attention and time to the tribe, regularly working 60 or more hours per week.

QUALIFICATIONS IN BRIEF

I have been Chief since 2006 and served on the Business Committee 17 years prior to my being elected Chief. I have educational experience, financial experience, ethical character, stability, history with this tribe, and most of all love and concern for what is best for both our tribe and our people. I have managed multi-million dollar budgets with consistent flawless audits, led in the addition of 9 duplexes or 18 units housing our elders, oversaw the birth of our Early Childhood Learning Center where in 6 years we have gone from an enrollment of 20 to approximately 120 children each day, expanded our Wellness Center programs where we now have outdoor trails, outdoor batting cages, indoor walking track, swimming pool, aquatic therapy pool for ailments such as arthritis, knee replacements, joint problems, etc. Our benefits have increased dramatically with the additions of utility reimbursement, Medicare premiums reimbursement, elder crisis, down payment assistance for first time homeowners, loans for start-up businesses, natural disaster assistance, housing improvement program. It has been important to me that the citizens living away have the same opportunities as those who live locally.

REASONS FOR RUNNING FOR OF-FICE

Observe any tribe and you will note that continuity and stability have proven to be the greatest predictors of success. We have made such progress in the last decade. In spite of a two year devastating pandemic, we have not only survived, we have progressed. Our casinos are doing well, we have completed four transitional housing units for individuals who are victims of crime/violence, we are constructing a 3.5 million dollar access road to our Housing Authority, we have just finished a million dollar expansion to our Learning Center. I have not done this alone. The BC has not done this alone. Tribal citizens have not done this alone. WE have done it together. This is not a job to me; this is a passion. As most of you know, I had an almost fatal experience with COVID last August. I had person after person ask me to run again for Chief. My answer was always the same: I won't run unless I am physically healthy. I am healthy and I am a candidate for Chief. I am for continued success for the Eastern Shawnee Tribe. Yes, mistakes have been made but successes have far outweighed those errors. I am for locating successful businesses, strengthening our programs, serving our people. I humbly ask for your vote.

Hello Tribal Members.

I would like to start by introducing myself and my involvement in the Tribe with a small story. About 16 years ago, I ran for the position of Chief against 2 of my tribal elders. After the election, a member of our Tribe approached me and stated, "We would like to see what you would do sitting on the Business Committee before running for Chief." Since that day, I have been on a journey to be as involved as possible and to learn everything I could about our Tribe and our government.

I began this journey by serving on the Pow Wow Committee, where I grew individually and learned invaluable lessons from the elders that walked with me on that committee. I mention this only because it was not the lesson from one elder that "you don't kiss butt or

wash windows," but the lesson of unity that I gained from walking together with my elders that stuck with me and drove me to strive higher and always do better. No one person leading but working together as one. Me being the young one and working beside my elders, 3 on one side, 2 on the other, made me feel protected and loved. I have carried this lesson of unity with me ever since.

Lessons I learned from another tribal member taught me about heart. His teachings I carry in my everyday life. During this time, I was working at the casino, our elected body took a chance on me and hired me to manage our Travel Center Casino. This position would later turn into the position of Assistant General Manager of the Outpost Casino. The lesson of heart and pride drove me to see our Tribe prosper and to work as a team to turn profits at the casino. I didn't do it alone; the casino employees were a unit. I couldn't have done such a good job if I didn't have those employees walking beside me and showing a sense of unity for the betterment of the place we worked.

Unfortunately, during this time, I did make a mistake and was let go. By dating an employee under my supervision, I broke policy. I mention this because it is brought up in every election. When I was asked about this, what was on my heart was to speak the truth. I could have denied my actions, but that was not being what I was feeling, so I told the truth and was let go the next day. After this, I was hurt and did not want to come out of my shell.

For the following 3 years, there were those that would ask if I was okay, but I could not bring myself to participate in tribal affairs. There was one friend, mentor, and tribal member who never gave up on me and let me have my space; through this support, I was

called back to the Tribe just as I was told I would be.

I was called back for the unity and heart to serve and help our Tribe and our people. At first, I tried to come back and work for the Tribe in some capacity. However, what I found was being away for 3 years, there were plenty of brick walls for employment on the casino and tribal side. Tribal preference was not being followed. This bothered me, and I confronted the Casino General Manager about this practice at a Business Committee meeting. He admitted that he was not following tribal preference and hired 2 non-tribal members for a position qualified tribal members had applied for. I was labeled at that meeting as a disgruntled tribal member. After that meeting, I decided to be a voice of change. I ran for my current position on the Business Committee. That was almost 9 years and 3 elections ago (5 elections if you count runoffs), and I have tried to make our people proud and stand up for what I feel is right every day since.

The reason I speak of these stories and life events is the reason I am running for Chief today. Recently, a tribal member asked in a meeting what I was doing to change a policy I didn't agree with. The only response I could give was that I was not sitting the Chief's position, who oversees administration.

I feel we need to get back to honoring our tribal preference policy and putting qualified tribal members in career positions within the Tribe. We need accountability for the actions of not just tribal members but the employees who work for us – what is considered wrong for one should be considered wrong for all. We need to continue to seek out grants that will help the Tribe grow but will also lead to self-sufficiency once the grant funding ends. We need to be

prepared to reduce reliance on federal funding by allowing the Business Committee to do their job and find ways to make this happen.

For our Tribe and our tribal members, we need to look for new programs that we can offer. We must find better ways to make sure medical needs are being properly taken care of and not just meeting the minimum requirements. We need to build a legacy for our future grounded in unity, pride, heart,

and love. Unity by walking together and joining as a united front as we did many years ago. Pride by having pride within our Tribe and within our people together. Heart in everything we do (from helping fellow tribal members to building a future free of negativity). And love, because it is the love for the Tribe and keeps us wanting to serve and move our people forward.

I have walked with and taken care of my elders as a CNA for the last 11 years, and proudly served as 2nd Council for close to 9 years; I am now ready to step up to the role of Chief of this great Tribe and to serve the Tribe and its tribal members with the groundwork of the 4 lessons I have had embedded into me since I started my journey with the Tribe. To do so, I need your help and humbly request that when you cast your vote in this year's election, you cast it for me as the Chief.

In 2007 I was promoted to manager of the Travel Center Casino (not the Travel Center Store). In 2008 I started in the position of Gaming Commissioner. During my tenure as Gaming Commissioner, I received the award of Regulator of the Year for Indian Country from the International Masters of Gaming Law. I was elected for two terms as Chairman of the Oklahoma Tribal Gaming Regulators Association. I served a term and a half before stepping down from that position because now I was going to work in the Casino as an Assistant General Manager. I left this position voluntarily due to health matters. In September of that same year, I started as the Tribal Historic Preservation Officer/ Cultural Preservation Office Director. At the current time I am the Shawnee Language Director for the Eastern Shawnee Tribe.

I would be honored to represent every member of the Eastern Shawnee Tribe of Oklahoma. Therefore, I am asking for your vote in this upcoming election. For the past 4 years, I have had the honor and the privilege of serving and representing you, the General Council, in my capacity as 1st Council of the Business Committee. Prior to serving on the Business Committee, I worked in the Social Services Department, worked in the Cell Tower Program, and worked as the Coordinator of the Native American Graves Protection and Repatriation Act (NAGPRA) Department. Each of these experiences afforded me the opportunity to build partnerships and de-

velop successful working relationships throughout the Tribe, the community, and within Indian Country.

The last 4 years have brought many opportunities for growth and success. As a Tribe, we have prospered, growing our Social Services and Education reserves by more than \$5,000,000.00 and ensuring the security of these benefits for future generations. We have grown both the Land and Economic Development accounts by more than \$2,000,000.00, allowing us the funds to pursue future growth and economic diversification. Additionally, we have put legislation in place to protect our culture and our heritage. While this list is not exhaustive, it highlights the diligence, cooperation, and commitment I have had to move our Tribe forward and to working with the entire Business Committee to represent the General Council with honor and dedication.

While we have seen many advancements the last 4 years, I would be remiss if I did not mention the emergence of COVID-19 and the subsequent challenges it presented. First and foremost is the health and safety of our Tribe and our employees. To address these health and safety concerns, I supported actions such as issuing a State of Emergency, direct stimulus payments (\$1,000 from CARES funding, \$2,500 from ARPA funding, and an additional \$1,000 for elderly and disabled tribal members), and establishing ongoing programs to address future medical, utility, internet, and supplemental pay needs.

In addition to the actions mentioned above, I have been committed to working towards achievements that benefit the Tribe as a whole and protect our sovereignty. I am proud to have voted to provide funding to the Housing Authority to build desperately needed

homes, to have supported multiple land purchases within our jurisdiction, to have advocated for the establishment of our own tribal court, to have voted to increase funding to the Home Improvement Program and First Time Down Payment Assistance Program, and to have supported the involvement of youth in extracurriculars (both through donations and through the establishment of a benefits program).

Over the last 4 years, I have worked hard to maintain and strengthen the integrity, sovereignty, and culture of the Tribe and to move us forward economically. I am dedicated to continuing the work as 1st Council of the Business Committee. I ask for your continued support and your vote this election. Sincerely,

I have been involved with the tribe for many years. I served on the Election




You, he said

THE CITY OF MIAMI'S FLOODING PROBLEM IS OUR PROBLEM TOO

Friday, June 11, I attended a public forum in Miami, Oklahoma regarding repeated flooding issues in the city of Miami. For those of you who do not live in this area, Miami is approximately twenty miles from our Bluejacket Complex and floods that affect Miami usually affect us as well. That's due to the fact that two nearby rivers, the Neosho River and Spring River, merge just seven or eight miles from our complex and form the beginning of Grand Lake. The Neosho River flows through the city of Miami, causing the water level to rise and Lost Creek which runs through Bluejacket Complex runs into the Spring River side of Grand Lake, or for the last several years I should say that it tries to run into Grand Lake. When Lost Creek cannot run smoothly into Grand Lake because of high water levels, it backs up, rises even higher and stays longer in the Wyandotte area and ultimately our Bluejacket Complex area. The reason Lost Creek has difficulty flowing smoothly into Grand Lake is that there have been so many floods throughout the years with each flood bringing and depositing sedimentation that has now risen to a troublesome level, thus causing the same amount of water to be higher than previously. This results in backwater; this results in longer and higher flooding.

This already problematic situation has taken on a more serious aspect in that Grand River Dam Association, GRDA, must relicense in 2025 and they want to raise the elevation or lake level even higher, meaning to 745 feet rather than remain at the current 735 feet level. If Grand Lake,



meaning Neosho and Spring Rivers along with Lost Creek are already repeatedly flooding at 735 feet, we know what the results will be to the Miami and Wyandotte area, consequently ultimately negatively affecting our tribal land. The city of Miami has filed a series of lawsuits attempt-

ing to have GRDA open the flood gates earlier and take other measures to prevent the flooding, attempting to resolve the issue. Miami believes GRDA's operation of the flood gates located at Pensacola and known as the Pensacola Project is the culprit and must be stopped from raising the lake

level to 745 feet. Thus the series of lawsuits, where previously the city of Miami had little if any success. This time it may be different as 456 plaintiffs have joined the fight in the latest lawsuit. As Mayor Parker of Miami

cause we are in a flood plain, I winced when I heard lead attorney Larry Bork who has been involved in the flooding lawsuits for twenty to thirty years state, "If GRDA wins this, the city of Miami will not exist." I won-

stated Friday night, "As far as the relicensing goes, we can't stopIf we do they get to raise it to whatever they want and we get flooded again, again and again....it will get worse."

Knowing that we have been in a twenty year process of moving to higher ground on Highway 10C bedered what the effect would be on us with Lost Creek located alongside our powwow grounds. For the first time, Miami has hope because in a ruling earlier this year, "the District of Columbia Circuit Court of Appeals ruled that the Federal Energy Regulatory Commission (FERC) must reconsid-

er a complaint by the City of Miami with more analysis."

Following are other quotes from an article appearing in the Miami News Record, regarding the public forum which was well attended and lasted almost three hours.

"A series of lawsuits, including one that dates back to 2008 and involves the catastrophic 2007 flood, is attempting to resolve the issue. The latest pins the blame on the GRDA for the repetitive flooding because of its operation plan for the Pensacola Project... The GRDA is in the midst of a relicensing for the Pensacola Project. The current license expires in 2025 and the next will cover the next 30 to 50 years."

Referencing the ruling earlier this year, the District of Columbia Circuit Court of Appeals ruled "The Federal Energy Regulatory Commission must reconsider a complaint by the City of Miami with more analysis. The City produced extensive evidence that previous damage was caused by flooding attributable to the operation of the Pensacola Dam...the evidence that Pensacola Dam's operation has caused the flooding in the city is powerful."

Everyone left the meeting realizing the gravity of the situation, but for the first time, with a glimmer of hope. I left the meeting realizing more than ever before the outcome of Miami's lawsuit does not affect just the city of Miami. The outcome of that lawsuit greatly impacts the Wyandotte area and our Bluejacket Complex. I, for one, support Miami in its fight for its life.

What is MDMA?

3, 4 methylenedioxy methamphetamine or MDMA also commonly known as ecstasy or molly, is a schedule one substance as it has no medical benefit and has a high potential for abuse. MDMA is a laboratory created drug, which produces similar effects to stimulants known as amphetamines. It is also known to produce psychedelic effects common to mescaline and LSD. It first became popular as a party drug at night clubs, raves, music festivals and concerts though its range has expanded to include diverse groups of individuals.

MDMA is taken in a pill, tablet, or capsule form. MDMA in recent times is often mixed or replaced with other drugs, many are found to contain synthetic cathinone, a chemical found in bath salts, as well as caffeine, dextromethorphan, amphetamines, PCP, or cocaine. It affects the brain by increasing dopamine, norepinephrine, and serotonin. These brain chemicals affect the body in a variety of ways from reinforcing certain behaviors, heart rate, blood pressure, mood, sleep, trust, and others. A large dose of MDMA can



cause a sense of emotional closeness, elevated mood, and higher levels of empathy. As with any drug it can cause a variety of health effects ranging from, nausea, muscle cramps, involuntary teeth clenching, blurred vision, chills, and sweating. MDMA typically lasts 3-6 hours though it can be extended by taking a secondary dose as the effects begin to fade. If taken moderately over a weekly period additional side effects

can occur. These side effects include irritability, aggression, depression, sleep disorders, anxiety, memory or attention issues, lack of appetite and others. If you take too much MDMA it can lead to an overdose, this could lead to your body having difficulty in controlling its body temperature. A too sharp of rise in body temperature can cause damage to your liver, kidneys, and heart failure.



Domestic Violence and the LG-BTQ Community

Because the majority of the domes-





tic violence awareness movement has focused on heterosexual relationships, members of the LGBTQ community have been largely left out of the movement. However, recent research shows that LGBTQ members fall victim to domestic violence at equal or even higher rates compared to their heterosexual

counterparts.

Nine Quick Statistics about Domestic Violence and the LGBTQ Community

1. 43.8% of lesbian women and 61.1% of bisexual women have experienced rape, physical violence, and/ or stalking by an intimate partner





- at some point in their lifetime, as opposed to 35% of heterosexual women.
- 2. 26% of gay men and 37.3% of bisexual men have experienced rape, physical violence, and/or stalking by an intimate partner in their lifetime, in comparison to 29% of heterosexual men.
- 3. In a study of male same sex relationships, only 26% of men called the police for assistance after experiencing near-lethal violence.
- 4. In 2012, fewer than 5% of LGBTQ survivors of intimate partner violence sought orders of protection.

- 5. Transgender victims are more likely to experience intimate partner violence in public, compared to those who do not identify as transgender.
- 6. Bisexual victims are more likely to experience sexual violence, compared to people who do not identify as bisexual.
- LGBTQ Black/African American victims are more likely to experience physical intimate partner violence, compared to those who do not identify as Black/African American.
- 8. LGBTQ white victims are more likely to experience sexual violence, compared to those who do not identify as white.
- LGBTQ victims on public assistance are more likely to experience intimate partner violence compared to those who are not on public assistance.

Fireworks Safety







Tips to Remember

If you live in a state that allows fireworks and you're planning a do-it-yourself celebration, follow these safety tips to protect yourself and the people watching:

- Buy ready-made fireworks rather than making your own, even from a kit.
- Make sure an adult is present at all times.
- Don't allow little kids to operate fireworks, even sparklers.
- Buy only legal fireworks that have a label with instructions for proper use. If your fireworks don't have an instruction label, they're probably illegal to use.
- Choose fireworks that are appropriate for the area you'll be using them in. For example, avoid using rockets or other aerial fireworks in the backyard or a busy street. Choose fountain-type fireworks instead.
- Follow all the directions on the label closely.
- Always use fireworks outside with a bucket of water or hose nearby. Keep fireworks away from dry leaves and other materials that can easily catch on fire.
- Light one firework at a time. Keep the firework you're lighting well away from unlit fireworks.
- Point fireworks away from people. If you're lighting a firework, wear eye protection and don't lean over the firework.

Fireworks: Handle With Care

Fireworks safety starts before a firework is even sold: It begins with the manufacturers, who need to follow strict quality controls in making their products. That doesn't mean every firework is guaranteed to be safe, though. Things can go wrong with fireworks, just as they can with any product, and most of the time it's because the fireworks aren't handled properly. That's the reason you see all those warnings on fireworks.

Thousands of people are taken to hospital emergency rooms in the United States every year because of injuries from fireworks — including bottle rockets, sparklers, and firecrackers. The most common fireworks injuries involve the hands, fingers, eyes, head, and face. Some of these injuries are severe, resulting in permanent health problems such as missing fingers and limbs and vision loss.

So what can you do to enjoy the Fourth of July and still stay safe? Going to public fireworks displays is the best approach. Not only are these displays bigger and brighter (the federal government bans the sale of the largest fireworks to the public), but many states have laws that don't allow people to buy or use fireworks. Before using fireworks, find out what the laws are in your area. The Consumer Product Safety Commission (CPSC) provides more information about state and federal regulations on its website.

- If a firework doesn't seem to work, don't go over to it or attempt to relight it. Stand back for a while.
 If you can reach it with a hose or bucket without getting too close, douse it with water.
- Soak all fireworks in a bucket of water before throwing them away.
- Store fireworks in a cool, dry place.
- If someone gets an eye injury from fireworks, don't rub the eye or attempt to wash it out. Call 911 or go to the nearest emergency room. It could make the difference between saving a person's sight and permanent blindness.

Emergency Rental Assistance Program By Amber Mittag, Education Coordinator



EMERGENCY RENTAL ASSISTANCE PROGRAM

The purpose of the Eastern Shawnee Tribe of Oklahoma Emergency Rental Assistance Program is to provide direct financial assistance, including rent, rental arrears, utilities and home energy costs, utilities and home energy costs arrears, and other expenses related to housing. This program will make available a limited amount of assistance to households that are unable to pay rent and utilities due to the COVID-19 pandemic. This program will serve eligible households and is subject to available program funding.

Eligibility:

- Qualifies for unemployment or has experienced a reduction in household income, incurred significant costs, or experienced a financial hardship due, directly or indirectly, to the Covid-19 outbreak.
- Demonstrates a risk of experiencing homelessness (rent) or housing instability (utilities and other expenses); and

Has a household income at or below 80 percent of your area median (FY 2020).

Assistance Provided:

- 1. Rent
- 2. Rental arrears
- 3. Utilities (electric, gas, water and sewer, fuel oil)
- 4. Utility arrears
- 5. Internet

Eligible households may apply and receive up to three months of assistance at a time, provided funds are available. A maximum of 12 months assistance or \$3,000, whichever should come first.

INTER-TRIBAL COUNCIL FOOD DISTRIBUTION

We are a federal program that provides commodity foods to low-income households residing in approved areas. To be eligible to participate, the household must contain at least one person who is a member of a federally recognized tribe. Eligible households are certified based upon income and resource standards act by the federal government.

The area served by the Inter-Tribal Food Distribution Program is a portion of Ottawa County, including the city limits of Miami east of Neosho River and a portion of Delaware county in Oklahoma. Cherokee and Labette Counties in Kansas, Newton, Barton, Jasper and McDonald counties in Missouri.

10th Annual Tire Collection Event By Jacob Bachman, Four Feathers Recycling

On the 19th and 20th of May, Four Feathers Recycling had the privilege of holding the 10th Annual Tire Collection event. This allows Tribal members and local residents to dispose of unwanted tires in an environmentally friendly manner.

A tire's life only lasts a couple of years on a vehicle. Not long after, a good number of tires make their way to a landfill and can take up to 100 years to decompose. On the other hand, we are finding more and more ways to recycle tires with less impact on the environment. Today, most are being used as fuel which serves as a more energy efficient method. They are also being used

as a gravel substitute, garden mulch, wastewater treatment filters, etc.

When a tire is left in a field, a ditch, or a small body of water such as a creek or pond, local plant and wildlife pay the price of chemicals released into the air, ground, and water. Another risk we take when we let tires stagnate over a long period of time is the chance of attracting varmints and disease carrying mosquitos. This becomes a public safety health risk.

Around 56 million tires are recycled every year and repurposed in the United States. With this being the 10th anniversary of our tire collection event, I decided to show an estimate of how

many tires we have recycled over the years. Since the beginning of this event in 2012, approximately 30,000 tires have been collected and properly disposed of. That means we have been able to rid our area an average of 3,000 unwanted tires every year. It may not seem like much compared to the national average, but this makes a huge impact towards cleaning up our community.

The EPA Department would like to thank everyone that took time out of their day to help. We are thankful that we have been able to host this event over the past 10 years and look forward to holding this event annually!

ECLC - Does have programs that offer assistance. Eastern Shawnee Students - 66% receive assistance or 80 students, 34% or 40 students do not receive subsidies and pay full price. 31 Eastern Shawnee receive assistance from CCDF and 19 Eastern Shawnee do not. At the ECLC there are 3 Seneca Cayuga that receive assistance, 5 from Wyandotte receive and 3 do not. Miami has 2 that receive assistance and

Ottawa have 4. Oklahoma has 4 that receive subsidies and Missouri has 5.

HIP Report - The BC recently extended the number of projects by twenty of which 8 applications have been received with 12 left open for applications for approval.

BROADBAND - Just last week we received another report that says they are narrowing that funding, but we are still on the list for available funding. We have two pages of curing question that we have to respond to. Others have gone up to 16 pages of curing. It could be up to two more months before we know if we are approved to receive this. REGULATOR OF THE YEAR - Jalene Wells, Gaming Commissioner was presented this award by Oklahoma Tribal Gaming Regulators. Congratulations were extended from Chief Wallace.

110 ROAD PROJECT - This will make another access road to the Housing Authority. We had a meeting last Friday with Hudson Prince the design company and they submitted a 60% per cent drawing. They are to submit a 90-95% drawing the later part of June. A grant is being written to try to get the entire project funded. One downside to the 110 Road project is that it is going to take out part of our trails behind the Wellness Center. The reason is that they have to miss the utility and gas lines, so the road is being moved more to the East. We will have to address that to replace what we are losing.

Splashpad Update - A water runoff study was not completed when we started building at the 110 complexes. With everything being built on concrete all the water is coming down and creating a problem. This will need to be corrected while we are building the Splash Pad, so they are putting in concrete box culverts.

ELDER DINNER – There were 75 in attendance. The program consisted of three videos. One of those videos was about Larry Dushane, Michael Daugherty a tribal citizen who has written and illustrated a children's book and the

Eastern Shawnee Tribe. Norma Kraus was selected as Female Elder of the Year and Bud Envart as Male Elder of the Year. Each Elder received a Pendleton blanket.

TINY HOMES - The Tiny Homes are 95-97% complete. Skirting is being installed around them, cabinets are still needing hoods installed over the stoves and, the washers and dryers are on back

EMPIRE RATE INTERVENTION -Rates are expected to increase 19% in the next two years. Chief would like to for the Eastern Shawnee Tribe to join in a rate reduction request and file an intervention with the Wyandotte and Modoc nations. All BC members agree with her request.

OHIO TRAIL OF ART - All three Shawnee Tribes have been requested to attend this event; the first statue being placed on the trail is Tecumseh. This will be June 17 thru June 18, 2022. Chief Wallace extended the invitation and information to the BC members that are planning on attending.

SERPENT MOUND - Summer Solstice, June 18. The Solstice is Tuesday, June 21st.

Ohio History Management likes for the tribes to hand out the programs.

FOOD DISTRIBUTION - The last food distribution was held at Growing Thyme for the first time. and it went quite well. Our next distribution will be May 26th, 2022, from 11-1:30 p.m. 105 families are being served and all are Eastern Shawnee. Racks have been ordered for the coolers to keep the fro-

HOUSING BOARD AUTHORITY NOMINATION - This has been advertised and two people expressed interest. Chief submitted for nomination a tribal citizen, Kenny Johnson. A question was raised by Jennifer Lankford that according to the by-laws a tenant is supposed to sit on the Board and that has not happened for a few years.

DRIVER'S EDUCATION - this program is offered free of charge to 15year-old students. The class is limited to 20 students.

GRADUATION PICTURES AND STOLES - Chief Wallace displayed a stole that will be presented for the first time to our college graduates. It is fashioned like the original sash/belt worn by during the removal march from Ohio to Oklahoma. One of the individuals attending our Elders Dinner was Rebecca Trulove. She is a member of our tribe and is Dean of Bacone College near Muskogee. She is the granddaughter of Babe Rickner. She was presented a Stole at the Elder Dinner that she will be able to wear at graduations as well. FHLB (Federal Home Loan Bank) -Some of our duplexes are under this

program and Chief recommended that we use some of our construction money this year and remove or payoff the loan with FHLB. Chief Wallace has contacted them, and they sounded favorable, but she has not yet received anything in writing.

RENTAL ASSISTANCE - This is re-

lated to COVID, and we have had a funding of \$90,382.91 and we have distributed this to tribal members who have applied for this program. We have \$2,882.87 left in this program. There will be a resolution presented tonight to add that under the ARPA program so that we may be able to continue that program. This program will go under the ERA and Amber Mittag from this point forward.

TIRE RECYCLING - EPA Dept. will sponsor a tire recycling day on May 29th, 2022, from 9 am to 1 pm. Bring tires to the recycling center on Hwy U. SPONSOR VOTER'S REGISTRA-TION - To encourage Native Americans to vote - this will be hold at the AOA on June 1, 2022. Nationwide, according to Google only 2.9% of the population of the United States is Native American. Less than 35% participate in elections and we realized that we have very little chance of influencing anything, particularly if we are not registered. We are not telling anyone how to vote we are just simply saying you can't express your interest if you are not registered to vote. This information will be available at our AOA on June 1st so that people can become registered to vote in Ottawa County, Oklahoma.

Vote Your Values – provides information about which candidates vote is more favorable towards tribes.

Casino Financial Report for April 2022 Comparison of actual to budget for April total revenues for Indigo Sky were up by 24% with expenses under

budget by 2%.

Outpost revenues were down from budget by 4% with expenses coming in on budget at 6%.

The comparison of actual to budget YTD have Indigo Sky revenue higher than projected at 15% and expenses came under budget by 7%.

Outpost YTD revenues come in higher by 1% and expenses were down by 5%. As we move into the third quarter of the fiscal year, we are proud that we were able to fund the BC recently approved resolutions for Maintenance and Operational Reserves. The funds transferred to the tribe total 14.5 million dollars. This was in addition to the 17 million where we paid off the Casino second tower in October. The total that was paid off was \$31.5 million. Melanie stated how proud she was of the Casino employees who work so hard for our tribe and were able to make this happen.

(Treasurer Barrett pointed out the \$14.5 million for the Maintenance and Operational reserves and the 17 million for the payoff of the Casino second tower was paid in addition to the monthly transfer from the Casino to the tribe which equates to approximately \$14 million dollars this fiscal year plus the other two were not budgeted.

Treasurer Barrett says this speaks volumes about the work that the Casino team does and what this allows us to do on the tribal level.)

Report on the progress of the Tower One project. All the site is secured. Trash chutes are being constructed. Everything is fenced off at the front of the Casino and around the Hotel Check-in. They will start disassembling rooms, taking everything out – furniture, pulling off vinyl and carpeting. This project will take about 6 months to complete.

Pow Wow rooms are available to all tribal members. Tribal members wanting a room should call the hotel and tell the front desk PBX they are tribal members, and they will book their rooms at a \$69.00 rate. The dates for this rate

are 9-14 thru 9-17. Anything past those dates will be a 25% discount to tribal members.

Gaming Commission – Jalene Wells, Gaming Commissioner

Report for April was provided at the May 11th Business Committee Meeting.

Treasure Report – Justin Barrett, Treasurer

The Business Committee Budget, the Chief's Budget, Cultural Preservation Budget, the Ceremonial Chief's Budget and Shawnee Skies budgets were forwarded to the Business Committee by Treasurer Barrett.

Tribal Cash Balance as of May 31st, 2022.

General Fund \$61.3 Million People's Bank CD's \$1.2 Million Land Account \$600,000

Economic Development \$ 2.6 million We were able to move over the Maintenance Reserves and the Maintenance Reserves now are \$5 million, the Operating Reserves have \$10 million, and the Tribal Government Building has a \$4 million dollar commitment out of General Fund.

Social Service and Education Reserves \$20.3 million

Education Reserves \$1.2 million Total Available Cash \$20 million for the tribe.

Treasurer Barrett read a donation request from tribal member, J.R. Conrad. On June 18th Mr. Conrad along with other coaches and peers will be putting on a free youth football camp at Quapaw, Oklahoma and several native youth will be attending this camp. The mission of the camp is to celebrate life, honor the Ellick family and raise donations to go towards funds for the Ellick family as they travel to and from Memphis during treatment weeks at St. Jude Hospital for Blakelynn. The request is for \$1500.00 to cover 6 hotel rooms for the guys helping with the camp that will be traveling in the night before with the remaining going directly to the Ellick family.

woodworking, pottery, flintknapping, regalia items, any form of art. Let us know if you are interested in displaying items at this museum honoring Shawnees. Pass the word and let everyone know and most importantly, participate. I truly hope to hear from many of you.

At this time groundbreaking for the Old Town Historic State Park is tentatively set for the 27th of this month. Definite dates to open are unknown at this time but hopefully the museum will open within a year. So begin collecting your items and share your intentions/findings with me. Let's make a strong Eastern Shawnee showing.

Turning to local tribal news, hopefully all of you are aware of our Elders Housing known as the Woodlands. We have nine duplexes there with 7 of the duplexes being built with Hous-

ing Urban Development (HUD) funds and 2 being built utilizing \$160,000 from the Federal Housing Loan Bank (FHLB) program with the tribe paying the remaining amount. The difference in the 2 programs would primarily be that the FHLB units had to adhere to strict low income guidelines whereas the HUD guidelines had more financial flexibility but required elders to be of independent living status, meaning they had to have their own transportation, etc. If elders didn't have their own transportation, then they weren't classified as independent living elders. Thus we have chosen to pay off our FHLB debt of \$160,000 freeing us from those low income restrictions. In our capital outlay budget this year we had budgeted \$150,000 for housing. Rather than using that as partial payment to build another duplex, we chose to use it and \$10,000 from the \$35,000 + rent dollars we had received from the FHLB units and pay off that debt. We were never charged any interest so we profited by using the FHLB loan but it feels good being debt free with far more flexibility. If you are 55 or older, interested in living near the tribe, paying rent of \$400 a month for 2 bedrooms, 2 baths, appliances and garage, then contact Kathleen Blanchard.

This past month we submitted a grant known as the Rural Surface Transportation Grant Program in the amount of \$4,785,000. This grant focuses on 110 Road, the road that is closed now but was an open county road years ago. This road would connect our Housing Authority location with Stateline Road. We have been working diligently on completing the engineering phase of this project for the last six or so months. We anticipate the engineering design phase to be completed July 15. The next step would then be to advertise for a company to do the actual

construction, paving of the road. The project is anticipated to cost in the neighborhood of 3 and a half million. Currently we have slightly less than 2 million dollars available to use on this road from BIA road funds with the remaining to be paid with ARPA funds. However, if we are fortunate enough to be awarded this grant, it would cover the entire cost of the road and we could use the BIA Roads money and ARPA funds for other projects. Cross your fingers with me. Hopefully we will know something within the next 45 days.

Also submitted recently were two trust packages for two different parcels of land in our Eastern Shawnee jurisdiction area. Remember that much of our land holdings at Highway 10C Complex are in Modoc jurisdiction and we can't get those lands into trust. The trust packages submitted included former Elbert property with 7 acres or so of it on Business 60, immediately east of Indigo Sky and the remaining Elbert property on Highway 60 southeast of Indigo Sky. Much of the land where Indigo Sky is located was purchased from the Elbert family about 15 years ago. The next piece of property we have submitted a trust package for is the McKibben property, a farm on 120 Road, immediately west of the Seneca Cemetery. Thanks to EPA Director Kristi Laughlin for completing these applications. Now we wait on the BIA.

This month we lost another elder, this time Bobby BlueJacket. Bobby was a fighter throughout his life and he lived that way to the very end. As the poem states, he did not "go gently into the night" but fought to live to the very end. No one can dispute that he loved this Eastern Shawnee Tribe and he loved serving it. Let's all remember his family during this difficult time. At the last Business Committee meeting, it was announced that we will be closing our Travel Center on 10C, ef-

fective June 30. The Travel Center

was originally built to house both the Convenience Store and a gaming center. While it operated in that mode, it was quite profitable. Since building OutPost Casino in 2008 and removing the gaming portion, the Travel Center has been more of a convenience to the tribe as opposed to a profit center. OutPost Casino does quite well on its own. It was a difficult decision to make but one that has been discussed for several years. As always, the tribe hopes to diversify in business operations, but it is imperative that we find profitable businesses.

I wish all of you could see our facilities this time of the year. We have had lots of rain and grass is abundant and a lively green. Add to that the beautiful red, white and blue flags that are flying at both the Bluejacket Complex and the 10C Complex and it makes me proud to be an American, proud of what we as a tribe have accomplished. Congratulations to our Maintenance Department for keeping our facilities so attractive and thanks to them also for the mowing they did at our cemeteries for Memorial Day. It's a special time of year.

I want to give a shout out to the Cherokee Nation and the late Wilma Mankiller for the recent honor bestowed upon them. A Wilma Mankiller quarter dedicated to the first female principal chief of the Cherokee Nation will be available soon. The Wilma Mankiller quarter is the third coin released under a U.S. Mint program celebrating the achievement of diverse prominent women in American history. Mankiller was Chief of the Cherokee Nation from 1985 to 1995. On one side of the quarter is President George Washington. The other side depicts Chief Mankiller clad in a traditional shawl with the seven-pointed star of the Cherokee Nation on her left. Born in 1945, Chief Mankiller was routinely questioned about her surname "Mankiller" which refers to a traditional Cherokee military rank, like a captain or major. I personally met Wilma Mankiller and her soft spoken demeanor in no way resembled a "mankiller". She was the first woman to lead a major Native American Tribe, not the first Native American female chief but the first to lead a major Native American Tribe, with the Cherokee Nation having the highest enrollment of all U.S. tribes.

In conclusion, I want to wish a belated Happy Fathers Day to all our dads out there. I also want to wish everyone a glorious Fourth of July. Let's reflect upon our country and be thankful we live here. Recently we have certainly had our problems, so let's do our part to bring more peace to our country and to this world.
