The Chief's Report . . .

Dear Fellow Tribal Citizens,

Once again I am writing this article early because of travel plans to take our summer youth and a few other teenagers active in the tribe on a historical, educational trip through Ohio and Michigan and on to Canada where Tecumseh was slain. We leave Sunday, July 17 and will be gone one week. We will first drive to Chillicothe, Ohio where we will be meeting up with youth from the Wyandotte Tribe, individuals from Michigan's River Raisin National Park and several schoolteachers to embark on a bus trip known as Journey to Understanding. We will visit historical Shawnee and Wyandotte sites in Ohio including some famous battle sites plus some of the mounds nominated for World Heritage status. We will then depart for Monroe, Michigan where we will visit the lands where BlueJacket lived in his later life (interestingly enough also the childhood home of Custer), learn about the River Raisin battle in the war of 1812, kayak the river then go on to Canada's River Thames where Tecumseh was slain. Everywhere we will have the most knowledgeable lecturers informing us of the history, the inside stories. On our return trip to Oklahoma, we will focus on the removal route taken by Shawnees in their 1832 removal march, stopping at several of the actual removal sites. Those Michigan teachers will then stay at Indigo Sky for a week, visit the nine tribes in Ottawa County and write curriculum, lesson plans based upon history books and what they have experienced, learned in the two weeks, using that for teaching in their schools this upcoming year and hopefully thereafter, hence the name of our travels, Journey to Understanding.

Bottom line is that I will be gone when it is time to submit this article to the Shooting Star, so I am doing it early. It is hot here and so dry! And it has been for some time with more of the same predicted for the future. We've had a few claps of thunder that seemingly suggested we might get some rain, but unfortunately like so many current politicians' promises, it was all noise with no results. It's so hot Wyandotte, Oklahoma and Seneca, Missouri areas could easily be referred to as Death Valley. That is definitely true for vegetation. My plants/flowers certainly would not argue with that descriptor. For an hour in the early morning and again for an hour in the late evening I lug hoses from one flower bed or flowerpot to another, soaking them with water trying to keep them blooming. It is a war I fear I am going to lose as there is no end in sight to this heat according to the weather forecasters. However lugging those hoses has certainly gotten me in shape for the walking that will take place on this upcoming trip. That's the optimist in me as I always try to look on the bright side.

Speaking of trips, let me give you a short synopsis of our recent time in Ohio at Darke County's Shawnee Prairie and Adam's County Serpent Mound. Eight of us were able to make the trip to Shawnee Prairie along with my good friend and navigator Lynette White for the unveiling of the statue of Tecumseh. It was three celebrations rolled into one for Darke County as they were honoring the famous Shawnee warrior and his influence on local history, the launch of the Darke County Art Trail and the 50th anniversary of Darke County Parks. 

PERSONAL INFORMATION

Once again I am asking for your vote to continue being your Chief. My personal information has not changed. I was born in Ottawa County, Oklahoma and have lived within 15 miles of my birthplace my entire life with the exception of 3 years when at age of 9 my family and I were migrant workers on the west coast moving from town to town, field to field, patch to patch, school to school, living in the back of a flatbed truck or an abandoned barn or even sleeping in actual pig sties at a green bean operation. These formative years impacted me greatly, teaching me to set goals, develop a work ethic, work hard, accomplish these goals, accept accountability, treat each person with dignity, be optimistic, strive to be a positive change agent and take pride in my work. The first female in my family to graduate from high school, I attained a BA, MA, EDS and worked at Crowder College for 38 years being promoted from instructor to department chair to division head to interim Academic Dean where I managed multi-million dollar budgets and supervised large staffs annually. Interspersed with those duties was writing/directing grants and director of travel which enabled me to visit more than 70 countries, learning from each country. I have lived on the same farm for more than 50 years, lost my husband almost 35 years ago, have 3 grown children, 7 grandchildren and 11 great grandchildren. I am able to devote my full attention and time to the tribe, regularly working 60 or more hours per week.

QUALIFICATIONS IN BRIEF

I have been Chief since 2006 and served on the Business Committee 17 years prior to my being elected Chief. I have educational experience, financial experience, ethical character, stability, history with this tribe, and most of all love and concern for what is best for both our tribe and our people. I have managed multi-million dollar budgets with consistent flawless audits, led in the addition of 9 duplexes or 18 units housing our elders, oversaw the birth of our Early Childhood Learning Center where in 6 years we have gone from an enrollment of 20 to approximately 120 children each day, expanded our Wellness Center programs where we now have outdoor trails, outdoor batting cages, indoor walking track, swimming pool, aquatic therapy pool for ailments such as arthritis, knee replacements, joint problems, etc. Our benefits have increased dramatically with the additions of utility reimbursement, Medicare premiums reimbursement, elder crisis, down payment assistance for first time homeowners, loans for start-up businesses, natural disaster assistance, housing improvement program. It has been important to me that the citizens living away have the same opportunities as those who live locally.

REASONS FOR RUNNING FOR OF-FICE

Observe any tribe and you will note that continuity and stability have proven to be the greatest predictors of success. We have made such progress in the last decade. In spite of a two year devastating pandemic, we have not only survived, we have progressed. Our casinos are doing well, we have completed four transitional housing units for individuals who are victims of crime/violence, we are constructing a 3.5 million dollar access road to our Housing Authority, we have just finished a million dollar expansion to our Learning Center. I have not done this alone. The BC has not done this alone. Tribal citizens have not done this alone. WE have done it together. This is not a job to me; this is a passion. As most of you know, I had an almost fatal experience with COVID last August. I had person after person ask me to run again for Chief. My answer was always the same: I won't run unless I am physically healthy. I am healthy and I am a candidate for Chief. I am for continued success for the Eastern Shawnee Tribe. Yes, mistakes have been made but successes have far outweighed those errors. I am for locating successful businesses, strengthening our programs, serving our people. I humbly ask for your vote.

Hello Tribal Members.

I would like to start by introducing myself and my involvement in the Tribe with a small story. About 16 years ago, I ran for the position of Chief against 2 of my tribal elders. After the election, a member of our Tribe approached me and stated, "We would like to see what you would do sitting on the Business Committee before running for Chief." Since that day, I have been on a journey to be as involved as possible and to learn everything I could about our Tribe and our government.

I began this journey by serving on the Pow Wow Committee, where I grew individually and learned invaluable lessons from the elders that walked with me on that committee. I mention this only because it was not the lesson from one elder that "you don't kiss butt or

wash windows," but the lesson of unity that I gained from walking together with my elders that stuck with me and drove me to strive higher and always do better. No one person leading but working together as one. Me being the young one and working beside my elders, 3 on one side, 2 on the other, made me feel protected and loved. I have carried this lesson of unity with me ever since.

Lessons I learned from another tribal member taught me about heart. His teachings I carry in my everyday life. During this time, I was working at the casino, our elected body took a chance on me and hired me to manage our Travel Center Casino. This position would later turn into the position of Assistant General Manager of the Outpost Casino. The lesson of heart and pride drove me to see our Tribe prosper and to work as a team to turn profits at the casino. I didn't do it alone; the casino employees were a unit. I couldn't have done such a good job if I didn't have those employees walking beside me and showing a sense of unity for the betterment of the place we worked.

Unfortunately, during this time, I did make a mistake and was let go. By dating an employee under my supervision, I broke policy. I mention this because it is brought up in every election. When I was asked about this, what was on my heart was to speak the truth. I could have denied my actions, but that was not being what I was feeling, so I told the truth and was let go the next day. After this, I was hurt and did not want to come out of my shell.

For the following 3 years, there were those that would ask if I was okay, but I could not bring myself to participate in tribal affairs. There was one friend, mentor, and tribal member who never gave up on me and let me have my space; through this support, I was

called back to the Tribe just as I was told I would be.

I was called back for the unity and heart to serve and help our Tribe and our people. At first, I tried to come back and work for the Tribe in some capacity. However, what I found was being away for 3 years, there were plenty of brick walls for employment on the casino and tribal side. Tribal preference was not being followed. This bothered me, and I confronted the Casino General Manager about this practice at a Business Committee meeting. He admitted that he was not following tribal preference and hired 2 non-tribal members for a position qualified tribal members had applied for. I was labeled at that meeting as a disgruntled tribal member. After that meeting, I decided to be a voice of change. I ran for my current position on the Business Committee. That was almost 9 years and 3 elections ago (5 elections if you count runoffs), and I have tried to make our people proud and stand up for what I feel is right every day since.

The reason I speak of these stories and life events is the reason I am running for Chief today. Recently, a tribal member asked in a meeting what I was doing to change a policy I didn't agree with. The only response I could give was that I was not sitting the Chief's position, who oversees administration.

I feel we need to get back to honoring our tribal preference policy and putting qualified tribal members in career positions within the Tribe. We need accountability for the actions of not just tribal members but the employees who work for us – what is considered wrong for one should be considered wrong for all. We need to continue to seek out grants that will help the Tribe grow but will also lead to self-sufficiency once the grant funding ends. We need to be

prepared to reduce reliance on federal funding by allowing the Business Committee to do their job and find ways to make this happen.

For our Tribe and our tribal members, we need to look for new programs that we can offer. We must find better ways to make sure medical needs are being properly taken care of and not just meeting the minimum requirements. We need to build a legacy for our future grounded in unity, pride, heart,

and love. Unity by walking together and joining as a united front as we did many years ago. Pride by having pride within our Tribe and within our people together. Heart in everything we do (from helping fellow tribal members to building a future free of negativity). And love, because it is the love for the Tribe and keeps us wanting to serve and move our people forward.

I have walked with and taken care of my elders as a CNA for the last 11 years, and proudly served as 2nd Council for close to 9 years; I am now ready to step up to the role of Chief of this great Tribe and to serve the Tribe and its tribal members with the groundwork of the 4 lessons I have had embedded into me since I started my journey with the Tribe. To do so, I need your help and humbly request that when you cast your vote in this year's election, you cast it for me as the Chief.

Hello Fellow Shawnees,



My time working for our Tribe started back in June of 1988, starting out as a bingo caller/security guard. Soon I started working as a floor clerk/admissions clerk. When the electronics games started making their way into our gaming operations, I worked some hours each week as a slot attendant. In 2007 I was promoted to manager of the Travel Center Casino (not the Travel Center Store). In 2008 I started in the position of Gaming Commissioner. During my tenure as Gaming Commissioner, I received the award of Regulator of the Year for Indian Country from the International Masters of Gaming Law. I was elected for two terms as Chairman of the Oklahoma Tribal Gaming Regulators Association. I served a term and a half before stepping down from that position because now I was going to work in the Casino as an Assistant General Manager. I left this position voluntarily due to health matters. In September of that same year, I started as the Tribal Historic Preservation Officer/ Cultural Preservation Office Director. At the current time I am the Shawnee Language Director for the Eastern Shawnee Tribe.

I would like for every member of our Tribe to be as proud as I am to be Shawnee. I wish to strengthen our sense of community and family. I would be honored to represent every member of the Eastern Shawnee Tribe of Oklahoma. Therefore, I am asking for your vote in this upcoming election. My name is Dee Gardner, and I am running for reelection as 1st Council of the Business Committee of the Eastern Shawnee Tribe of Oklahoma. I am the daughter of Frances (Buttram) Jenkins, and the granddaughter of Gladys (Millhollin) Newberry.

For the past 4 years, I have had the honor and the privilege of serving and representing you, the General Council, in my capacity as 1st Council of the Business Committee. Prior to serving on the Business Committee, I worked in the Social Services Department, worked in the Cell Tower Program, and worked as the Coordinator of the Native American Graves Protection and Repatriation Act (NAGPRA) Department. Each of these experiences afforded me the opportunity to build partnerships and de-

velop successful working relationships throughout the Tribe, the community, and within Indian Country.

The last 4 years have brought many opportunities for growth and success. As a Tribe, we have prospered, growing our Social Services and Education reserves by more than \$5,000,000.00 and ensuring the security of these benefits for future generations. We have grown both the Land and Economic Development accounts by more than \$2,000,000.00, allowing us the funds to pursue future growth and economic diversification. Additionally, we have put legislation in place to protect our culture and our heritage. While this list is not exhaustive, it highlights the diligence, cooperation, and commitment I have had to move our Tribe forward and to working with the entire Business Committee to represent the General Council with honor and dedication.

While we have seen many advancements the last 4 years, I would be remiss if I did not mention the emergence of COVID-19 and the subsequent challenges it presented. First and foremost is the health and safety of our Tribe and our employees. To address these health and safety concerns, I supported actions such as issuing a State of Emergency, direct stimulus payments (\$1,000 from CARES funding, \$2,500 from ARPA funding, and an additional \$1,000 for elderly and disabled tribal members), and establishing ongoing programs to address future medical, utility, internet, and supplemental pay needs.

In addition to the actions mentioned above, I have been committed to working towards achievements that benefit the Tribe as a whole and protect our sovereignty. I am proud to have voted to provide funding to the Housing Authority to build desperately needed homes, to have supported multiple land purchases within our jurisdiction, to have advocated for the establishment of our own tribal court, to have voted to increase funding to the Home Improvement Program and First Time Down Payment Assistance Program, and to have supported the involvement of youth in extracurriculars (both through donations and through the establishment of a benefits program).

Over the last 4 years, I have worked hard to maintain and strengthen the integrity, sovereignty, and culture of the Tribe and to move us forward economically. I am dedicated to continuing the work as 1st Council of the Business Committee. I ask for your continued support and your vote this election. Sincerely,

My name is Clint Kissee. I am 59 years old, and have lived in the Wyandotte area most of my life. I am running for the position of First Council on the Business Committee. I am retired now, and stay busy working in the garden, taking care of the family land, and learning native archery skills such as bowmaking, flintknapping, arrow making, and other primitive skills.

QUALIFICATIONS FOR THIS OF-FICE IN BRIEF:

I have been involved with the tribe for many years. I served on the Election

Board for several years, and served on the Powwow Committee for 10+ years, serving as Co-chair and Chairman for the last 6 years of my tenure. I resigned a couple years ago to help take care of my parents when Dad's health started failing. During my teaching career, I was an officer in the Career Tech teachers association for my subject area for many years, serving one term on the executive board as Vice-President and President. My years of service in my career and with the tribe will help me to serve on the Business Committee. I have worked with people most of my life, and have learned to hear and listen to other points of view, and make decisions that are based on all input.

REASONS FOR RUNNING FOR OFFICE

I am running for the BC to try and help our tribe create and expand our business interests. Many other tribes in OK are creating diverse business opportunities outside of gaming, and creating many jobs for tribal members, as well as providing services to tribal members. I also want to help ensure our tribe will hire qualified tribal members for jobs whenever possible, and ensure tribal members feel they have job security no matter what their tribal politics



I feel our tribe hasn't progressed much the last several years because of continuous turmoil within our tribe due to tribal politics, and I feel several tribal members who were also tribal employees were terminated or harassed because of this turmoil. It's time to start making decisions based on what is best for the tribe as a whole, not who is or is not supporting one side or the other. It's also time to start recruiting our qualified tribal members to come and help build our tribal businesses and work in our tribal government with the confidence they can do so with competitive pay and the job security to allow them to make a career and raise a family while doing so. It's way past time to change the mindset of making decisions based on tribal politics, and time to start making decisions based on what will strengthen and build our tribe as a whole.



TRAVELS TO OUR HOMELANDS

It is most unusual, but various Business Committee members or I have traveled to Ohio to represent our tribe on three different occasions in the last month. The first trip was to attend the unveiling of the sculpture of Tecumseh where all three federally recognized Shawnee Tribes were honored by re-

questing our presence at the unveiling. Attending were Business Committee members Second Chief Chris Samples, first council Dee Gardner, third council Norma Kraus and Chief Glenna J. Wallace. That two-day event ended on a Saturday night and the next morning Gardner, Kraus and Wallace drove to Serpent Mound where programming for the spiritual Shawnee Summer Solstice was already in process and Chief Wallace made presentations for three days.

The following week Chief Wallace returned to Ohio for the ground-breaking of Ohio's 76th State Park, the Great Council, where tribal citizen Talon Silverhorn and Chief Wallace have been active for several months in the planning of the ten million Shawnee facility. Chief Wallace also met with Ohio Governor Mike DeWine to discuss the possibility of his coming to Oklahoma later this year. Following are newspaper write-ups of two of these occasions.

OHIO'S 76TH STATE PARK SIGNALS MORE COLLABORATION WITH SHAWNEE TRIBE

A new state park is coming to southwest Ohio. Great Council State Park will be located between Xenia and Yellow Springs at the site of a former Shawnee settlement called Oldtown.

The park will feature a \$10 million interpretive center designed in the traditional council house form used by Shawnee tribes. It's expected to open in 2023.

Glenna J. Wallace, chief of the Eastern Shawnee Tribe of Oklahoma, was at the park's groundbreaking and has been involved in the center's planning process.

"It's a combination of the past, the present and the future. I think it's an excellent concept,' Wallace said. "I think that we want to tell our stories, but we also want to correct some incorrect stories that have been told and that people might think about today."

The interpretive center at Council State Park is planned to be three stories tall, with one floor dedicated to modern stories of the Shawnees.

"Too many people think that when we left Ohio, we disappeared from the surface of the United States. That's simply not so. We are strong tribes today." She said. "We have our challenges, we

have our successes and we work hard at maintaining our culture, working for our people, and making them proud of being Shawnee." The center will also tell the stories of people from other Ohio Valley tribes and settlers like Daniel Boone and Simon Kenton.

Tecumseh returns to Shawnee Prairie

GREENVILLE — More than 200 people witnessed Tecumseh's return to Shawnee Prairie Preserve on Friday, June 17, 2022. The unveiling of Tecumseh's statue was a three-fold celebration honoring the intrepid Shawnee warrior, and his influence on local history, the launch of the Darke County Center

Tecumseh, sculpted by Joshua Shepherd, is the initial installations of the Darke County Art Trail.


for the Arts (DCCA) public Art Trail, and the 50th anniversary of Darke County Parks (DCP).

DCP Director Roger Van Frank, who will retire in December, emceed the event, taking special pride in introducing representatives from all three federally recognized Shawnee tribes: The (Loyal) Shawnee, the Eastern Shawnee, and the Absentee Shawnee (so named because they did not attend the signing of an 1854 treaty for a Kansas reservation). They traveled from

Oklahoma to attend the ceremony, marking the first time all three Shawnee Tribes have been back in Ohio, at the same time, since the Indian Removal Act of 1832 forced them westward.

Chief Glenna Wallace of the Eastern Shawnee Tribe, spoke of her ancestors, who, together with the Seneca, were known as the "mixed band." U.S. soldiers planned to load them onto watercraft for the journey

Tar Creek Happenings

For the second year in a row, Tar Creek has been named one of the America's Most Endangered Rivers by American Rivers. Although many years ago, the mining around Tar Creek was abandoned, the pollution that still comes up from the underground discharge into the creek is still a public health concern. That doesn't mean that there is no hope for Tar Creek. The work to improve Tar Creek continues.

One of the groups working on Tar Creek is LEAD Agency in Miami, OK. Local Environmental Action Demanded, or LEAD, has been active in the Tar Creek area for many years and is still busy informing residents and demanding improvement for the creek and for public health. Rebecca Jim is the Tar Creekkeeper and Martin Lively is the Grand Riverkeeper as part of the Waterkeeper Alliance. Both are active this summer in surveys, trainings, cleanups, and planning the next conference.

The 24th Tar Creek Conference will be held October 10-12 at NEO College Student Union, on the banks of Tar Creek. The annual conference is a great opportunity for residents to hear from the tribes and agencies working to make things better, and monitoring changes in water quality and in the health of people. There is always work happening. More information on the Conference can be found at the LEAD Agency website and Facebook page.

LEAD Agency is also conducting flood survey and a well survey in Miami, OK. The well survey is for residents east of Tar Creek with private wells and will be used to get the wells sampled by Oklahoma Department of Environmental Quality or Indian Health Services. These wells may be compromised by the Boone Aquifer, and it is important to get them checked. And thanks to a small grant from the Western Mining Action Network to LEAD Agency, Brita pitchers and filters will be provided to the first 40 who give permission to get their wells sampled.

Other active groups at Tar Creek include the area tribes, including the Eastern Shawnee Tribe of Oklahoma. Quapaw Nation is remediating much of their tribal lands around Tar Creek. All area tribes participate in Tar Creek Trustee Council and Tri-State Mining District meetings and studies. Many government agencies like United States Environmental Protection Agency, United States Geological Service, United States Fish and Wildlife Service, and state environmental agencies like Oklahoma Department of Environmental Quality are working with the tribes in these groups.

University of Oklahoma has active student participation in Tar Creek studies.

The Center for Restoration of Ecosystems and Watersheds and Dr. Bob Nairn from OU have been working for many years on remediation and using natural infrastructure and ecological engineering to filter the mining discharge. The passive treatment systems they have established are making a difference and are an excellent example of education in action.

Cyberbullying is bullying that takes place over digital devices like cell phones, computers, and tablets. Cyberbullying can occur through SMS, Text, and apps, or online in social media, forums, or gaming where people can view, participate in, or share content. Cyberbullying includes sending, posting, or sharing negative, harmful, false, or mean content about someone else. It can include sharing personal or private information about someone else causing embarrassment or humiliation. Some cyberbullying crosses the line into unlawful or criminal behavior.

The most common places where cyberbullying occurs are:

- Social Media, such as Facebook, Instagram, Snapchat, and Tik Tok
- Text messaging and messaging apps on mobile or tablet devices
- Instant messaging, direct messaging, and online chatting over the internet

- Online forums, chat rooms, and message boards, such as Reddit
- Email
- Online gaming communities

Special Concerns

With the prevalence of social media and digital forums, comments, photos, posts, and content shared by individuals can often be viewed by strangers as well as acquaintances. The content an individual shares online - both their personal content as well as any negative, mean, or hurtful content - creates a kind of permanent public record of their views, activities, and behavior. This public record can be thought of as an online reputation, which may be accessible to schools, employers, colleges, clubs, and others who may be researching an individual now or in the future. Cyberbullying can harm the online reputations of everyone involved - not just the person being bullied, but those doing the bullying or participating in it. Cyberbullying has unique concerns in that it can be:

Persistent – Digital devices offer an ability to immediately and continuously communicate 24 hours a day, so it can be difficult for children experiencing cyberbullying to find relief.

Permanent – Most information communicated electronically is permanent and public, if not reported and removed. A negative online reputation, including for those who bully, can impact college admissions, employment, and other areas of life.

Hard to Notice – Because teachers and parents may not overhear or see cyberbullying taking place, it is harder to recognize.

Laws and Sanctions

All states have laws requiring schools to respond to bullying. As cyberbullying has become more prevalent with the use of technology, many states now include cyberbullying, or mention cyberbullying offenses, under these laws. Schools may take action either as required by law, or with local or school policies that allow them to discipline or take other action. Some states also have provisions to address bullying if it affects school performance. You can learn about the laws and policies in each state, including if they cover cyberbullying.

The best way to help our kids is to educate ourselves. This isn't the world we all grew up in, so we parents/guardians/teachers have to educate ourselves on what our kids are facing. It's important that everyone in our community know they are NOT ALONE! Haven is here to help and provide services.

Seasonal Affective Disorder

Typically winter with its grey skies and frigid days are known to go hand in hand with feeling down during the winter months. The feeling of sadness or becoming depressed can occur during the summertime as well for up to 30 percent of individuals. Typically the common symptoms of depression are experienced during the four or five months of warmer weather.

An individual suffering from SAD during summer may experience agitation, anxiety, insomnia, lack of appetite, and in extreme cases instances of violent behavior. These can be triggered by the sudden change in routine caused by summer. This can include heat and humidity, financial stress due to rising cost of cooling a home or childcare, vacationing, body image issues due to the more revealing nature of summer clothes and change in daily routine. This can include having children

at home from school, lack of sleep due to longer day hours etc. The risk of Seasonal Affective Disorder increases for females, those that have a familial history of mental illness or if you have been diagnosed with major depressive disorder, bipolar disorder, or other mental illness.

Some helpful ways to cope with Seasonal Affective disorder is to identify the triggers causing it, getting plenty of sleep, creating a routine and staying with it, getting plenty of sun as your body absorbs vitamin D from the sunlight, and taking time for yourself. If these do not help, seeing your physician or counselor is recommended.

If you find yourself in crisis and need to speak someone immediately the National Suicide and Crisis hotline is 1-800-273-TALK and soon will be also the three digit number 988.

INTER-TRIBAL COUNCIL FOOD DISTRIBUTION

The EOB will show the amount of expenses paid by the plan and the amount you must pay. For expenses that are partially covered by you or your dependents insurance plan, you must attach the EOB.
- **B.** All other expenses: For medical expenses not covered at all by any insurance plan, burial, school expenses and utilities, your claim must include acceptable evidence of your expenses. Acceptable evidence includes receipts which contain the following information:
 - Type of service or product provided
 - Date expense was incurred
 - Person or organization providing the service and product
 - Amount of expense

Step 4: Read the certification, sign and date the form where indicated

Step 5: Submit your form

Chief's Report – Chief Glenna Wallace Thank You- received from Suzanna Profit for the tribe's sponsorship of the application submitted to the World Heritage Designation for the protection of the mounds in Ohio and Mary Ledford thanking the Chief and tribe for the food distribution program.

Donation Request – Seneca Fire Auxiliary submitted a request for a donation for their Annual 4th of July Celebration. Melanie Heskitt, GM of Indigo Sky reports that Indigo Sky had donated, and the BC did not take any action for this donation.

Director's Reports - Reports were pre-

viously provided to all BC members. HIP Report – 20 additional applications have been approved. 6 remain available for \$10,000 for home improvement. You must own the home for at least one year.

SUMMER YOUTH – The summer youth program is ready to start.

TINY HOMES – A video of the Tiny Homes was presented by Chief Wallace showing what the Tiny Homes looked like. A gazebo and fencing will be added. These homes have been turned over to HAVEN.

SANDY CAPTAIN CULTURAL CENTER – The room next to the outer kitchen will be turned into a bedroom area for when the cooks come. The cooks could be there for three days, and this will provide a sleeping area. There will be a washer and dryer as well and an ice machine placed in this area. It was agreed by all to increase the amount of money needed to complete this project as the \$6,000 remaining is insufficient for the completion.

DARKE COUNTY'S TRAIL OF ART – will be held June 18-19, 2022, in Ohio. Talon Silverhorn, tribal member will be joining us there.

SERPENT MOUND – June 19, 20, and 21st, 2022.

OLDTOWN GROUNDBREAKING – June 27th, 2022, in Ohio.

BREAK IN NATIVES CONNECTED – A female broke into this building. After breaking a glass and doing other damage to the building the keys to a van was found leading to the van being stolen resulting in \$37,802.33 in damages. The female subject has not been arrested at this time. Federal charges will be filed.

FHLB CONTRACT – Paperwork has been received and the check will be sent to pay off the \$160,000 loan from the Federal Home Loan Bank.

GUY BARKER MEET AND GREET

– Mr. Barker is running against Mark
Wayne Mullin in the upcoming elections. Chief Wallace would like permission to sponsor a meet and greet

at the ITC building stating it would be beneficial to have a Native American from this area elected to this position. Mr. Barker is the Treasurer of the Quapaw tribe. Discussion followed concerning donating to his campaign fund. MOTION: The motion to make a \$2,000 donation not to exceed the donation limits was made by Treasurer Barrett with second by Secretary Little-field

Motion carried: 4 approved (Daugherty, Kraus, Barrett, Littlefield), 0 opposed, 0 abstained, 1 absent (Gardner). FOOD DISTRIBUTION – scheduled for the 23rd of this month. This is going well and staying within budget.

110 ROAD – We had a meeting this afternoon at 2:30 and final plans and drawings are scheduled to be in by July 15th.

RURAL SURFACE TRANSPORTATION GRANT PROGRAM-We contracted with Jenny McCullan who owns her own grant writing company. She feels this is a strong grant and it would pay for 110 Road. This is a \$4,785,000 grant. This grant has been submitted and we should know something in 45 days.

BROADBAND GRANT 2.6 million – we have received positive feedback on this grant.

ICDBG GRANT, NOT FUNDED IHBG GRANT, NOT FUNDED

ECLC SUMMER PROGRAM INCI-DENT – Friday of last week the buses had gone to All Abord which is close to Redings Mill. On the return trip home on Hwy. 86 one of the children on the bus unbuckled their seat belt and got up and began moving around the bus causing the driver to pull over to return the child to their seat. Unfortunately, the driver pulled over into the ditch and another child opened the back door and started letting children out. In the chaos no one was hurt. Meetings were held to determine how to respond to incidents like this in the future.

SPLASH PAD – Chief has requested additional information from Brinko

and this information will be sent to Inhouse Counsel when received.

SEWER PROJECT - \$65,000 has already been allocated for the pipe. We have contacted the Pipe Company and they will refund every penny. We had purchased 6- and 8-inch pipe for this project but to connect to the City of Seneca sewer lines we need 10-inch pipe. The company that holds the \$65,000 has submitted a bid for \$85,000 as they would have to go deeper for the 10-inch. This is a firm bid with the exception that right across the road there is lots of limestone so this could cause use of a jackhammer, and this would be an additional fee. 2nd Chief Samples asked Chief to obtain a contingency for a rock remediation clause from the company.

WOODLANDS ROCKS/SOD-Three bids were presented. The first bid - \$74,000, second bid - \$46,700 and third bid - \$59,400. All in agreement to accept the low bid.

OTHER QUOTES-Waste Water Treatment Center (to evaluate the capacity of our wastewater treatment center). The bid is \$15,100 from ECCI. All in agreement to accept this quote. The quotes for the fence around the wastewater treatment plant - First quote - \$26,685.81 and second quote - \$30,495.00. (These quotes are for replacement of the wooden fence that is in deteriorating condition and needs to be replaced). Request by 2nd Council Daugherty for our construction department to do the work to replace the fence. Chief Wallace will take this back to Tracy to see if our construction crew may be able to handle this project. Chief Wallace agrees and this discussion will be moved to the next meeting. ELDERS CRISIS PROGRAM - Chief Wallace requests that this program be placed under the direction of Amber Mittag under special projects.

Treasurer Barrett requested that OTFC be added to the next agenda.

Funds will be used for the Haven Emergency Temporary Homes daily running hiring of an advocate to assist with the clients in the homes, purchase of a modular office for the advocate to be located at the Emergency Temporary Homes as well as establishing safety at the space. We will use funds to put in a fence, set up security cameras, and furnish the office at the space. These funds will pay for the monthly electric, water/sewer, and internet charges of the homes as well as the modular office and pay for the supplies needed for clients in the homes such as bedding, food, and cleaning of the homes, etc. The funds will allow Haven to cover food costs for all outreach and education events held by Haven and pay for the continuation salary (in year four and five) of the Haven Mobile Unit and transport Advocate (hired with the FVPSA ARP funds in 2022.

This grant application is due in Just-Grants by June 23, 2022. This is a non-competitive formulated grant. No matching funds are required.

BUSINESS ANNOUNCEMENTS

The Business Committee has decided to close the Eastern Shawnee Travel Center at the end of June.

We have engaged Klaus Robinson to conduct two feasibility studies for us. One is for Indigo Sky Casino and Resort. The second is for economic development opportunities on the Elbert property. We should have those back for us to review in July.

CASINO OPERATIONS

Our gaming operations continue to do well. We were able to transfer \$14.5 million to the tribe that was not budgeted in May. We committed those funds to a \$10 million Operating Reserve and \$4.5 to a Maintenance Reserve. Based on financial data we are doing better than 2018, 2019, and 2020. 2021 was a record-breaking year across the country for the gaming industry both tribal and commercial. Some months we are exceeding the 2021 numbers and some we are not.

The Business Committee has taken a proactive step to commit funding to reserves the past two years in anticipation of an economic downturn. In 2021 we committed \$7 million to reserves and

this year we committed \$14.5 million. ESTE UPDATE

We are continuing to wind down Burggraf Corporation operations. All the N2N companies have been dissolved. Burggraf is transferring \$232,670.80 to ESTE to pay off the loan and interest for the loan ESTE gave Burggraf in July of 2015. ESTE is then transferring this money to the tribe. This money will be deposited into the tribe's economic development account.

BUDGET MODIFICATIONS

The Business Committee approved a \$200,000 budget modification for the HIP Program a few months ago. The last report we received is that there are still open spots in this program. We also approved A \$20,000 budget modification for the Hardship Program since it ran out of funding last month.

Treasurer Barrett read a thank you not from JR Conrad for the donation made to the football camp for children which provided financial assistance for the Ellick family whose daughter is currently undergoing treatment for cancer in Memphis,

Tennessee.

Treasurer Barrett provided information about the Heartland Forward program. Along with its partner Builders +Backers they have used a new approach to problem solving to stimulate entrepreneurial thinking and action across the heartland. Working with local partners, they have supported 15 Builders in Oxford, MS and Tulsa, OK to launch their ideas and solve community challenges. We are the first tribe that they are working with. There will be more information included in the Shooting Star.

The Oklahoma Tribal Finance Consortium will be hosting an event to celebrate the partnership between our Tribal Nations in Oklahoma, Oklahoma Communities and their Business Partners with a special dinner and reception on Tuesday, August 9th, 2022, at Cox Business Center in Tulsa.

Information was also provided on TFCU. TFCU has a partnership pro-

gram that they offer. Federal Credit Union is the largest credit union in the state with over 32 branches. They partner with large and small companies, tribes, non-profits, churches, schools, universities and other community organizations. They offer many great perks that come with the partnership. They present free, in-person financial education workshops throughout the state of Oklahoma with virtual workshops as well. Their trained financial educators are a great resource. The partnership does not involve a contract and is nonexclusive. It is completely free and only a benefit to your members and employees. With this partnership it provides access to the credit union for your employees and tribal members.

tending for the Eastern Shawnees were Chris Samples, his wife and daughter; Dee Gardner and husband Jeff along with Norma Kraus and husband Joe and I. Attending also were Absentee Shawnee Governor John Johnson and Absentee Shawnee Secretary Alicia Miller as well as Business Councilman Kenny Hood representing the Shawnee Tribe. We were told this was the first time all three Shawnee Tribes had been back in Ohio at the same time since 1832 when the 1830 Indian Removal

Act forced them to leave. We had the Tecumseh unveiling ceremony Friday followed by a banquet that night where everyone was most welcoming and excited to host us. Saturday, we visited the Old Council House in Greenville as well as Tecumseh's Point plus viewed the statue of Miami's Little Turtle who fought with BlueJacket. Sunday Chris Samples and his family had to leave for Oklahoma but Dee, Norma, their husbands and Lynette and I drove to Serpent Mound for the summer solstice observance. There I spoke twice a day for three days about the sacredness of all Native American mounds there in

Ohio, but especially Serpent Mound. I reminded them that a certain decorum, a certain reverence was expected for sacred sites and that did not include drugs, liquor, sexual activities, and foreign objects such as crystals thrust into the mounds. It was an excellent trip where everyone came home with more appreciation and knowledge than we had when we first departed Oklahoma. I wish each of you had been able to attend.

Let's turn to things that are currently happening here in the four state corner. Unfortunately we have lost another elder who had been active for many years

in the tribe: Jack Ross. Jack served our tribe in several different capacities. He volunteered to lead our Bingo operations many years ago in our early days of gaming, the late 1980's. He then left the area and returned sometime later. At that point he once again became active in gaming and served as our Gaming Commissioner. Even later he ran for a position on the Business Committee, where he served as Second Chief for 12 years. Our condolences go to Norma, his wife of 63 years, his son Jay and his wife, his granddaughter and two great grandchildren, plus his many siblings and numerous nieces and nephews. Jack's death came quickly after he was diagnosed with cancer. The Eastern Shawnee Tribe is indebted to Jack and his family for the many years he devoted to us. Jack was buried in the Wyandotte Cemetery.

Our Children's Summer Camp and our Shawna Stovall Back-to-School Children's Pow Wow is coming up shortly. The summer camp occurs for three days, Wednesday, Thursday and Friday in the first week of August so that those who come from some distance away can stay one extra day and participate in the Children's Pow Wow on Saturday of that same week. Our Children's Pow Wow is always the first Saturday in August. We are so pleased that we can have the nighttime youth contests this year as we were unable to do these the last two years while COVID was rampant. Daytime activities begin at noon, Saturday, August 6. Free backpacks, school supplies, booth activities and other prizes/gifts will be available. This year Ohio History Connection will be present to film many of the activities with portions of the film footage to be used in future exhibits in various locations.

Other news would be in reference to the progress we have made on 110 Road which as a reminder will connect 695 Road on Highway 10 C just west of the Outpost Casino with 110 Road which will then connect with Stateline Road leading into Seneca, Missouri. We have completed our first phase. This

phase which took six months was the Engineering phase. The road itself is about 1.2 miles in length, will be in the shape of a right triangle with the road running south from Hwy 10C on 695 Road then turning east to connect with Stateline Road. The land is extremely hilly, has several trees that will need removed plus having a wet weather creek run through it and then gas lines and other utility features, making a complicated set of circumstances to engineer. It also takes quite a chunk from our walking trails which we will have to redesign. But as of July 15, we have the finished blueprints. Hudson-Prince, our engineering firm, stayed dedicated to the project. We are indebted to them but thankful to have this portion finished. Next is partnering with Bureau of Indian Affairs (BIA) out of Muskogee who will lead us through the next two phases: preparing bids/advertising the project, selecting the road construction firm and then the final phase of actually constructing the road. We have met with BIA and will be preparing the bid packages for interested parties. We'll keep you apprised of the progress on this undertaking.

The end of this fiscal year is fast approaching. Remember that our financial year runs from October 1 through September 30. That means we have two months remaining: August and September. Our General Council meets the first Saturday following Labor Day, September 10 at Indigo Sky. At the time of this writing, we still have seven remaining slots in our Home Improvement Program (HIP). This program provides up to \$10,000 in home repairs to homeowners, must not have been used in the last 5 years and if awarded cannot be used again for 10 years. I would also remind you that we have a \$3,000 closing costs assistance program for first time home ownership. It is proposed that this program will increase to \$10,000 in assistance in the next fiscal year so if you are considering purchasing a home for the first time, you might consider waiting until after October 1 to request use of these funds.

I remind you that our Annual Fall Pow Wow is fast approaching. The dates this year are September 16, 17, and 18. Indigo Sky has set aside rooms for tribal citizens and made a special rate of \$69 per day available if you ask for your tribal discount. As always, the Pow Wow Committee will be assisting with travel costs. If you have never attended, you don't know what you are missing. After COVID cancellations the last two years, we are eagerly looking forward to seeing everyone.

west. They refused, fearing the rafts would be set on fire, or the blankets would be laced with cholera. Determined to leave Ohio the same way they came: by horseback, or on foot, the Shawnee walked 800 miles to a reservation in Oklahoma.

"Our first return to Ohio was in 2007, and there was a gentle rain for three days," Wallace recalled. "We know our ancestors were crying for joy that we had returned."


Quoting Tecumseh, Absentee Shawnee Governor John Johnson stated "A single twig breaks, but a bundle is strong." He added that Tecumseh, whose name means "falling star," spent his whole life fighting for independence and unity.

"We are the warrior group, we know our language, and we practice our culture," said Absentee Shawnee Tribal Secretary Alicia Miller.

"We're all related," added Shawnee Councilman Kenny Paul Hood, referring to the other two Tribes.

Van Frank responded, "We learned a lot in your words today, and I hope we listened well." He explained the significance of unveiling Tecumseh's statue at Shawnee Prairie: "We know Tecumseh was here," he said, citing Shaker accounts dating back to 1807 that describe their visit to Tecumseh and his brother, Tenskwatawa, The Prophet.

It is therefore fitting that Tecumseh's statue was chosen as the first stop on the new Darke County Art Trail. "We are proud to be unveiling the initial installation, and offering new and unique arts experiences, as well as celebrating art that is

already here in the county," stated DCCA Executive Director Andrea Jordan. Other stops along the Art Trail include Greenville's Annie Oakley statue, St. Clair Memorial Hall, the Maid-Rite Gum Wall, Ansonia's Annie Oakley Barn Mural, and Union City's Mural.

Tecumseh sculptor Joshua Shepherd, a self-taught artist, said, "It was a hobby that accidentally grew

into a career. I've always been interested in history, so this is a dream job." Shepherd takes all types of commissions, but prefers historical figures such as his rendition of Miami Chief Little Turtle (also part of the Art Trail), located at Greenville City Park, and Tecumseh.

Tim Wells, of Michigan, served as coordinator between DCP and the DCCA on the Art Trail. Wells spent

a year as an artist-in-residence in Darke County, advising students at Mississinawa Valley on the Union City Mural. He is starting a podcast on Spotify, and will feature Van Frank, Jordan, Shepherd, and Marilyn Delk. "Roger (Van Frank) and Andrea (Jordan) make my job easy," said Wells, noting their dedication and thoroughness with regards to every aspect of the project. Twenty artists will be included in the Art Trail, with new commissions located along the Tecumseh bike trail.

"I couldn't ask for a better collaboration than DCP and DCCA," stated Darryl Mehaffie, DCCA chairman. "There hasn't been one iota of a

problem." He credited Ohio Senator Matt Huffman's 2020 proposal, and subsequent securing of \$40,000 in the state budget, as being the impetus for the statue. The 2021 state budget included \$180,000 for future Art Trail projects. "We're small compared to other communities, but they saw that we were important enough to get the funding," Mehaffie stated.

"Not everyone has people as dedicated as Darryl Mehaffie and Roger Van Frank," stated Huffman, remarking that Mehaffie has advocated for Darke County on every state budget with which the senator has been involved.

Proclamations were sent to mark the occasion by Governor Mike DeWine's office, as well as that of Lieutenant Governor Jon Husted. U.S. Senators Sherrod Brown and Rob Portman, Congressman Warren Davidson, along with State Representatives Susan Manchester and Jena Powell, sent commendations via senior staff members.

In conclusion, Van Frank turned to the Shawnee leaders, saying, "You've honored Shawnee Prairie, you've honored me. I hereby proclaim, Tecumseh has returned." After a round of applause, and a standing ovation, Van Frank presented the Tribes' officials with framed copies of Tecumseh's Teachings.
