## The Chief's Report . . .

Hatito Fellow Tribal Citizens, It's January, totally dark outside at 5:30 p.m. and once again weather is the topic of discussion here at the Eastern Shawnee Tribe. An unknown poet once wrote,

"Whether the weather be fine, Whether the weather be not; Whether the weather be cold, Whether the weather be hot; We'll weather the weather; Whatever the weather; Whether we like it or not."

I like it NOT, but the forecast is what it is: freezing temperatures and perhaps 5-10 inches of snow accumulation. I had best get this article written in case we have to close down. I love Oklahoma, but I must say Oklahoma could certainly improve when it comes to keeping roads cleared, drivable and safe during bad weather.

I suspect most of you know that over Christmas weekend we not only had bad weather but extremely bad results from that bad weather. Christmas Eve at 5 p.m. an alarm went off at our Early Childhood Learning Center. Thank goodness we have police presence 24/7 so law enforcement officer Brady Barrett heard the alarm and went to investigate, thinking it was the Wellness Center where the problem was. He im-

mediately called Ron Wallace, our Wellness Center Director who went to the Wellness Center and found nothing but stated that the alarm at the Early Childhood Learning Center was connected to the Wellness Center and they needed to check the ECLC to determine if a problem was located there. Sure enough, there was. Pipes had frozen resulting in pipes bursting resulting in water coming into the building. Most of the damage was done at both ends of the ECLC, meaning the north end and the south end while there were areas in the middle that didn't receive much damage, especially the kitchen area and the Safe Room. Help was immediately summoned with the Maintenance Department arriving soon as well as other volunteers. Sweep that water, move that furniture, sweep that water, stack those toys high, sweep that water, and so it went from 5 p.m. until midnight of Christmas Eve. Santa certainly didn't get any Christmas cookies or milk that night at our ECLC. Fans were placed throughout the building, insurance was notified, doors were locked and then we went home. We had the weekend to think about what we were going to do with the more than 100 kiddos who come next week.

But our Christmas adventures didn't end with the Early Childhood Learning Center. Sunday was Christmas Day and Monday, the following day, the tribe was closed providing the employees with a paid holiday. My family celebrated Christmas on Monday morning with a Christmas breakfast, followed by opening of presents. About noon my son Ron and I drove out to the ECLC to see how

## Woodlands Management Report

Woodlands Management will move funds to Woodlands Development to purchase the Tecumseh property from Burgraff. The amount will be \$1,016, 251 (For the building and land and the value of the lease).

The lease will be transferred to Woodlands Development from Burggraf.

ESTE will request a transfer of funds from Burggraf to pay off ESTE physical assets/property then the BC will transfer this back to the holding company.

The note balance will be forgiven in the amount of approximately \$200,000.00.

#### **ESTE and Burgraff Report**

ESTE will be selling the last property to Woodlands Development. The existing lease will be transferred to Woodlands Development. The reason we are selling to Woodlands Development is to reduce the tax liability of Burgraff.

ESTE and Burgraff Corporation will be dissolving after this. The cash will be

used to pay the outstanding notes. My recommendation is to then re-allocate this cash to the holding companies for operating capital.

Eastern Shawnee Economic Services This is a new holding for the possibility of acquiring two construction companies. These funds were set aside a few months by resolution. The new holding company is needed for the bonding company to prevent from having to release the casino and Tribe's financials.

Eastern Shawnee Economic Services is being renamed to Eastern Shawnee Companies.

#### **Totem**

The Business Committee executed a letter of intent with Totem Technologies. Totem is a digital banking app that anyone can use. The Tribe will receive a percentage of the revenue earned by Totem from debit card transactions. Totem is trying to resolve access to banking faced by tribal members. 17% of Native Americans are not banked. A press release will be issued next month announcing our partnership. This cost the tribe nothing. The app is expected to launch in the second quarter of 2023.

#### **Indigo Sky Online**

#### Eastern Shawnee Tribe of Oklahoma first to offer Totem accounts

Partnership provides digital bank accounts to enrolled members, revenue to the tribe

Tulsa, Oklahoma — Totem Technologies, Inc. and the Eastern Shawnee Tribe of Oklahoma have entered into a strategic partnership to create pathways to financial inclusion for tribal members through digital banking. The entities will work together to deliver culturally relevant financial products and education, while streamlining access to the benefits provided by the tribe.

"We are always looking at ways to empower our citizens," said Eastern Shawnee Chief, Glenna J. Wallace. "Working with Totem provides a great opportunity for us to provide best-in-class financial products to our people while simultaneously growing economic opportunities in areas that we already lead in — namely, financial services and innovation."

The Eastern Shawnee Tribe is Totem's first announced partner and already has an established expertise in financial technology. The tribe is a majority owner of the Peoples' Bank of Seneca, a \$364 million asset institution based in Seneca, Missouri, and recently announced that it is developing a gaming venture in the Metaverse featuring a variety of virtual goods.

Partnering with Totem will enable the tribe to offer FDIC-insured accounts with no monthly fees or balance minimum requirements to its members nationwide. Accounts are held in partnership with Oklahoma-based First Pryority Bank, Member FDIC.

In addition to a virtual and physical debit card, a network of 55,000 surcharge free ATMs, and 2-day early paycheck access (see terms and conditions here), Totem is designed to improve its customers' financial health. It encourages incremental savings and responsible spending, and the company plans to roll out a credit-builder product later this year.

Totem is distinguished from other digital banks through its focus on building Native wealth. First, the app provides information on national and tribe-specific benefit programs to enable its users to access financial support. Second, it engages in revenue-sharing with its partner tribes. Every time a tribal member uses their Totem debit card to make a purchase, a portion of the fees generated from the transaction go back to the tribe.

"We couldn't be happier to be working with the Eastern Shawnee Tribe of Oklahoma to launch Totem," said Amber Buker, Totem's founder and CEO. "Together with our current and future tribal partners, we're working to create a new tradition of Native wealth-building that will help all of our people thrive for generations to come."

Totem is set to launch in spring 2023. Individuals can sign up for the waitlist to receive monthly updates and early account access here.

#### FROM THIS CORNER

### **BUD NELSON: DON'T TELL HIM WHAT TO DO**

Former mechanic, Navy veteran, member of the prestigious Seals, owner of a Consignment Auction Company, restorer of antique furniture, voracious talker, one who shares his opinions freely and in country vernacular tells you just how to cut the cabbage, Bud Nelson is an active Eastern Shawnee elder. From attending Business Committee meetings to talking to many tribal citizens on the phone, the man loves to talk and doesn't mince words. If that description seems harsh to you, let me quickly add that he's also the man who pays for a lady's groceries at the store when she is running short of cash, stops his vehicle to give a walking man a ride, gets down on the floor and wrestles with his grandchildren, keeps bicycles at his house for kids without one to ride, helps people whenever or however he can. Yes, he's a man who never meets a stranger, never shies away from giving his opinion and giving it in plain words with maybe a cuss word or two laced in there someplace. For example, take his often quoted line known as the six p's: "Prior Planning Prevents Piss Poor Performance." Bud is Bud.

Now 88 years young, Bud has a long history with the tribe. The son of Forrest and Vance Dushane Nelson, he is the grandson of our second Chief since the adoption of our constitution in the late 1930's, Chief Dave Dushane and wife Allie. Bud comes from a family of six children: sisters Carmalita Nelson Handcock, Marcella better known as Dee Nelson Griffith, Josephine or Jo Nelson Barnes, Rhonda Nelson, younger brother Doyle better known as Butch Nelson and Bud himself. He has lived in the Seneca/Wyandotte area much of his life. In his childhood days the family lived on Eastern Shawnee Tribal land just across Lost Creek which is now our Ceremonial Grounds. His grandparents




lived on the old Dushane Farm just below Indigo Sky which they now refer to as the Old Homeplace where he and his family spent many hours along the banks of and in Lost Creek fishing, climbing trees, swimming, picnicking and playing on gravel bars as well as looking for arrowheads amongst the rocks. He fondly recalls Lost Creek as having a nearby Spring that was so cold they would begin their day by placing a watermelon in the cold, cold water and

when they were ready to eat the melon was ice cold.

A not so pleasant memory regarding the Old Homeplace is the death of his uncle Jimmy Curtis Dushane, named after Charles Curtis the first with American Indian ancestry to hold the second highest office in the United States, who being only a few months older than Bud made them more like brothers than uncle and nephew. Jimmy Curtis went

to the rural school of South Number 7 which is located about one mile west of Indigo Sky. Jimmy loved to trap animals on the steep bluffs of the Old Homeplace and was running his traps one morning before going to school when he slipped, lost his footing and fell, not surviving the accident. Losing Jimmy Curtis, the youngest of Dave and



Allie's family, seemingly left a curse or eerie feeling on the land and life there was never the same. Years later the Dushane Homeplace was sold to Vic and Imogene Elbert who later sold it to the Eastern Shawnee Tribe for construction of Indigo Sky.

A distinct personality, Bud doesn't believe in the word "can't". Tell him something can't be done and he will prove to you that it can be. One of the most unusual oddities about Bud is that he does not have a certified birth certificate. A midwife living near where Indigo Sky is today delivered Bud when he was born. When the doctor came to check on the birth, the doctor didn't write down the date. Consequently Bud was never able to have a certified birth certificate. Years passed without verifiable documentation. He even used his sister Dee's birthyear to join the Navy at age 16. He was told he would never be able to draw Social Security because

We still have our Car Seat and Newborn Starter Kit programs; you must live within a 100-mile radius of our office to be eligible for these programs. These programs are funded with the CCDF grant and this is our service area per our grant guidelines.

## **9 Steps to More Effective Parenting**

Raising kids is one of the toughest and most fulfilling jobs in the world — and the one for which you might feel the least prepared.

These 9 child-rearing tips can help you feel more fulfilled as a parent.

#### 1. Boost Your Child's Self-Esteem

Kids start developing their sense of self as babies when they see themselves through their parents' eyes. Your tone of voice, your body language, and your every expression are absorbed by your kids. Your words and actions as a parent affect their developing self-esteem more than anything else.

Praising accomplishments, however small, will make them feel proud; letting kids do things independently will make them feel capable and strong. By contrast, belittling comments or comparing a child unfavorably with another will make kids feel worthless.

Avoid making loaded statements or using words as weapons. Comments like "What a stupid thing to do!" or "You act more like a baby than your little brother!" cause damage just as physical blows do.

Choose your words carefully and be compassionate. Let your kids know that everyone makes mistakes and that you still love them, even when you don't love their behavior.



#### 2. Catch Kids Being Good

Have you ever stopped to think about how many times you react negatively to your kids in a given day? You may find yourself criticizing far more often than complimenting. How would you feel about a boss who treated you with that much negative guidance, even if it was well-intentioned?

The more effective approach is to catch kids doing something right: "You made your bed without being asked — that's terrific!" or "I was watching you play with your sister and you were very patient." These statements will do more to encourage good behavior over the long run than repeated scoldings.

Make a point of finding something to praise every day. Be generous with rewards — your love, hugs, and compliments can work wonders and are often reward enough. Soon you will find you are "growing" more of the behavior you would like to see.

## 3. Set Limits and Be Consistent With Your Discipline

Discipline is necessary in every household. The goal of discipline is to help kids choose acceptable behaviors and learn self-control. They may test the limits you establish for them, but they need those limits to grow into responsible adults.

Establishing house rules helps kids understand your expectations and develop self-control. Some rules might include: no TV until homework is done, and no hitting, name-calling, or hurtful teasing allowed.

You might want to have a system in place: one warning, followed by consequences such as a "time out" or loss of privileges. A common mistake parents make is failure to follow through with

the consequences. You can't discipline kids for talking back one day and ignore it the next. Being consistent teaches what you expect.

#### 4. Make Time for Your Kids

It's often hard for parents and kids to get together for a family meal, let alone spend quality time together. But there is probably nothing kids would like more. Get up 10 minutes earlier in the morning so you can eat breakfast with your child or leave the dishes in the sink and take a walk after dinner. Kids who aren't getting the attention they want from their parents often act out or misbehave because they're sure to be noticed that way. Many parents find it rewarding to schedule together time with their kids. Create a "special night" each week to be together and let your kids help decide how to spend the time. Look for other ways to connect — put a note or something special in your kid's lunchbox.

Teens seem to need less undivided attention from their parents than younger kids. Because there are fewer windows of opportunity for parents and teens to get together, parents should do their best to be available when their teen does express a desire to talk or participate in family activities. Attending concerts, games, and other events with your teen communicates caring and lets you get to know more about your child and his or her friends in important ways.

Don't feel guilty if you're a working parent. It is the many little things you do — making popcorn, playing cards, window shopping — that kids will remember.

#### 5. Be a Good Role Model

Young kids learn a lot about how to act by watching their parents. The younger they are, the more cues they take from you. Before you lash out or blow your top in front of your child, think about this: Is that how you want your child to behave when angry? Be aware that you're constantly being watched by your kids. Studies have shown that children who hit usually have a role model for aggression at home.

Model the traits you wish to see in your kids: respect, friendliness, honesty, kind-

ness, tolerance. Exhibit unselfish behavior. Do things for other people without expecting a reward. Express thanks and offer compliments. Above all, treat your kids the way you expect other people to treat you.

#### **6. Make Communication a Priority**

You can't expect kids to do everything simply because you, as a parent, "say so." They want and deserve explanations as much as adults do. If we don't take time to explain, kids will begin to wonder about our values and motives and whether they have any basis. Parents who reason with their kids allow them to understand and learn in a nonjudgmental way.

Make your expectations clear. If there is a problem, describe it, express your feelings, and invite your child to work on a solution with you. Be sure to include consequences. Make suggestions and offer choices. Be open to your child's suggestions as well. Negotiate. Kids who participate in decisions are more motivated to carry them out.

## 7. Be Flexible and Willing to Adjust Your Parenting Style

If you often feel "let down" by your child's behavior, perhaps you have unrealistic expectations. Parents who think in "shoulds" (for example, "My kid should be potty-trained by now") might find it helpful to read up on the matter or to talk to other parents or child development specialists.

Kids' environments have an effect on their behavior, so you might be able to change that behavior by changing the environment. If you find yourself constantly saying "no" to your 2-year-old, look for ways to alter your surroundings so that fewer things are off-limits. This will cause less frustration for both of you.

As your child changes, you'll gradually have to change your parenting style. Chances are, what works with your child now won't work as well in a year or two. Teens tend to look less to their parents and more to their peers for role models. But continue to provide guidance, encouragement, and appropriate discipline

while allowing your teen to earn more independence. And seize every available moment to make a connection!

#### 8. Show That Your Love Is Unconditional

As a parent, you're responsible for correcting and guiding your kids. But how you express your corrective guidance makes all the difference in how a child receives it.

When you have to confront your child, avoid blaming, criticizing, or fault-finding, which hurt self-esteem and can lead to resentment. Instead, try to nurture and encourage, even when disciplining your kids. Make sure they know that although you want and expect better next time, your love is there no matter what.

## 9. Know Your Own Needs and Limitations as a Parent

Face it — you are an imperfect parent. You have strengths and weaknesses as a family leader. Recognize your abilities — "I am loving and dedicated." Vow to work on your weaknesses — "I need to be more consistent with discipline." Try to have realistic expectations for yourself, your partner, and your kids. You don't have to have all the answers — be forgiving of yourself.

And try to make parenting a manageable job. Focus on the areas that need the most attention rather than trying to address everything all at once. Admit it when you're burned out. Take time out from parenting to do things that will make you happy.

Focusing on your needs does not make you selfish. It simply means you care about your own well-being, which is another important value to model for your children.

#### Flu: What To Do If You Get Sick

## COMMON SIGNS & SYMPTOMS OF FLU

#### **FLU SYMPTOMS**

Influenza (flu) can cause mild to severe illness, and at times can lead to death. Flu symptoms usually come on suddenly. People who have flu often feel some or all of these symptoms:

- fever\* or feeling feverish/ chills
- cough
- sore throat
- runny or stuffy nose
- muscle or body aches
- headaches
- fatigue (tiredness)
- some people may have vomiting and diarrhea, though this is more common in children than adults.

\*It's important to note that not everyone with flu will have a fever.

#### What should I do if I get sick?

Most people with flu have mild illness and do not need medical care or antiviral drugs. If you get sick with flu symptoms, in most cases, you should stay home and avoid contact with other people except to get medical care.

If, however, you have symptoms of flu and are in a higher-risk group, or are very sick or worried about your illness, contact your health care provider (doctor, physician assistant, etc.).

Certain people are at increased risk of serious flu-related complications (including young children, people 65 and older, pregnant people, and people with certain medical conditions). For a full list of people at increased risk of flu-related complications, see People at Higher Risk of Developing Flu–Related Complications. If you are in a higher-risk group and develop flu symptoms, it's best for you to contact your doctor early in your illness. Remind them about your higher-risk status for flu. CDC recommends that people at higher risk for complications should get antiviral treatment as early as possible, because benefit is greatest if treatment is started within 2 days after illness onset.

## Do I need to go to the emergency room if I am only a little sick?

No. The emergency room should be used for people who are very sick. You should not go to the emergency room if you are only mildly ill.

If you have emergency warning signs of flu sickness, you should go to the emergency room. If you get sick with flu symptoms and are at higher risk of flu complications or you are concerned about your illness, call your health care provider for advice.

#### Are there medicines to treat flu?

Yes. There are drugs your doctor may prescribe for treating flu called "antivirals." These drugs can make you better faster and may also prevent serious complications. See Treatment – Antiviral Drugs for more information.

#### How long should I stay home if I'm sick?

CDC recommends that you stay home for at least 24 hours after your fever is gone except to get medical care or other necessities. Your fever should be gone without the need to use a fever-reducing medicine, such as Tylenol®. Until then, you should stay home from work, school, travel, shopping, social events, and public gatherings. CDC also recommends that children and teenagers (anyone aged 18 years and younger) who have flu or are suspected to have flu should not be given Aspirin (acetylsalicylic acid) or any salicylate containing products (e.g. Pepto Bismol); this can cause a rare, very serious complication called Reye's syndrome. More information about Reye's syndrome can be found here.

#### What should I do while I'm sick?

Stay away from others as much as possible to keep from infecting them. If you must leave home, for example to get medical care, wear a facemask if you have one, or cover coughs and sneezes with a tissue. Wash your hands often to keep from spreading flu to others.

#### What are emergency warning signs of flu?

People experiencing any of these warning signs should obtain medical care right away.

#### In children

- Fast breathing or trouble breathing
- Bluish lips or face
- Ribs pulling in with each breath
- Chest pain
- Severe muscle pain (child refuses to walk)
- Dehydration (no urine for 8 hours, dry mouth, no tears when crying)
- Not alert or interacting when awake
- Seizures
- Fever above 104°F
- In children less than 12 weeks, any fever
- Fever or cough that improve but then return or worsen
- Worsening of chronic medical conditions

#### In adults

- Difficulty breathing or shortness of breath
- Persistent pain or pressure in the chest or abdomen
- Persistent dizziness, confusion, inability to arouse
- Seizures
- Not urinating
- Severe muscle pain
- Severe weakness or unsteadiness
- Fever or cough that improve but then return or worsen
- Worsening of chronic medical conditions

These lists are not all inclusive. Please consult your medical provider for any other symptom that is severe or concerning. CDC Centers for Disease Control and Prevention

## **Education Snapshot**

Hello Students!!

Welcome to Spring semester!! This is a friendly reminder that all students must reapply with a new application each semester. If you received scholarship in Fall, you do not automatically qualify for Spring without sending in new paperwork. We are currently busy sending student award letters to your schools! Most of you are aware of this but the reason we send award letters is to let your schools know of your impending award and to let them know that we do not pay out scholarships until after the school's final drop date for the semester. This letter ensures that you will not be dropped from your classes for nonpayment until we are able to send a check. Most all the schools we have worked with will honor our award letter, however, there have been a select

few that will not. If this is the case for you, generally the best plan is to set up a payment plan with the school to ensure that you are not dropped from classes. Anything that you may have to pay out will be reimbursed to you. Just be sure to communicate with us so that we can help guide you. We hate to see students dropped from classes as a lot of the time it is difficult to get back into them.

I would also like to highlight this month the benefits that we offer our younger students. First of all, we offer a grade incentive for all student's 6th through 12th grade!! Once a year at the end of the school year all tribal members can send in a copy of their grades for the entire school year. If the cumulative gpa at the end of the year is either a B or A average, we will reward you! A B average gets an award of \$250, and an

A average gets an award of \$500.

Next, we have our Junior/ Senior benefit for those in the 11th and 12th grades. These students have an allowed benefit max of \$750 for each year that can go towards items that are junior/ senior specific. These items include senior pictures, class rings, prom attire, graduation packages, ACT or SAT fees, etc.

Then specifically for our seniors we have a graduation award. Once a high school senior graduates and receives their diploma if they send us a copy they will receive \$500 for their hard work!!

You can find all of this information on the tribal website under the forms section. It is listed on the 6th through 12th grade application that will need to be filled out to receive these benefits.

## Looking to the Sky By Debbie Dotson, Water Quality Officer

People have always been interested in precipitation and strive to predict patterns in the sky. Basic needs of knowing when to grab a coat or umbrella and using complex sciences to study the effects of flooding and drought are important to all people. Precipitation affects our daily lives and impacts our health, economy, agriculture, and culture.

The water cycle is highly dependent upon precipitation rates, in both the amount of precipitation and the intensity. Recharge of the groundwater supply and our creeks and rivers can vary greatly depending upon precipitation frequency and amounts. Intensity of rainfall is a great concern as climate continues to change and the number of high intensity storms leading to increased flooding.

There is always a lot to learn from the weather no matter your job title or age. There are a couple of great free resources available for monitoring precipitation and tracking past rainfall events.

The first is Mesonet, with at least one site in every county in Oklahoma, and a total of 120 sites currently in the state. The site in Ottawa County is in Miami, OK and it has been active since 1994. Mesonet began in the 1980's with the need to get more real-time, local weather information for agricultural applications and emergency management.

The following are some common parameters that many stations measure:

- Air temperature
- Barometric pressure
- · Rainfall amount
- Relative humidity
- Soil moisture
- · Soil temperature
- Solar radiation
- Wind direction
- Wind speed

The following link https://www.me-sonet.org will take you to the website, where you can select a station for local weather data, past and present.

Another way to monitor precipitation as an individual is using a rain gauge and reporting to a volunteer rainfall network at CoCoRaHs, or the Community Collaborative Rain, Hail, and Snow Network. The nationwide network of rain gauges has been active since 1998 and is comprised from daily reports of precipitation by private citizens. Zero readings are just as important as accumulation "because every drop counts" and the lack of rain is just as important as the quantity in tracking long term.

From the website https://www.cocorahs.org, you can sign up to purchase a standardized rain gauge (approximately \$30) and start entering rainfall from your exact location. Each daily precipitation value is displayed on a map of the United States, and each dot represents a rain gauge location. Precipitation can vary even in a small area, so the more reports, the better the accuracy.

The Eastern Shawnee Tribe Water Quality Monitoring Program has participated in CoCoRaHs since 2012 and uses the data in correlation with tracking spikes in bacteria results, runoff pollution areas, and flow changes in area creeks and rivers.

Mesonet and CoCoRaHs data are both valuable resources for tracking precipitation long term and monitoring flooding and drought conditions. Both websites are available to anyone and have information to help with a wide range of things, from planning what to wear, when to work or plant, and planning for long term building projects and standards.


#### February is Teen Violence Dating Awareness Month

The purpose of the Eastern Shawnee Tribe of Oklahoma Emergency Rental Assistance Program is to provide direct financial assistance, including rent, rental arrears, utilities and home energy costs, utilities and home energy costs arrears, and other expenses related to housing. This program will make available a limited amount of assistance to households that are unable to pay rent and utilities due to the COVID-19 pandemic.

This program will serve eligible households and is subject to available program funding. **Eligibility:** 

- Qualifies for unemployment or has experienced a reduction in household income, incurred significant costs, or experienced a financial hardship due, directly or indirectly, to the Covid-19 outbreak.
- 2. Demonstrates a risk of experienc-

- ing homelessness (rent) or housing instability (utilities and other expenses); and
- Has a household income at or below 80 percent of your area median (FY 2020).

#### **Assistance Provided:**

- 1. Rent
- 2. Rental arrears
- 3. Utilities (electric, gas, water and sewer, fuel oil)
- 4. Utility arrears
- 5. Internet

Eligible households may apply and receive up to three months of assistance at a time, provided funds are available. A maximum of 12 months assistance or \$3,000, whichever should come first.

On July 19, 2016, James "Eric" Clouse was riding his motorcycle home after leaving work at his automotive business. In an instant, Eric was pummeled by an SUV pulling out of a parking lot in Tulsa. When the driver stopped and got out of the vehicle to look at what they had hit, they came upon a mangled motorcycle. Eric had been thrown over the hood of the SUV and was laying on the ground nearby.

When EMS arrived, he was barely breathing and he had obvious injuries to his head, chest, legs and wrist. Once at

the hospital, it was determined that he had rib fractures on both sides, traumatic brain injury, skull fractures, liver and spleen lacerations, both femurs broken, a crushed right heel, and numerous other injuries. In simpler terms, he had multiple life-threatening injuries and was intubated upon arrival.

His initial neurological exam showed minimal activity and the doctor was not convinced that he would survive his injuries. Over the next few hours, they performed another neurological exam and noticed that he had miraculously made some minimal improvements. Unfortunately, he needed to have a portion of his skull removed in order to relieve pressure on his brain. A couple weeks later, they took him to surgery and placed hardware in his ankle and legs. From the time he had been admitted into the hospital to the time he was transferred to a nursing home the doctors told him and his family three

different times that he was going to die.

On October 6<sup>th</sup> 2016, he was transferred to a nursing home in Warner, OK after the hospital did everything they could do for him. His mother Joyce, spent every day with him and was diligent on taking detailed notes on his status and any little changes that she noticed. She then relayed that information over to the doctors. Joyce worked tirelessly to find a facility that accepted patients with a tracheotomy. Thankfully, she found one and he was able to be transferred to a long-term care facility in Webb City and was closer to home.

His mother also helped take him to specialty doctors. She received the surprise of her life while visiting an ear, nose and throat office one day. The doctor took out his trach tube, which he had since the wreck, and he spoke for the first time since the wreck on May 1, 2017. Joyce stated that he said "I'm thirsty, I want something to drink". He then proceeded to take the cup of water they offered and started drinking. A phrase that you would have never thought would make you cry, had Joyce crying tears of joy.

With every win, there was always a battle just around the corner. Later that year, despite all efforts to fix his right leg and ankle, he had his leg amputated above the knee in November of 2017.

In January of 2018, he met with a neurosurgeon and had cranioplasty surgery to replace the portion of the skull that they had removed in the hospital. The neurosurgeon had a 3D synthetic skull made and placed. Against all odds he was then able to return home in July of 2018. In September of 2019 he was fitted with a prosthetic leg and had a wrist fusion about a year and a half ago.

He completed occupational therapy and was able to meet all of his own set goals and still goes to physical therapy to help with contracture of his left side twice a week. He is his harshest critic when it comes improvements and states that he is still working on getting his posture in tip top shape and getting used to the prosthetic.

Eric is a walking miracle and the journey has not been easy, but things worth fighting for don't always come easy. Eric stated that "The wreck tragically altered my life in many ways and that

nothing should ever be taken for granted. Everything can change in a moment." His son Lincoln has been

an enormous influence on his recovery. He hopes that his drive and passion for success may influence his son to succeed in every aspect of his life. Eric's attitude and determination have also played big part in his recovery. He did not and will not ever stop fighting to get better. His mother Joyce played a pivotal role in his life as well. She spoke for

him and fought for him when he couldn't. The community helped as well. The Downed Bikers Association in Tulsa held an event in his honor to help with expenses throughout treatment.

He wants people to know to never give up your passions or hope. He corrected me when I asked him if he "hoped" to ride with the Downed Bikers Association one day for an event. He stated "I will ride with them one day." Eric wants his story to influence

others going through hard times to not give up and never lose your positive attitude since that plays such a huge part with recovery. With his tenacity, I have no doubt that he will keep moving forward and succeed in anything he puts his mind to.



## **Cocaine Facts**

Cocaine is a stimulant drug that is highly addictive. It is created from the leaves of the coca plant located in South America and is one of the oldest drugs known. Cocaine comes in two chemical forms. The first is powdered and generally taken intravenously by using needles to inject into a vein or intranasally, which is by inhaling it through the nose. It is generally sold in a white powder known as snow, flake, coke and others slang terms and is often diluted with material such as cornstarch, talcum powder and/or sugar, and at times with other drugs such as anesthetics, and stimulants such as amphetamines. The second form is known as "freebase" which is smokable is known as crack in the drug community. It is referred to this, due to the crackling sound made when it is smoked. Crack is generally processed with ammonia or baking soda and water followed by heating it to remove the hydrochloride. Smoking it causes a quick high and combined with it is inexpensive to make and buy leads to its popularity.

Cocaine increases dopamine in the brain that is associated with motor control and the body's natural reward system, it does this by causing dopamine to build up in the nerve cells and stopping the normal process that occurs to cycle dopamine back within the body, this causes the brain to be flooded with dopamine. Some of the short-term effects include mood swings from extremely happy to extreme paranoia, higher mental alertness, hypersensitivity to sight, sound, and touch. If taken in large amounts it can lead to unpredictable and violent behavior or overdose. These effects appear quickly and disappear within a minute or can last if an hour. Long term use of the drug can lead to a variety of effects depending on how it is routinely taken.

Nasally causes a loss of smell, nosebleeds and sinus problems, as well as swallowing difficulties. Smoking results in respiratory illness and higher



risks of infections. Orally causes reduced blood flow in the abdomen and can cause your internal organs to die and decay. Injections lead to an increased risk of contracting HIV, Hepatitis C and other bloodborne diseases as well as skin infections and collapsed veins. Cocaine can also lead to other illnesses and injuries due to a lack of judgement while impaired by the drug, such as malnourishment due to lack of eating and even hallucinations.

Overdoses can and do happen when using cocaine in either form, this can be from taking too much on the first time using, taking higher dosages due to your body building up a tolerance to the drug, or due to one of the ingredients sellers dilute it with, or by mixing it with other drugs. This can lead to heart attack, seizure, and stroke. For those addicted to the drug and not using typical withdrawal include depression, increased appetite, nightmares and lack of ability to sleep, difficulty with completed mental tasks. Unfortunately, there is no medication to take to assist those attempting to get off the drug, but there is behavioral therapy, motivational incentives, therapeutic communities, and community-based recovery groups.

CHRISTMAS GIFT CARDS FOR YOUTH, ELDERS AND DISABLED - 2,333 individual cards totaling \$63,1741.95 have all gone out in the mail to tribal children, tribal elders and disabled tribal members.

ELDERS LUNCHEON – will be Saturday December 17th, 2022, from 12-3 p.m. Lunch, visiting and bingo will be enjoyed by all. The event will be held in the annex.

FOOD DISTRIBUTION – Thursday, Dec. 15th, 2022, the monthly food distribution will be combined with the Christmas food baskets to be provided starting at 10:00 am.

BROADBAND CONNECTIV-ITY GRANT has been funded for \$2,650,630. This will help to lay fiber around entire complex on Hwy. 10 and will also extend to Housing Authority and Woodland's

OHIO SUPREME COURT – Ruled six to one to make a public park making the mounds available to visitors every day all day long. There is one more trial to go and this will go to Jury Trial in Lincoln County. This trial is to determine what is a fair price to pay the Mound Builders Country Club. They currently have a lease to lease the land until 2078, so we need to pay them the money they would have paid plus any improvements made. We are hoping this will be done within the next six months.

TRANSPORTATION GRANT – We have heard back once, and they were asking for additional information which we provided. Chief Wallace states that in her experience that has always been a good sign. We have not heard anything since they contacted us back, but Chief Wallace has contacted Milo Booth, Federal Department of Transportation Tribal Liaison. He contacted the Federal Department of Transportation. He wrote back that they have not made final decisions, but they hope to make that that decision in December.

TRIBAL LEADERSHIP CONFER-ENCE WITH PRESIDENT BIDEN - President Biden and Vice President Harris has pledged their support for the Indian Child Welfare Act. This conference was important for us and had good results. Chief Wallace was able to meet personally with the Department of Justice to talk about the effects of Tar Creek and how it affects the Tribes. She was also able to meet personally with the Secretary of Transportation, Pete Buttigieg, and spoke with him about our Transportation Grant. She was also able to meet with the Department of the Interior, Deb Holland. SHAWNEE TRIBE REOUEST SHAWNEE INDIAN MANUAL LA-BOR BOARDING SCHOOL - The Boarding School is presently owned by the State of Kansas. The Shawnee Tribe wants to take possession and ownership of that school and are willing to pay \$15 million to rehabilitate and to make the school a museum. They have asked for a letter of support. Chief Wallace has responded to them stating our support for their effort to purchase the school and the letter has been sent to Chief Barnes. The Business Committee was in support of this

REQUEST FROM EMPIRE DISTRICT ELECTRIC COMPANHY/ LIBERTY RIGHT OF WAY WYAN-DOTTE 114 ACRES – The Business

Committee will be receiving this Resolution tonight. They need us to provide them a resolution and approve access to the 114 acres that several tribes own together to upgrade the IT support, Electrical support in the Wyandotte area.

PEOPLE'S BANK OF SENECA – Reports November was an excellent month. Net profit for the month of November was \$417,885.00 which brings year to date to \$5,022.945.00 – an increase of over one million from last year. Total assets are now \$381.7 million and past dues finished the month at 0.36% - one of our lowest months ever for past dues.

SHOW ME MAGAZINE – The city of Seneca will be featured in their January issue. They will be writing articles on our donations to the Fire Department and the Police Department.

#### **OLD BUSINESS**

We get funding every single year. It doesn't vary, it is their formula. He indicated that it would be a minimum of \$150,000 a year that we would be receiving in Roads Funds. They could lend it for 10 years and the tribe would take out a note and agree on a percentage that we would pay and that could be used for the funding of this road.

An update of information from Karen Allen indicates that as of now we have a balance of \$2,130,457.80 as our balance of Road Funds. As a total we have spent \$320,647.82 on 110 Rd. leaving a balance of \$1,810,809.98

in roads funds. If we chose to take out the income that would be coming from the Roads, it would be a total of \$3,310,809.98. The original bid was 4.4 million. The tribe could choose to put in 1 million from ARPA Funds or General Funds

2nd Chief Samples requested that we see if the bidding company will update their numbers, hold it for 30 days and see what we can do with our cash balances.

Resolutions - Treasurer Barrett gave an update on progress of Resolutions being uploaded on the web site without attachments beginning in 2023. the drying process was coming along and to reposition the fans. By that time I had determined that we would need to relocate our ECLC kiddos to the recently closed Travel Center and make the best of the situation for three weeks or so until the ECLC could be repaired, restored, made safe and welcoming again. Dropping me off at my house, Ron went on home. I decided to go to BlueJacket Building and work since no one would be there and I can get far more work done when no one is around. Imagine how shocked I was when I unlocked BlueJacket Building, opened the front door to discover at least five inches of water standing in every room with more pouring in. Immediately I opened all three doors to let the water begin to run out then grabbed my cell phone to call Ron and tell him to come to town immediately, which he did. Following him was grandson Chance and it was déjà vu all over again—grab a broom, sweep the water, call everyone for help, sweep the water, figure out where to turn off the water-Oh we are on the city of Seneca's water. We will need to contact them. Who has their number and they aren't going to be working today either. Just as before, Maintenance came immediately and performed miracles along with other employees, other volunteers. But I was the only one sweeping water because all the brooms and other disaster items had been taken to the ECLC and left there Saturday night. What a day, what an evening. Pizza was brought to us meaning we took a short break then we commenced working again. We finally stopped at 6 p.m., having been there 6 hours. Both buildings were destroyed, but not our spirits.

The next morning which was Tuesday morning all employees gathered at 8 a.m. and received our assignments. The entire ECLC staff would go to the aban-

doned but full of things Travel Center, completely empty out everything, clean the gutted building then begin to decide how the building would be arranged to accommodate our youngsters. From 8 to 11 we emptied out the building, washed everything down and began to move what could be moved from the former ECLC to the new ECLC. Employees were fantastic—no complaints, no bickering, no moaning, just an attitude of "We can do this" and they did. Some worked until about 8 that night. But the next morning we were ready to

reopen to accommodate the children of the employees and the following day we were open for everyone. Closed for one day! It was miraculous. Open to everyone the second day! Some parents had tears of gratitude in their eyes to have a place, a safe place, a loving place to leave their children to enable the parents to go to work and not lose more income from missed work because of no place to leave their children. Yes, Saturday, Monday and Tuesday were tough days but they brought out the spirit of teamwork, apprecia-



tion, and the desire to overcome in all of us. What a Christmas week we had! Today, both buildings have been gutted and restoration underway. We are hopeful within 10 more days the Early Childhood Learning Center will be finished, bright and shiny to begin anew. And BlueJacket Building, well we have said our kiddos come first and we have concentrated on the ECLC but we are ready to begin restoring every single room in BlueJacket Building. We have enlisted Judy Brown, a BlueJacket descendant, to oversee all interior decorating there along with Shelly Rogers, Administrative Assistant. It will be something all of will be proud of and I can't wait to see it. With all that being said, along with being so proud of our employees, I don't want to be Scrooge and say Bah Humbug, but I do hope we



have a more traditional Christmas next year.

Last month I promised that I would talk about 3 projects we are working on this year—a new governmental building, a splashpad and 110 Road. Actually there are more than 3 major projects but all of them take planning and have needs that must be addressed before we can complete any one of them. As you know for several years we have been relocating from our downtown flood plain location near Seneca, MO up to Highway 10C, a distance of about four miles. Before completing future plans, we must address issues of capacity. Do we have sufficient water capacity to add more facilities? Do we have a sufficient sewer system? What about our energy needs and our roads? And the list goes on.

To address these issues, we recently hired ECCL a firm from Arkansas that we had used before, to evaluate the Tribe's existing wastewater treatment system. More specifically, since the initial installation of the Tribe's current wastewater treatment system, the Tribe has continued to expand our housing and businesses. With this added growth, we may need additional capacity to meet our current demand. The Tribe has also emphasized that we wish to evaluate the potential future demands based on additional planned expansion over the next four years. The purpose of the requested evaluation was to determine the remaining operating capacity of the existing wastewater treatment system and make recommendations for future expansion. The wastewater treatment system has been in operation for 14 years with no upgrades or major maintenance issues. The results of that study are now in.

The Tribe has grown significantly in the last 14 years. Several additions were made within the community and the housing district since the construction and commissioning of the wastewater treatment system. We also know we have future plans of additional homes and community buildings in the near future. The goal of this evaluation is to review current needs based on flow data, determine what the capacity increase needs are, and provide final recommendations that are to include capacity evaluations for any planned expansions within the Tribe.

ECCI designed the Tribe's current wastewater treatment system in 2007, based on a needed wastewater flow of 20,000 gal/day. We chose a treatment plant with a capacity of 49,500 gal/ day to allow for future growth, choosing an AdvanTex - Orenco system with an original design that included 4 primary tanks, 1 dose tank, 2 recirculation tanks, 15 filter pods and a 2-acre drip field for our wastewater treatment system. The wastewater treatment system treats the wastewater biologically prior to discharging to the drip fields. We installed and began operating the current wastewater treatment system in 2008. Several years after the construction of the original wastewater treatment system, we added a 5th primary tank to the wastewater treatment system that increased the total volume capacity by 15,000 gallons. The additional tank was deemed the appropriate size to fit the needs at the time we started expanding and adding buildings to the community. A site visit was completed by ECCI at the 10C Tribal Complex on September 27, 2022, to gather data and inspect the wastewater treatment system. The purpose of the onsite meeting was to

gather updated information regarding the list of homes, community buildings, and businesses that are serviced by the wastewater system. The updated list of structures connected to the wastewater treatment system shows we have grown significantly since the wastewater treatment system began operation and continue to grow. The originally sized system included a few office buildings and 13-3 bedroom/2 bath homes. Since that time, the Tribe has added the following businesses and homes after the wastewater treatment system began operations in 2008:

- 1. Wellness Center that includes:
  - a. Swimming pool;
  - b. Hot tub; and
  - c. Therapy pool
- 2. Learning Center;
- 3. Child WellCare Center;
- 4. AOA Elder Care Center;
- 5. Police Station;
- 6. 15-3 bedroom/2 bath Homes; and
- 7. 18 2 bedroom/2 bath duplexes.
- HAVEN center for violence against women.

The original wastewater treatment system design was based on a demand of approximately 20,000 gallons, with an additional 30,000 gallons for future planned expansions and population growth. During ECCI's site visit, the Tribal EPA office personnel and ECCI determined the occupancy ratings for the businesses and homes. The occupancy ratings were determined by reading existing plans, occupancy plaques on the buildings, estimating the number of employees in each business, and estimating the number of students/occupants for the wellness center and AOA. The occupancy of the pool was assumed to be 10 gallons per person. The occupancy rating was utilized to determine the typical flow per day for each of the businesses and homes. Our current flow is about 56,385 gallons. The current flow is approximately 6,385 gallons over the original design capacity of the wastewater treatment system and our drip field has capacity



of 52,272 gallons per day but the current flow is approximately 4,113 gallons over the original design capacity of the drip field.

The Housing Authority has plans to build an additional 20 more 3 bedroom/2 bath homes while the Tribe's future plans include a large governmental building, a splash pad at the ECLC and a second therapy pool in the Wellness Center. Yes, we have grown and before growing more, we must address water, wastewater treatment and energy needs before we can proceed much further. Thanks to ECCI for supplying us with this information. We have our work cut out for us.

I want to remind everyone we have vacancies on our Housing Authority Board and on our Election Board. If you are interested in serving, please get in touch with me by calling (918) 238-5151 or text me at (918) 533--8422 or emailing me at gjwallace@estoo.net I must make those nominations soon.

We have just learned that our World Heritage nomination for 8 sacred mounds in Ohio will be heard this coming September at a meeting in Saudi Arabia. Yes, I plan to go at no expense to the tribe. And we are still waiting for a jury trial to be set in Licking County in Ohio to determine fair price to buy out the Moundbuilders Country Club's lease to eliminate the golf course there.

Margie walked on this week and we extend our condolences to Roy, their son Chad, daughter Cyndie and their children. Roy was formerly employed at the tribe, then became a B.C member and is currently serving on our Election Board. Son Chad teaches our Drivers Education Program in the summer which is free to our youth. Margie was Tribal Administrator for the Ottawa Tribe for 30 years with Roy also working there in the Indian Child Welfare Program. Please remember this family with your prayers.

he couldn't prove his identity. At some point he went to Vital Statistics, got a letter and today has a Social Security Card, ID, and guess what—today he draws Social Security. Don't tell him he can't.

Bud has had three marriages, fathering five children from his first marriage – Terri Landis, Bonita Payton, Patti Cochran, Mike Nelson, Lori Neuman—and one from his second marriage, Kelly Nelson along with four stepchildren, and one from is third marriage, Forest Nelson and two stepchildren adopting both of them. And grand-children—Oh My! 28 grandchildren, 41 great grandchildren, 3 great great grandchildren with one on the way.

Always active in the tribe, always telling us when we have fallen short and sometimes telling us when we have done well, Bud has been on the Business Committee, on the Housing Authority Board, on the Elder Crisis Committee. Below is an article showing his participation and wisdom back in 1965, a decision made 58 years ago that has enormous consequences, especially today.

"What is the value of \$3,000.00 to this tribe in 1965?

Most of us today are not aware that Grace Dixon stood strong to save this Tribe from extinction along with Buddy Nelson who said NO we will not sell the land for \$15,000 but what almost ended in a tragic sale of the tribes remaining 52 acres would or could have ended us as a Tribe. When the vote for selling the land for \$15,000 {to the city of Seneca} had no votes the City Manger at that meeting Mr Hall said "we raise the offer to \$18,000".

And the \$3,000 dollar raise made 9 members vote YES to sell this land.

of Seneca for \$15,000 please stand This question has zero votes in favor all of those NOT in favor of selling the land. The NO vote got 20 votes. (30 voters were present)

"Comment from the floor"

Grace Dixon: "We want to keep this land!"

Grace Dixon: "I am in receipt of an envelope from Washington DC that if we sell this land our tribe will be terminated by the US Government".

NOTE: She refused to tell who the letter was from"

Buddy Nelson: "We are not here to give these people anything"

Mr Hall "has just been informed the city of Seneca has raised its offer to \$18,000 (the Mayor was present at this meeting)

Mr Hall: "I know positively as human beings that you will never again be offered this much money for this land If you ever want to sell it you will have to sell it for less"

"Chief Captain informally asked how many members would be willing to sell this land for \$18,000, 9 members agreed to sell the land for this price. 16 members opposed selling this land for that price."

"Chief Captain thanked them and showed them the door and from that action we are who we are today"

Those 52 acres is the land where the BlueJacket Building is located today, the site of the old Bingo Hall, of Bordertown, the origins of gaming for the Eastern Shawnee Tribe. Thank goodness Grace Dixon and Bud Nelson were vocal and said, "No, this land is ours and you can't have it.



To help us to better serve you, please call in refill requests by utilizing the automated refill system. It's really simple and goes a long way towards making our Pharmacy have a more efficient workflow.


- <u>Dial 918-678-3244</u>. It can be found in the upper right hand portion of your prescription label. (It is circled in red in the example below.) Have your prescription bottle handy.
- 2. Follow the voice instructions given.
- 3. Press 1 to refill a prescription.
- Enter your prescription number. PLEASE USE THE MOST RECENT PRESCRIPTION BOTTLE as it will have the most recent prescription number!

The prescription number is located just above your name on the label. This number and your name are both highlighted in yellow. It is circled in blue in the example attached.



- 5. The system will ask you to confirm the first three letters of the last name on the prescription. **Press 1 if it is correct.**
- 6. If you need to enter another prescription, press 1, if not press 2.
- 7. That's it! Pretty simple.

Please keep in mind that refills called in during business hours will be ready the following business day after 1pm.

#### REFILLS BY MAIL

As of October 17, 2022, Medication Refills will be available by mail for *most* chronic medications. We are pleased to offer this service as a way for our patients to save time and money.

New prescriptions will not be mailed. These must be picked-up at the clinic.

#### How do I get started with Refills by Mail?

- Enrollment must be made in person at Bearskin Healthcare Pharmacy. A form will be available for each patient to register for refills by mail. Patients under the age of 18, must have a parent/guardian signature.
- To request refills, call the <u>Automated Refill Line</u>: 918-678-3244. This is the number on your prescription label. If you get a message that says your prescriptions are on "HOLD" or "there are no refills remaining" the Pharmacy will get these messages and process them accordingly. If you are told by the automated system that it is too early to refill your medications, call back 7 days prior to running out of meds.
- ALWAYS UPDATE your current address and telephone number with Registration AND
  the Pharmacy. If packages are returned due to incorrect addresses you will be disenrolled from the Refill by Mail program.
- You may call in to request refills up to 7 days early to allow time for processing and mailing. NOTIFY THE PHARMACY if you have not received your meds within 7 days, otherwise non-notification will be accepted as confirmation of medication delivery.
- Controlled medications (Tylenol with Codeine, clonazepam, tramadol, Lyrica, butalbital products, diphenoxylate/atropine, testosterone injection/gel, Provigil, and others) will not be eligible for refills by mail.
- CHECK your mail regularly on the days following your requests to help prevent loss and
  exposure to the elements. If you have several medications you may receive more than
  one package. If you repeatedly have medications which come up missing we may
  disenroll you from the RBM program.
- PLEASE CONSOLIDATE refill requests as much as possible to help keep postage costs down

The pharmacy reserves the right to dismiss any patient from the program as necessary. Reasons for dismissal include but are not limited to; returned deliveries, missed or denied receipt of medications, chronic early refill requests, failure to keep scheduled appointments, etc.
