29	vacancy on the Election Board the Chief shall present his/her
30	appointment to the Business Committee. The Chief shall present a
31	different person for appointment within thirty (30) days of failure of
32	confirmation notice to the Chief.
33	Article V - Section 2, page 9. Said ballots shall be printed no
34	later than forty-five (45) calendar days prior to the date for a given
35	election.
36	<u>Constitution</u> :
37	Article XIV - Section 2, page 13. The Business Committee shall
38	call a referendum within ninety (90) days of receipt of a valid petition
39	(or in this case, Resolution) and said referendum shall be conducted in
40	the manner prescribed by Article XI.
