Ms. Allen also presented an Estimated Major Repairs Report for the next five (5) years and suggested the Business Committee might consider setting aside \$250,000 from the General Fund to cover these expenses. Discussion was held and she said if this is to be done a decision should be made by September.

CASINO GENERAL MANAGER, RICK SMITH:
