

- WHEREAS, the Constitution of the Eastern Shawnee Tribe of Oklahoma, Article IX, Section 1, empowers the Business Committee to protect and preserve the interests of the Tribe; and
- WHEREAS, the Constitution of the Eastern Shawnee Tribe of Oklahoma, Article IX, Section 1, empowers the Business Committee to appoint such subordinate committees and agents as the business of the Tribe may require and to allow suitable compensation.

- WHEREAS, the Oklahoma Court of Criminal Appeals (OCCA) is hearing *State of Oklahoma* v. *Harry William Hull, Jr.*, S-2021-110, a case involving the Eastern Shawnee Reservation in which the Tribe has submitted a brief as amicus curiae regarding the continued existence of the Eastern Shawnee Reservation; and
- WHEREAS, the OCCA has directed the parties and has invited the Tribe to provide supplemental briefing on questions that implicate the Tribe's authority to prosecute criminal defendants on its Reservation; and
- WHEREAS, the Business Committee of the Eastern Shawnee Tribe of Oklahoma has determined that the Tribe should submit a supplemental brief responsive to the OCCA's questions so as to represent and protect the Tribe's sovereign interests in its Reservation and its criminal jurisdiction over Indian defendants within the

- Tribe's Indian country, continue to participate in the case as necessary to protect the Tribe's sovereign interests, and pursue further litigation in the event of an adverse decision from the OCCA; and
- WHEREAS, the Tribe's special legal counsel has estimated the costs of continued participation in this case as shown on the budget attached hereto as <u>Exhibit 1</u>; and
- WHEREAS, funding is available from the Bureau of Indian Affairs to cover the cost of legal fees to prepare, file, and argue before the OCCA in defense of the Tribe's Reservation and its jurisdiction over Indian defendants on the Reservation; all communications and strategic efforts relative to this case, and fees incident to any petition for certiorari to the United States Supreme Court relative to this case; and
- **WHEREAS**, the Tribe is otherwise unable to cover the cost of attorney's fees for continued work on this case; and
- WHEREAS, the Bureau of Indian Affairs has approved the Tribe's request to submit an application for attorney's fees to prepare, file, and argue before the OCCA in defense of the Tribe's Reservation and its jurisdiction over Indian defendants on the Reservation; all communications and strategic efforts relative to this case, and fees incident to any petition for certiorari to the United States Supreme Court relative to this case.
