Robert Miller Speaks on McGirt and the Impact Upon the Nine Tribes of Ottawa County



"On the far end of the trail of tears was a promise," one of the often quoted attorneys regarding the McGirt decision is Robert Miller, an Eastern Shawnee Tribal Citizen. Robert has served as Judicial Law Clerk for a Federal Judge, Instructor, and Professor, Attorney at Law and currently serves as Tribal Judge for three different tribes and the Northwest Inter-tribal Court System as Appellate Judge.

Robert spoke at two location on Thursday, April 20th at the Inter-Tribal Council, Miami, Oklahoma and the Eastern Shawnee Tribe later in the day.

A Professor at the Sandra Day O'Connor College of Law, Arizona State University since 2013; Robert has authored several books and numerous articles. He co-authored "A Promise Kept: The Muscogee (Creek) Nation and McGirt v. The Chief's Report ...

Hatito Fellow Tribal Citizens,

It doesn't seem possible that April is almost over and the month of May will be with us complete with Mother's Day, school graduations and Memorial Day. Previously known as Decoration Day, this holiday is one of my favorites. My grandmother on my mother's side died when my mother was only seven years of age. My grandfather on my dad's side died when my father was only six months old. Thus both my mom and dad grew up going to cemeteries, always observing Decoration Day doing just that-decorating family graves, meeting with relatives, reminiscing, and of course eating together. Grandmother Crain was buried in Tulsa, Oklahoma and at first my mom's family lived near there. Later after moving to her allotment, it was a trip of almost 100 miles. I recall how Mom said they had no money to buy flowers, so as they drove to Tulsa they would spot wild flowers growing alongside the roads and they would stop, pick the flowers and weave them into garlands to place on Grandmother's grave. They picked enough to cover the entire grave with those flowers. Not a blade of grass could be seen because of the mass of flowers. For 84 years she went every single year to Tulsa to decorate that grave with the last few years decorating both graves

as Grandad had joined Grandmother there in the cemetery. The same was true with Dad's side of the family. Beside his father's grave at Baxter Springs, Kansas, were the graves of two of Dad's older siblings who died in infancy. As the years passed, others joined them at the cemetery. Thus thinking of family, decorating graves has been ingrained in my siblings and me. Family members now rest in seven different cemeteries and it takes me at least two days to get to all of them, but it's two days of recalling special memories. As I said, Decoration Day is one of my favorite holidays and I look forward to it. I just need to make sure I have enough beautiful flowers for beautiful people.

April has been a busy month for us here at the tribe. We had a beautiful warm, sunny day for our Easter Egg hunt, resulting in more children than we have ever had before. And we loved it! The Wild Green Onion and Eggs festivities did not have the biggest of crowds, but the food was fabulous, prizes were plentiful and laughter filled the room. This week we say a fond farewell to Monica Bettis, Director of Health and Social Services. Monica has been with us for $33\frac{1}{2}$ years. We will miss her but both she and her husband have had health issues in the past, are doing better, and she wants to retire and enjoy their lives together. She has definitely earned this and while we will miss her, we certainly understand, support her decision and wish her well. Jana Edwards Johnson, Shawnee Tribe, will be the new Director and will report to work later in May. Until then, James Sullivan, tribal citizen and new Tribal Administrator, will be spending quite a bit of time in Social Services until Jana is full time.

Speaking of James, we have filled the Tribal Administrator position with two of our current employees, James Sullivan and Kristi Laughlin. They will share responsibilities with James focus-

Annual Wellness Visits - Medicare Part B Submitted by Ashley Crawford, RMA, CPhT Clinic Liaison

The Annual Wellness Visit (AWV) is a yearly appointment with your primary care team to create or update a personalized prevention plan. This plan may help prevent illness based on your current health and risk factors. Keep in mind that the AWV is not a head-to-toe physical. Also, this service is similar to but separate from the one-time Welcome to Medicare preventive visit.

ELIGIBILITY Medicare Part B covers the Annual Wellness Visit if:

- You have had Part B for over 12 months
- And, you have not received an AWV in the past 12 months
- Additionally, you cannot receive your AWV within the same year as your Welcome to Medicare preventive visit.
- Covered services
- During your first Annual Wellness Visit, your care team will develop your personalized prevention plan. Your care team may also:
- Check your height, weight, blood pressure, and other routine measurements
- Give you a health risk assessment
 - This may include a questionnaire that you complete before or during the visit. The questionnaire asks about your health status, injury risks, behavioral risks, and urgent health needs.
- Review your functional ability and level of safety

• This includes screening for hearing impairments and your risk of falling.

- Your care team must also assess your ability to perform activities of daily living (such as bathing and dressing), and your level of safety at home.
- Learn about your medical and family history
- Make a list of your current providers, durable medical equipment (DME) suppliers, and medications
 - · Medications include pre-



scription medications, as well as vitamins and supplements you may take

• Create a written 5-10 year screening schedule or check-list

• Your care team should keep in mind your health status, screening history, and eligibility for age-appropriate, Medicare-covered preventive services

Screen for cognitive impairment, including diseases such as Alzheimer's and other forms of dementia

> • Medicare does not require that care teams use a test to screen you. Instead, care teams are asked to rely on their observations and/or on reports by you and others.

- Screen for depression
- Provide health advice and referrals to health education and/or preventive counseling services aimed at reducing identified risk factors and promoting wellness

• Health education and preventive counseling may relate to weight loss, physical activity, smoking cessation, fall prevention, nutrition, and more.

- AWVs after your first visit may be different. At subsequent AWVs, your care team should:
- Check your weight and blood pressure
- Update the health risk assessment you completed
- Update your medical and family history

- Update your list of current medical providers and suppliers
- Update your written screening schedule
- Screen for cognitive issues
- Provide health advice and referrals to health education and/or preventive counseling services

COSTS

If you qualify, Original Medicare covers the Annual Wellness Visit at 100% of the Medicare-approved amount when you receive the service from a participating provider. This means you pay nothing (no deductible or coinsurance). Medicare Advantage Plans are required to cover AWVs without applying deductibles, copayments, or coinsurance when you see an in-network provider and meet Medicare's eligibility requirements for the service.

During the course of your AWV, your care team may discover and need to investigate or treat a new or existing problem. This additional care is considered diagnostic, meaning your care team is treating you because of certain symptoms or risk factors. Medicare may bill you for any diagnostic care you receive during a preventive visit. To schedule a Medicare Wellness Exam Contact:

Are you looking for a summer job that isn't "just" a job?

Do you want to work with professionals in their field?

Do you want to learn more about Eastern Shawnee History and Culture?

If you answered yes to these four questions, then we have the opportunity for YOU!

Our ESTO Summer Youth 2023 program has 2 major goals for interested participants. First it is the opportunity to help you grow culturally as a young tribal citizen by participating in a variety of ESTO cultural events and activities such as culture camp, language classes, hoop house project and various meaningful activities to name a few. Our second goal is working with Directors to find the best employment fit for your career goals. You are the future of your Tribe, and as such it is our wish to provide you with the tools of success and leadership to help you grow.

Below are the guidelines for participation:

- Summer employment opportunities are open to enrolled ESTO tribal citizens from 16-22 years.
- You must fill out a Summer Youth Program Application. These can be found on the ESTO website, as well as at the Tribal Administration/HR office.
- Applications must be filled out in their entirety, and submitted by May 19, 2023, at 4 p.m.
- Tribal membership will be verified with Vital Statistics, and a copy of a school schedule or proof of enrollment for the fall semester must be turned in with the application.
- You must be enrolled as full-time students for the next school year.
- The program will run from the first day after summer break begins until first day classes resume Earlier availability will be considered on a case-by-case-basis.

- We will accommodate summer camps, sports, vacations, etc. as much as we can.
- Our goal is to make department assignments based on personal interests (as much as possible) taking age restrictions and other limitations in to account as applicable.
- Youth must be available for cultural events.
- Assist in the greenhouse(s) as needed.
- Pay will be \$13.00/hr. and the schedule will be up to 40 hours a week.
- Interviews will be held after the closing date.
- Individual selections will be made based on the interview process and available positions.

EMERGENCY RENTAL ASSISTANCE PROGRAM

Emergency Rental Assistance Program By Amber Mittag, Education and Specialized Services

The purpose of the Eastern Shawnee Tribe of Oklahoma Emergency Rental Assistance Program is to provide direct financial assistance, including rent, rental arrears, utilities and home energy costs, utilities and home energy costs arrears, and other expenses related to housing. This program will make available a limited amount of assistance to households that are unable to pay rent and utilities due to the COVID-19 pandemic. This program will serve eligible households and is subject to available program funding. **Eligibility:**

- Qualifies for unemployment or has experienced a reduction in household income, incurred significant costs, or experienced a financial hardship due, directly or indirectly, to the Covid-19 outbreak.
- 2. Demonstrates a risk of experienc-

ing homelessness (rent) or housing instability (utilities and other expenses); and

 Has a household income at or below 80 percent of your area median (FY 2020).

Assistance Provided:

- 1. Rent
- 2. Rental arrears
- 3. Utilities (electric, gas, water and sewer, fuel oil)
- 4. Utility arrears
- 5. Internet

Eligible households may apply and receive up to three months of assistance at a time, provided funds are available. A maximum of 12 months assistance or \$3,000, whichever should come first.

Brian has been working in collaboration with the Indian Child Welfare Department to submit the Tribal Maternal, Infant, and Early Childhood Home Visiting Program: Development and Implementation Grants Proposal. If funded, the program would provide in-home early childhood education for the families of the nine tribes located in Ottawa County and provide linkage for the families to available resources in the community. The proposal outlines community needs assessment activities in the first year of the program including tribal leadership meetings, provider focus groups, parent survey and parent focus groups. If awarded the grant would provide \$350,000 for the first year and up to \$1,000,000 a year for three additional years based on the outcome of the community needs assessment.

The Grants Department is also searching for funding opportunities to address food security, infrastructure, elder, recreation, education, economic development and other tribal needs.



DUSHANE PLACE TO BLUEJACKET COMPLEX TO HIGHWAY 10C COMPLEX

BlueJacket Complex is a name, a location that the Eastern Shawnee Tribe references daily. Located today at 12755 South 705 Road, Wyandotte, OK with the same mailing address, it was formerly 127 W. Oneida Street with a mailing address of P. O. Box 350, Seneca, MO. The mailing address change came about when Ottawa County provided 911 addresses to the Tribe in June of 2010, almost thirteen years ago. That means for almost fifty years, the Eastern Shawnee Tribe located in Oklahoma had a Missouri mailing address. You would be amazed at how much mail we receive today still addressed to Eastern Shawnee Tribe, P.O. Box 350, Seneca, MO.

And how did an Oklahoma Tribe receive a Missouri address? Part of it might be because we are located at the Oklahoma/Missouri line and the nearest town is Seneca, MO which is at our doorstep and the next nearest town is some 7 or 8 miles away. Perhaps another reason is that an evaporated milk company named Milnot came to the area in the late 1940's. Milnot was a filled milk product and could be sold only in states where it was produced. Thus when the manufacturing plant was constructed, part of the building was positioned in Missouri extending over into Oklahoma with a gold line separating the one building into two separate and distinct operations. The little town of Seneca, Missouri spawned a sister city known as West Seneca, Oklahoma with one post office serving both entities.

The land where BlueJacket Complex is located has a unique history also. Originally part of the 60,000 acres promised to the Mixed Band of Senecas and Shawnees when a treaty was signed in 1831 and they were forcibly removed in 1832, sixty-seven and fif-

teen-hundredths acres were allotted to Nina Dushane July 1, 1904. Born in 1897 and the daughter of Charles Dushane Sr., Nina was only seven years of age when she received information dated July 1, 1904, about her allotment. For years those 67+acres as well as the surrounding land were known as the Dushane Place as Dave Dushane's allotment (Nina's uncle) was in the same vicinity of Nina Dushane's. Years later Nina married a Kiowa native and they lived at Colony, Oklahoma with their children. In 1937 she wrote a letter to the government asking if she could trade her allotment in Ottawa County for land where she and her husband lived. The government agreed, stating that at the present moment a group of Shawnees known as Eastern Shaw-

nees were working toward developing a constitution and when that was finalized and elections held, the government would transfer Nina's land to the Eastern Shawnee Tribe. That occurred in 1939 but the land was still referred to as the Dushane Place.

Nina's letter stated her allotment was 67 and fifteen hundredths acres. In an interview with Chief Tom Captain in 1969, he described the land as being fifty-seven acres of creek-bottom land which made the tribe \$250 a year. Today the description reads as 58.19 acres. What happened to the 10 or so acres from 1939 to today, I am not sure. The city of Seneca does own some land immediately west of BlueJacket Complex where the ballfields are. There has to be a story there, but at this moment, I am not familiar with the details. Chief Tom Captain also stated that in the mid-1950's the government wanted to build the tribe a council house, but he turned it down. The land continued to be known as the Dushane Place.

The first tribal buildings on the Blue-Jacket Complex began construction in 1977 under the leadership of Chief James Greenfeather. An Administration building was started in 1977 with Greenfeather as Chief but not completed and occupied until 1979 under the leadership of George (Buck) Captain. That building is now named the Chief James Greenfeather Building in honor of Chief Greenfeather. The land and location now began to be referred to as the Eastern Shawnee Tribe. Also in 1977 the Eastern Shawnee Tribe secured its first grant, obtained through the Department of Commerce at no cost to the tribe and a contractor was hired to construct an industrial building. The industrial building was never completed as funds ran out and the contractor disappeared. That red metal building stood unfinished until 1984 when David Allen, a Bingo operator from Pryor, Oklahoma, approached the tribe about converting the incomplete industrial building into a Bingo operation. A partnership was formed. December 7, 1984, was the opening date for Eastern Shawnee gaming and the rest is history. Also in 1984 a nutrition building was built to feed our elders, later remodeled in 1994.

Growth continued, land was purchased and in the year 1992 a new administration building was built next to the old administration building under the leadership of Chief Buck Captain and his son Second Chief Neil Captain. It was Neil who gave the building the name of BlueJacket Center, "dedicated to BlueJacket, a Shawnee War Chief and Walter, Julian and Clyde BlueJacket, former Tribal Chiefs." We now had a building named BlueJacket Center with the land across Lost Creek still referred to as The Dushane Place.

The date is famous—9-11-2001when the World Trade Center was bombed. It was also the same week the Eastern Shawnee Tribe was scheduled to hold its grand opening of a semiadministrative building on Highway 10C housing Human Resources (HR), the Environmental Department (EPA), Accounting, Benefits, and Tribal Administrator. Under the leadership of Chief Charles Enyart, the dedication was not postponed but held as scheduled and the names 10C Complex and BlueJacket Complex were born, distinguishing the two locations. That semiadministrative building now bears the name Chief Charles Enyart Building. The move from downtown BlueJacket Complex to Highway 10C Complex was necessitated by the downtown area being designated a flood plain making grant funds no longer eligible to build in this location.

Today, 2023 we are now designing two new buildings at Highway 10C Complex, one a remodel of the former Travel Center and a new Administrative Building. Highway 10C Complex will soon consist of one casino, six program facilities (semi-administration, Health and Social Services also housing CCDF and ICW, AOA, Early Childhood Learning Center-built in 2 stages-- Wellness Center-built in 3 stages-- Law Enforcement, plus the two new buildings now in planning stages. Nearby we have Growing Thyme building with 4 hoophouses, our HA-VEN headquarters, 9 elders duplexes, and 27 homes in the Housing Authority with more hoped for. Add to those facilities our own water system, sewer system, and of course roads

And it all began with a gift of allotted land from Nina Dushane.

Seasonal Allergies (Hay Fever)_

What Are Seasonal Allergies?

Seasonal allergies are sometimes called "hay fever" or seasonal allergic rhinitis. These allergy symptoms happen during certain times of the year, usually when trees, grasses, and weeds release tiny pollen particles into the air to fertilize other plants.

The immune systems of people who are allergic to pollen treat these particles (called allergens) as invaders and release chemicals, including histamine, into the bloodstream to defend against them. It's the release of these chemicals that causes allergy symptoms.

People can be allergic to one or more types of pollen. The type someone is allergic to determines when symptoms happen. For example, in the mid-Atlantic states, tree pollen is highest from February through June, grass pollen is highest from May through August, and weed pollen is highest from July through October — so kids with these allergies are likely to have increased symptoms at those times.

Even kids who have never had seasonal allergies in years past can develop them. Seasonal allergies can start at almost any age, though they usually do not develop before a child is 2 years old. Most people with seasonal allergies develop them by age 20.



What Are the Signs & Symptoms of Seasonal Allergies?

If your child develops "cold" symptoms at the same time every year, seasonal allergies might be to blame. Allergy symptoms, which usually come on suddenly and last for as long as a person is exposed to the allergen, can include:

- sneezing
- itchy nose and/or throat
- nasal congestion
- clear, runny nose
- postnasal drip

These symptoms often come with

itchy, watery, and/or red eyes, which is called allergic conjunctivitis. Kids who have coughing, wheezing and/or shortness of breath in addition to these symptoms might have allergies that trigger asthma.

How Are Seasonal Allergies Diagnosed?

Talk with your doctor if you think your child might have seasonal allergies. The doctor will ask if the same symptoms happen at the same time each year after your child is around an allergen, and do an exam. The doctor may be able to make a diagnosis, or might refer you to an allergy doctor (allergist) for allergy skin testing (called skin prick testing) or a blood test.

To find which allergens cause a person's symptoms, allergists usually do skin testing. During skin prick testing, an allergist or nurse puts a tiny bit of a liquid containing an allergen into the skin by making a small scratch or prick on the skin. They usually do skin testing on a person's forearm or back. The allergist then waits 15 minutes or so to see if a red, raised bump, called a wheal, forms. If it does, there might be an allergy. The allergist uses a ruler to measure the wheal and the redness around it.

Even if a skin test or a blood test shows an allergy, a child must also have symptoms to be diagnosed with an allergy for sure. For example, a child who has a positive test for grass pollen and sneezes a lot while playing in the grass would be considered allergic to grass pollen.

How Are Seasonal Allergies Treated?

There are many ways to treat seasonal allergies, depending on how bothersome the symptoms are. An important part of treatment is knowing what someone is allergic to. Some kids can get relief by reducing or eliminating exposure to the allergens that bother them.

If certain seasons cause symptoms, keep the windows closed, use air conditioning instead of fresh air when possible, and stay indoors when pollen counts are high. It's also a good idea for kids with seasonal allergies to wash their hands or shower and change clothes after playing outside.

If reducing exposure isn't possible or doesn't help, doctors may recommend medicines for allergy symptoms. These can include oral, nasal, and ocular (eye) antihistamines and nasal steroid sprays. If these don't help or a child has to take multiple medicines to ease symptoms, the doctor may recommend seeing an allergist. The allergist can decide whether allergy shots (immunotherapy) could help.



Benzodiazepinese Submitted by Ben Bingham, Native Connections Project Director

Benzodiazepines (pronounced 'benzoh-die-AZ-a-peens'), is a depressant or sedative drug used to treat ailments such as insomnia or anxiety, as well as alcohol withdrawal and epilepsy. It is sometimes referred to as "Benzos" and work by calming or sedating an individual, specifically by inhibiting or blocking the neurotransmitter GABA in the brain. The most common "benzo's" include Diazepam (Valium), Alprazolam (Xanax), Clonazepam (Klonopin), and others. "Benzo's are not generally the first line of medication due to the short time required for addiction and withdrawal symptoms.

Overdoses occur when Benzodiazepine are mixed with alcohol or other drugs, such as stimulants like amphet-

amines or cocaine and are associated with being a sedated state or suppressed breathing and impairment of cognitive functions. In Oklahoma 12 residents of the state die every week from an unintentional overdose which involved 17% of them being related to Benzodiazepines. In Ottawa county they were involved in 11% of all nonfatal overdoses. Those using benzodiazepines exhibit some of the following signs. Euphoria, depression, confusion, impaired thinking, slurred speech, double/ blurred vision, impaired coordination, drowsiness, sleepiness, and fatigue. Those injecting benzodiazepine risk infection, including hepatitis, HIV, and AIDS. Long term effects from using "benzo's" include personality change, weakness, drowsiness, nausea, headaches, anxiety and depression and is a risk factor for epilepsy, stroke and brain tumors. Program Update:

Hello all -

Spring is here – the weather is getting warmer, and the days are getting longer. May is a busy time for many of us, our kids are getting out of school, and we start planning summer break. However, May is also Missing and Murdered Indigenous Women and Girls Month.

Social media does a great job at putting acronyms and images out but does not give us the full picture of what they mean. One of those is MMIW and MMIWG. We see images of Native women with the phrase MMIW on Facebook and we wonder...what does that mean? Does that happen here in Oklahoma? Is that just something that happens in rural Canada? The answer is YES ... missing and murdered indigenous women and girls happens in Canada, it happens on rural reservations in Wyoming, North Dakota, in every state, and in Ottawa County Oklahoma. To get a better picture of the issue here in Oklahoma, I'd like us to listen to the voice of a family dealing with the loss of someone they love here in Oklahoma. This is a section of an article published in the Oklahoman on July 17, 2019. Please read the article below, listen to this family's story, and let's learn what MMIW really means.

Missing in Oklahoma: State could take steps to curb 'epidemic' of missing Native American women

Rebecca Ponkilla still remembers the last moment she saw her daughter. She hugged Ida Beard inside their El Reno home as her daughter's friends waited for her outside. Beard, 29, walked to a friend's house just blocks away, but never returned home. A member of the Cheyenne and Arapaho Tribes, Beard is one of many Native American women and girls across the country who have vanished without a trace.

Oklahoma has one of the highest rates of missing or murdered Native American women, according to a report from the Urban Indian Health Institute.

But the report doesn't show a complete picture of the problem because of a widespread lack of comprehensive data. As indigenous people have become increasingly more vocal about the alarming trend that has silently plagued the Native American community for decades, one Oklahoma lawmaker wants to see what the state can do to help. When Beard didn't make it home later on June 30, 2015, Ponkilla assumed her daughter was having fun with her friends. But then she began to worry. "I had no idea, no idea where she was," she said. "I still really can't believe she's gone, you know?" Over the years, the El Reno police never received any substantial leads on Beard's disappearance, said LaRenda Morgan, Beard's cousin. Beard's family hasn't given up. They recently hired a private investigator to look at the case, Morgan said. But the uncertainty surrounding Beard's disappearance and the lack of closure haunts her family, especially her younger sister, Zina Deere. The two were nearly inseparable, and Beard always looked after Deere.

Deere, 27, regrets she wasn't with her sister that night. "We would've helped each other," she said. "But whatever happened to her, she was by herself." At the time of her disappearance, Beard's children were ages 5, 6, 8 and 14. Her oldest daughter now has a child of her own who may never get to meet her grandmother. "We won't stop looking and waiting for her to come through the door until we know what really happened to her," Ponkilla said through tears. Beard's family is not alone.

An epidemic of violence

Linda "Lindy" Zotigh, also a member of the Cheyenne and Arapaho Tribes, was brutally killed in 2017 in Hammon. A federal grand jury indicted Zotigh's boyfriend, Tommy Dean Bullcoming, last year on first-degree premeditated murder, first-degree felony murder and other charges related to her death. Bullcoming is accused of stabbing Zotigh, 55, which led to her death, "in an especially heinous, cruel and depraved manner in that the offense involved torture and serious physical abuse," according to court documents. The case is still ongoing. Bullcoming killed Zotigh because she tried to leave him, said Imogene Herndon, Zotigh's friend.

"He actually treated her pretty good," Herndon said. "Since he seemed like such a kind, quiet man and was nice looking, you would never dream there was this demon in him. Authorities from the Roger Mills County sheriff's office and the Oklahoma Highway Patrol found Zotigh's body on Sept. 7, 2017, on tribal land about seven miles from where her mobile home had been set on fire — the catalyst for the search. Law enforcement detained Bullcoming the following day on an unrelated drug charge. Herndon, 60, describing an incident where she previously was stalked by a man, said she hates how Native American women always seem to get blamed for the violence they face."They keep putting it on the women," she said. "It's these men they need to do something with."

Native American and Alaska Native women face higher rates of violence than the general populace with more than four out of five indigenous women experiencing some type of violence in their lifetime... according to a study from the National Institute of Justice. That violence can include stalking, sexual violence or physical or psychological aggression by an intimate partner. Overall, more than 1.5 million American Indian and Alaska Native women have experienced violence in their lifetime, which contributes to the epidemic of missing and murdered indigenous women and girls, according to the study. "There are domestic violence relationships that continue to escalate and a lot of times the most dangerous times of the relationship are when the individual attempts to report to the police, to leave, to get a divorce. ... Statistics show that that's when those events occur," she said.

According to the urban institute report, 5,712 cases of missing American Indian and Alaska Native women and girls were reported to the National Crime Information Center in 2016 alone.

When violence boils over, limited law enforcement and jurisdictional issues can complicate matters. Depending on where a crime is committed, different law enforcement agencies could take the lead on the case, said Carr, who also works for the StrongHearts Native Helpline. And the lack of a centralized missing and murdered indigenous persons database that can be used across all law enforcement entities doesn't help matters, she said. "There's a lot of miscommunication between the databases and then a misunderstanding of who is responsible for an individual who went missing in location X," Carr said. "There's a lot of jurisdictional confusion."

Native American tribes also lack the authority to prosecute most of the crimes that occur on their land because federal law places most major crimes under federal jurisdiction, she said. That's part of the problem, Carr said.

Federal authorities have exclusive jurisdiction over sexual assault or sexual violence cases, but oftentimes, resources are so limited they can only pursue the most egregious of cases, she said. That leads to a vicious cycle where many perpetrators continue to do what they're doing because they know they can get away with it, Carr said.

Sovereignty and jurisdiction barriers

Part of the problem stems from a confusion about which government entity — local, state, federal or tribal — should investigate the disappearance or murder of tribal members. Oklahoma officials have taken longer to dive into this issue because the state has a more complicated landscape than some other states, Word said. The sheer number of tribes in Oklahoma — the state has nearly 40 federally recognized tribes — and the fact that they're spread across the state makes it harder for the tribes to communicate and coordinate with one another.

Invisible to the media

Along with insufficient data on missing and murdered indigenous women, there also is a lack of media coverage. Of the 506 cases the urban institute studied, only 129 received media coverage. About 7% of the cases made up more than half the coverage.

Part of the reason there are so many missing indigenous women is that it's "an unknown issue," Webster said.

When Beard went missing, Morgan said she and several of her relatives reached out to media outlets to ask them to cover it. None did, she said. More women could be found sooner if the media reported each time a Native American woman went missing, she said. "If (people) knew someone was missing from that location, they could call in and give information," Morgan said. "Nobody knows until afterward when bodies are found."

And every time the family hears of a body found, they're on "pins and needles" waiting to see whether it's Beard, Morgan said. Beard's family has lost and found their strength over the years. "We really fell into depression over the years where we would sleep all day, (we) wouldn't get up to eat sometimes," Deere said. But now, Deere said she knows Beard wouldn't want that for her family. There are two things that keep her going.

"Hope and faith," she said. "Because hope gives me some kind of joy, knowing that maybe she'll come back. My faith is knowing what happened, happened. And I believe I'll see her again." RA Nance Visits Tar Creek

This week, RA Nance and team visited the Tar Creek Superfund site area, meeting with the Tar Creek Trustee Council Indian Tribes comprised of the Ottawa Tribe, Miami Tribe, Wyandotte Nation, Seneca-Cayuga Nation, Eastern Shawnee Tribe, and Peoria Tribe. The Modoc Nation and the Shawnee Tribe were also visited, as was the grassroots organization Local Environmental Action Demanded Agency. On April 11, site visits included a water monitoring site on Tar Creek, a chat pile, a riparian/streambank area prioritized by the Eastern Shawnee Tribe for restoration, a recycling facility, an aquatic facility for producing fish and mussels, and places where flooding has increased in recent years.

On April 12, the RA and team met with Tar Creek Trustee Council Indian Tribes leadership and staff to review the site visits and follow-up actions. The Chiefs from the Eastern

Shawnee Tribe, Miami Tribe, Seneca-Cayuga Nation and the Wyandotte Nation were in attendance, which is one of the highest attended in-person meetings between EPA and elected tribal leadership in several years. Tribal and local partners were appreciative of the Region 6 visit and the work the Superfund Division has conducted at the Tar Creek site for many years.

tance – if you have depleted your Social Services funds. 4)Medical Assistance – if you have used all your medical assistance. 5) Internet Program helps with those enrolled up through High School and now through college if you are enrolled in online classes. Submit receipts. BANK REPORT – Chief Wallace read report provided by Deron Burr, President/CEO of People's Bank of Seneca.

MONICA BETTIS RETIREMENT – Monica will be retiring at the end of April.

CURRENT MCGIRT STATUS OTTA-WA COUNTY – Chief Wallace is on the committee that has met numerous times. She reports the Attorney General has reversed his opinion and has sent a letter to Doug Pewitt, District Attorney for Otta-

wa and Delaware Counties. Previously he had stated that he would accept that all the tribes had sovereignty, that our reservations had never been disestablished. He has now changed his mind and written a letter to all of the tribes to Doug Pewitt saying that every case that comes before him that has anything to do with being on Indian land or so forth is to be considered as non-native, non-reservation land. So, there are five tribes that have formed a consortium and they wanted to write a letter and in fact file lawsuit against this immediately. The Miami tribe has chosen to go ahead and act by themselves. Chief Wallace read the letter that the Miami tribe has written.

The Modoc's do not have a police force and we discussed that our Police Force could patrol this since we go by there anyway.

ing primarily on working directly with Department Directors and HR issues

Department Directors and HR issues internally and externally with Kristi retaining her duties as EPA Director, adding additional grant duties along with working with Tribal wide benefits. Congratulations to both and welcome aboard.

Congratulations are also extended to People's Bank of Seneca upon their grand opening of the tribe's fifth bank, located in Neosho, Missouri. Grand opening is scheduled Wednesday, April 26th 4 p.m. to 5:30 p.m. CEO and Bank President is Deron Burr and Nancy Maxwell, Jay Ross and Audrey Dixon are our representatives on the Board of Directors.

We continue with the restoration of BlueJacket Building. It has been four long months since the Christmas flooding debacle of our Early Childhood Learning Center and BlueJacket Building. Maintenance is about to finish the kitchen. Beautiful cabinets have been purchased and installed plus this week we gained a kitchen sink and water. That's right-we now have water in the kitchen. We have laughed because we have sporadically had water in our one holer bathroom. Ultimately we will have three stools but we have had only one stool and still have just one. We have suffered several water line issues, leaving us without water. When that happens we have large buckets of water and when we need to use the bathroom, we remove the lid on the stool, pour in water, then flush. It's like going back in time 70 or more years ago, but we are about to start getting the bathrooms restored. We won't know how to act because we are sure they will be beautiful, along with the rest of the building. When our maintenance crew finishes with BlueJacket Building, they will turn their attention to another need we have and another building-childcare available for casino employees who don't have nine to five jobs Monday through Friday. Everyone knows casinos are busiest in the evenings and on weekends. While we have an Early Childhood Learning Center, its hours are 6 a.m. to 6 p.m. Monday through Fridays. Those aren't the hours needed by casino employees. Plans are just now developing to turn the Elbert house across the street from Indigo Sky into a daycare center open the hours needed for children of casino employees. Currently plans call for Tribal Administration to pay for updating the house and Gaming to then rent the facility. It will be their decision regarding the hours, fees, etc. It's a win-win for everyone as Tribal Administration is having problems with homeless people squatting in the unoccupied house and Gaming is having problems finding childcare solutions for their employees. Working together we can solve both issues. Stay tuned for further developments on this project.

Recently we had another win-win at the tribe and that was having tribal citizen Robert Miller come and give two presentations regarding the McGirt legal ruling affecting all tribes in Oklahoma. "At the end of the Trail of Tears there was a promise," U.S. Supreme Court Justice Neil Gorsuch wrote in the decision issued on July 9, 2020, in the case of McGirt v. Oklahoma. And that promise would finally be kept. A Promise Kept, a book co-authored by Miller, explores the circumstances and implications of McGirt v. Oklahoma, likely the most significant Indian law case in well over 100 years. Combining legal analysis and historical context, this book gives an in-depth, accessible account of how the case unfolded and what it might mean for Oklahomans, the Muscogee (Creek) Nation, and other tribes throughout the United States. Do we have a reservation or not? The

McGirt decision says we do.

One of the most quoted attorneys regarding the McGirt decision is Robert Miller, an Eastern Shawnee Tribal Citizen. Miller has served as Judicial Law Clerk for a Federal Judge, Instructor and Professor, Attorney at Law and currently serves as Tribal Judge for three different tribes and the Northwest Intertribal Court System as Appellate Judge. A Professor of Law at the Sandra Day O'Connor College of Law at Arizona State University since 2013, Robert has authored several books and numerous articles. He co-authored "A Promise Kept: The Muscogee (Creek) Nation and McGirt v. Oklahoma" that has been selected as the January 2023 book of the month by the NPR affiliate in Oklahoma, KGOU.

Robert Miller's speech was thorough, filled with facts and delivered in a lively, humorous but thought-provoking way. He brought 35 of his books, selling and autographing everyone, clearly illustrating how much people enjoyed his presentation. Job well done Robert. We might ask him if he would come back to speak to all our employees.

Do you remember our Summer Youth Employment Program begins in a few short weeks. Applicants need to be Eastern Shawnee, at least 16 years of age, will be attending school the following year. Pay is \$13 per hour. For information contact HR Director Kendra Stuart.

Finally, let me end with more good news. We are going to begin to have a quarterly free Tribal Community Dinner and Fellowship event. The first will be Friday, May 19 at 5:30 p.m. outdoors behind BlueJacket Building. We will provide the meal, but you need to provide the lawn chairs. By mid-May it should be warmer and if it rains we can either go inside BlueJacket Building or assemble under the former bull pens at Bordertown Bingo and Casino, now referred to as the Arbor. We will eat, play games, perhaps have a short history or culture talk, possibly some music. The intent is to gather with our fellow tribal members, relax, have a good time with food, fun, and fellowship for all ages.



The meal is free, so come and join us.

Congratulations to all who are graduating this year and mothers, enjoy Mother's Day.



- <u>Dial 918-678-3244</u>. It can be found in the upper right hand portion of your prescription label. (It is circled in red in the example below.) Have your prescription bottle handy.
- 2. Follow the voice instructions given.
- 3. Press 1 to refill a prescription.
- 4. Enter your prescription number. PLEASE USE THE MOST RECENT PRESCRIPTION BOTTLE as it will have the most recent prescription number!

The prescription number is located just above your name on the label. This number and your name are both highlighted in yellow. It is circled in blue in the example attached.



- The system will ask you to confirm the first three letters of the last name on the prescription. Press 1 if it is correct.
- 6. If you need to enter another prescription, press 1, if not press 2.
- 7. That's it! Pretty simple.
 - Please keep in mind that refills called in during business hours will be ready the following business day after 1pm.



REFILLS BY MAIL

As of October 17, 2022, Medication Refills will be available by mail for *most* chronic medications. We are pleased to offer this service as a way for our patients to save time and money.

New prescriptions will not be mailed. These must be picked-up at the clinic.

How do I get started with Refills by Mail?

- <u>Enrollment</u> must be made in person at Bearskin Healthcare Pharmacy. A form will be available for each patient to register for refills by mail. Patients under the age of 18, must have a parent/guardian signature.
- To request refills, call the <u>Automated Refill Line: 918-678-3244. This is the number</u> on your prescription label. If you get a message that says your prescriptions are on "HOLD" or "there are no refills remaining" the Pharmacy will get these messages and process them accordingly. If you are told by the automated system that it is too early to refill your medications, call back 7 days prior to running out of meds.
- <u>ALWAYS UPDATE</u> your current address and telephone number with Registration AND the Pharmacy. If packages are returned due to incorrect addresses you will be disenrolled from the Refill by Mail program.
- 4. You may call in to request refills up to 7 days early to allow time for processing and mailing. NOTIFY THE PHARMACY if you have not received your meds within 7 days, otherwise non-notification will be accepted as confirmation of medication delivery.
- <u>Controlled medications</u> (Tylenol with Codeine, clonazepam, tramadol, Lyrica, butalbital products, diphenoxylate/atropine, testosterone injection/gel, Provigil, and others) will not be eligible for refills by mail.
- 6. <u>CHECK your mail regularly</u> on the days following your requests to help prevent loss and exposure to the elements. If you have several medications you may receive more than one package. If you repeatedly have medications which come up missing we may disenroll you from the RBM program.
- 7. <u>PLEASE CONSOLIDATE</u> refill requests as much as possible to help keep postage costs down.

The pharmacy reserves the right to dismiss any patient from the program as necessary. Reasons for dismissal include but are not limited to; returned deliveries, missed or denied receipt of medications, chronic early refill requests, failure to keep scheduled appointments, etc.
