Solar Eclipse: April 8, 2024 Watch Party

On April 8, 2024, a total solar eclipse will cross over North America. The last total eclipse crossed Earth on March 9, 2016 and the next one will not occur until August 23, 2044; however, it will lack the broad reach across the US like this one. This centerline of the eclipse enters Oklahoma at approximately 12:28 pm, with Totality occurring at about 1:45 pm.

We will be hosting an Eclipse Watch Party that day at the ESTOO Pow Wow Grounds and would like to invite all who are available to attend. Bring your chairs and a friend and let's all enjoy this event together. We will provide the Eclipse Glasses to the first 100 people beginning at 12:00 pm.

THE CHIEF'S REPORT

Hatito Fellow Tribal Citizens,

Let's begin with an important announcement. Friday, June 7 is the official date set for the Grand Opening of the new Interpretive Center at Ohio's newest state park, The Great Council located near Xenia, or Old Town, there in Ohio in the area where Tecumseh was born. This Interpretive Center honors the three federally recognized Shawnee Tribes and includes other historical happenings of that time period, specifically Daniel Boone. We are planning a four- or five-day trip for that opening beginning Thursday June 6 through either Sunday the 9th or Monday June 10. We will travel Thursday, June 6, attend the Grand Opening on the 7th and then visit several of the Ohio World Heritage Earthworks contained within eight sites found at Fort Ancient in Warren County, the Newark Earthworks in Licking County, and the Hopewell Culture National Historical Park in Ross County. These special and sacred places were built by American Indians between 1,600 and 2,000 years ago. Hopefully, we will also be able to make a stop at an Amish location.

That means if the numbers warrant it, we will be traveling in a bus and staying in motels two persons per room. The two travel days will be long, as it will take a minimum of 12 hours to journey from Oklahoma to Ohio. We can take up to 50 individuals. Priority will be given to Eastern Shawnee tribal citizens first, their spouses next, followed by Eastern Shawnee employees, then other tribal citizens such as Shawnee Tribe, Absentee Shawnee Tribe, or other Tribes, followed by non-tribal individuals. If you are

interested in going on the trip, contact Shelly Rogers, 918-238- 5151. Final details will be announced in next month's Shooting Star.

Another special event steeped in Shawnee history occurs Monday, April 8 and is known by many as Tecumseh's Eclipse. This eclipse occurred originally June 16, 1806, when Tecumseh and his brother Tenskwatawa (later known as The Prophet or The Open Door) united other Native Americans to fight against the United States and defend Native American lands. To quote and sometimes summarize good friend Scott Bentley and staff members of River Raisin Nation Park located in Michigan: "The conflict started with Americans killing Native Americans for their land, and it quickly blew up into a full-scale war where Americans fought Native American, British and British-Canadian armies to keep control of the Michigan Territory and land that would later become several other states."

Tenskwatawa has a colorful history. Born a triplet, he was given the name Lalawethika or He Makes a Loud Noise or The Noise Maker due to colic and digestive issues. He lost an eye at an early age, was never warrior material as his older brothers Chicksika and Tecumseh, ultimately going from a hapless, alcoholic youth to an influential spiritual leader. One day, Tenskwatawa fell unconscious. He was unresponsive for so long that Tecumseh and others thought he was dead, so they started preparing his body for burial. While being prepared for burial, Tenskwatawa suddenly woke up, and told the people around him that he'd just had a vision. Tenskwatawa saw two worlds. One was a paradise with Native People following their traditional ways and rejecting white European culture including the consumption of alcohol. The other was a world of pain and suffering where Native Americans have adopted European culture. This is how Tenskwatawa became known as the "the Open Door," or "the Prophet,"

The primary opponent to Tecumseh's and The Prophet's vision was William Henry Harrison who later became the 9th President of the United States. General Harrison saw Tecumseh and Tenskwatawa as a threat, so he set out to make Tenskwatawa look like a fool. General Harrison thought the best way to

discredit Tenskwatawa was to issue him a challenge only a true prophet could accomplish. General Harrison wrote: 'If he is really a prophet, ask of him to cause the sun to stand still—the moon to alter its course the rivers to cease to flow—or the dead to rise from their graves.'" Tenskwatawa heard and accepted General Harrison's challenge stating that the Great Spirit was angry at Harrison and would give a sign. "Fifty days from this day there will be no cloud in the sky. Yet, when the Sun has reached its highest point, at that moment will the Great Spirit take it into her hand and hide it from us. The darkness of night will thereupon cover us and the stars will shine round about us. The birds will roost and the night creatures will awaken and stir." On that day, June 16th, 1806, there was an eclipse, and Harrison's attempt to divide the Shawnee people backfired spectacularly. Then Tecumseh ordered the Great Spirit to release the sun. That reoccurring black sun is now known as Tecumseh's Eclipse. So how could Tenskwatawa have predicted the event? As it turns out, even though the movement of the moon and sun can seem chaotic, they actually move in predictable ways, so eclipses happen on a regular and predictable schedule. This predictable pattern is called the Saros Cycle and cultures have used it to predict eclipses all the way back to ancient Iraq in 700 BCE. This is around 2,500 years before Tenskwatawa's prophecy.

Many generations of indigenous people built sophisticated earthworks that interacted with the solar and lunar cycles. The solar cycle is the cycle the sun's magnetic field goes through about every 11 years. The lunar cycle is the phase the moon moves through about every 30 days. Long before Europeans arrived in North America, indigenous communities understood the complex mathematics behind how the sun and moon interact. To predict when the sun would stand still and the moon alter its course was something that Tenskwatawa and other indigenous people would be able to do because of their deep understanding of the solar and lunar cycles. So, check out your location and look for Tecumseh's Eclipse Monday, April 8.

We have exciting news to share with you. We have been awarded a new ICDBG HUD grant in the amount of 2,000,000 to expand our Wellness Center. That's right—2million. The expansion will include three major additions. One will be the

addition of a new weightlifting room. Weightlifting is one of our most used spaces but is also the smallest room or area we currently have. Another well used area is our therapy pool which is heavily scheduled. A second therapy pool will enable more individuals to use our facility. The third major addition will be a community room in our Wellness Center. Here people may rent space for a birthday party, family gathering, special occasion or we can provide space for meetings, afternoon cards, etc. The possibilities are endless and we are anxious to get started. Congratulations to grant writer Brian Perry and Wellness Center Director Ron Wallace and all Wellness Center employees. The real winners are all those who use the Wellness Center. Building a new Government Building, 110 Road and now an addition to the Wellness Center—we are busy, busy, busy.

I also want to remind you that our annual Elders Dinner will be held the last Friday in April, specifically April 26 at our AOA. For those coming from out of town, you will be able to see the progress on our Governmental Building and 110 Road. Mark those calendars and plan to attend. Several drive considerable distance to attend this banquet and stay overnight at Indigo Sky at discounted prices. This event has become like a family reunion, an Eastern Shawnee Family Reunion, so I look forward to seeing many of you. Following our Elders Dinner will be our Education Banquet on May 31st. More about that next month.

I want to thank everyone for the prayers lifted up on behalf of my 36 year old granddaughter Jordan who gave birth to Sophia Rush, 7 lbs and 14 ozs and just days later had a stroke and had to be med flighted from Joplin to Springfield, Mo where she was in ICU for more than a week following surgery for a blood clot the size of a plum on her brain. Jordan is now home, improving every day. I am so grateful to all of you.

Please continue to keep good thoughts for Bud Nelson and add George Blanchard, husband of Kathleen Blanchard, to that list. George had triple by pass surgery recently. Condolences to the John Irwin family on the loss of his mother, Jean Kelly. Recent personnel changes include the retirement of Sharon Farris, our Benefits Director for the last 16 years and congratulations go to Amanda Triplett Wallace, our new Benefits Director. Shortly after this

change, Karen Hamilton, the assistant in the AOA, announced that she would be retiring as well. Karen worked for the tribe for the last 16 years. We are sad to see them leave, but happy for them to enjoy a more leisurely life.

April is Sexual Assault Awareness Month

For Sexual Assault Awareness Month (April), we're focusing on defining what is sexual assault, what is rape, what is force and who are perpetrators, and what is consent.

Sexual assault can take many different forms, but one thing remains the same: **it's never the victim's fault.**

What is sexual assault?

The term sexual assault refers to sexual contact or behavior that occurs without explicit consent of the victim. Some forms of sexual assault include:

- Attempted rape
- Fondling or unwanted sexual touching
- Forcing a victim to perform sexual acts.
- Penetration of the victim's body, also known as rape

What is rape?

Rape is a form of sexual assault, but not all sexual assault is rape. The term rape is often used as a legal definition to specifically include sexual penetration without consent.

What is force?

Force doesn't always refer to physical pressure. Perpetrators may use emotional coercion, psychological force, or manipulation to coerce a victim into non-consensual sex. Some perpetrators will use threats to force a victim to comply, such as threatening to hurt the victim or their family or other intimidation tactics.

Who are the perpetrators?

The majority of perpetrators are someone known to the victim. Approximately eight out of 10 sexual assaults are committed by someone known to the victim, such as in the case of intimate partner sexual violence or acquaintance rape.

The term "date rape" is sometimes used to refer to acquaintance rape. Perpetrators of acquaintance rape might be a date, but they could also be a classmate, a neighbor, a friend's significant other, or any number of different roles. It's important to remember that dating, instances of past intimacy, or other acts like kissing do not give someone consent for increased or continued sexual contact.

In other instances, the victim may not know the perpetrator at all. This type of sexual violence is sometimes referred to as stranger rape.

Survivors of both stranger rape and acquaintance rape often blame themselves for behaving in a way that encouraged the perpetrator.

It's important to remember that the victim is never to blame for the actions of a perpetrator.

What is Consent?

Consent is a clear "yes" to sexual activity.

Not saying "no" does not mean you have given consent.

Sexual contact without consent is sexual assault or rape.

Your consent means:

- You know and understand what is going on (you are not unconscious, blacked out, asleep, underage, or have an intellectual disability).
- You know what you want to do.
- You are able to say what you want to do or don't want to do.
- You are aware that you are giving consent (and are not impaired by alcohol or drugs).

Sometimes you cannot give legal consent to sexual activity or contact — for example, if you are:

- Threatened, forced, coerced, or manipulated into agreeing
- Not physically able to (you are drunk, high, drugged, passed out, or asleep)
- Not mentally able to (due to illness or disability)

- Under the age of legal consent, which varies by state

Remember:

- Consent is an ongoing process, not a one-time question. If you consent to sexual activity, you can change your mind and choose to stop at any time, even after sexual activity has started.
- Past consent does not mean future consent. Giving consent in the past to sexual activity does not mean your past consent applies now or in the future.
- Saying "yes" to a sexual activity is not consent for all types of sexual activity. If you consent to sexual activity, it is only for types of sexual activities that you are comfortable with at that time with that partner. For example, giving consent for kissing does not mean you are giving consent for someone to remove your clothes.

Breastfeeding FAQs: Getting Started

Breastfeeding is natural, but it takes practice to get it right. Here's what you need to know about getting started.

When Will My Milk Come In?

For the first few days after your baby's birth, your body will make colostrum, a nutrient-rich "pre-milk." Colostrum (kuh-LOSS-trum) has many benefits, including nutrients that boost a baby's immune system and help fight infection.

For some women, colostrum is thick and yellowish. For others, it is thin and watery. The flow of colostrum is slow so that a baby can learn to nurse — a skill that requires a baby to suck, breathe, and swallow.

After 3–4 days of making colostrum, your breasts will start to feel firmer. This is a sign that your milk supply is increasing and changing from colostrum to mature milk. Your milk may become whiter and creamier, but this varies between women.

If your milk takes longer to come in, don't worry.

CONT.

This is normal and usually isn't a cause for concern, but let your doctor know. While babies don't need more than colostrum for the first few days, the doctor may need to make sure your baby's getting enough to eat. It can help to breastfeed often during this time to stimulate your milk production.

When Should I Begin Breastfeeding?

If possible, start nursing within an hour of your baby's birth. Babies tend to be alert in the first few hours of life, so breastfeeding right away takes advantage of this natural wakefulness. After this, newborns will sleep for most of the next 24 hours. At that point, it might be harder to get your baby to latch on.

When placed on your chest, your baby will naturally "root" (squirm toward the breast, turn the head toward it, and make sucking motions with the mouth). To breastfeed, babies latch onto the breast by forming a tight seal with the mouth around the nipple and areola (the dark part of skin around the nipple). Even if your baby doesn't latch on now and just "practices," it's still good for your baby (and you!) to get used to practicing breastfeeding.

In the first few days of life, your baby will want to feed on demand, usually about every 1–3 hours, day and night. As babies grow and their bellies can hold more milk, they may go longer between feedings.

How Can I Tell When My Baby's Ready to Nurse?

On-demand feeding means breastfeeding whenever your baby seems hungry. How can you tell? Hungry babies:

- move their head from side to side
- open their mouth
- stick out their tongue
- suck on their hands and fists
- pucker their lips as if to suck
- nuzzle against mom's breasts
- show the rooting reflex (when a baby moves their mouth in the direction of something that's stroking or touching their cheek)

Crying is a late sign of hunger. So try to nurse before your baby gets upset and harder to calm down.

To calm a crying or fussy baby before a feeding, try soothing "skin-to-skin" time. Dress your baby in only a diaper and place your little one onto your bare chest.

How Do I Get My Baby to Latch?

When your baby shows hunger signs, follow these steps:

- Make a "nipple sandwich." Hold your breast with your hand, and compress it to make a "nipple sandwich." An easy way to remember how to hold your hand: Keep your thumb by your baby's nose and your fingers by the chin. (The thumb and fingers should be back far enough so that your baby has enough of the nipple and areola — the darker circle of skin around the nipple — to latch onto.) Compressing your breast this way lets your baby get a deep latch. Your baby's head should lean back slightly, so their chin is touching your breast.
- Get your baby to open wide. Touch or rub your nipple on the skin between your baby's nose and lips. When this happens, your baby should open wide (like a yawn) with the tongue down.
- Bring your baby to your breast. When your baby's mouth is open wide, quickly bring your baby to your breast (not your breast to your baby). Your baby should take as much of the areola into the mouth as possible. Your baby's nose should almost touch your breast (not press against it) and their lips should be turned out ("flanged").

When your baby is properly latched on, you may have a few moments of discomfort in the beginning. After that, it should feel like a tug when your baby is sucking.

To make sure you're doing it right, it's best to be observed by a lactation consultant, or someone else who knows about breastfeeding.

How Do I Know My Baby Is Getting Enough to Eat?

Your baby's diapers can help you tell if your little one is eating enough. The more your baby nurses, the more dirty diapers you'll see.

Pee

Because colostrum is concentrated, your baby may have only one or two wet diapers in the first 24 hours. After 3–4 days, look for:

- 6 or more wet diapers per day, with clear or very pale pee. Fewer wet diapers or darker pee may mean your baby's not getting enough to drink. If you see orange crystals in a wet diaper, call your baby's doctor. They're common in healthy, well-fed babies and usually not a cause for concern.

But sometimes they're a sign that a baby isn't getting enough fluids.

Poop

A newborn's poop is thick and tarry at first, then more greenish-yellow as mom's milk comes in. After 3–4 days, look for:

- 4 or more yellow, seedy poops per day, usually one after each feeding. After about a month, babies poop less often and many may go a few days without pooping.

Your baby probably is getting enough milk if he or she:

- feeds 8–12 times a day
- seems satisfied and content after eating
- sleeps well
- is alert when awake
- is gaining weight

If you're worried that your baby isn't getting enough to eat, call your doctor.

I'm Having a Hard Time. What Can I Do?

Nursing takes time and practice. In fact, it can be one of the most challenging — and rewarding — things you do as a new mom.

While you're in the hospital, ask for help from a lactation consultant, the nursing staff, your baby's pediatrician, or your OB-GYN. When you get home, see if there's a lactation consultant in your area. You can search online at:

The pediatrician will want to see your baby 24–48 hours after you leave the hospital. During [this visit](#), the doctor will check your baby's weight and your feeding technique. If you have trouble or questions before then, call the doctor.

Whatever you do, don't let it get you down. With a little patience and some practice, breastfeeding is likely to get easier.

For more help or if you have questions, talk to a lactation consultant, your doctor, or someone who knows about breastfeeding.

Hello students!

I have an exciting announcement regarding an additional scholarship opportunity that has been granted to the Education Department. Thanks to Aristocrat Gaming, we have an allowance for an additional outside scholarship available to students. Following are the details.

The Aristocrat Gaming Scholarship fund is a needs-based scholarship for those tribal members receiving post-secondary Education benefits through the tribe. As a needs-based scholarship the student must provide the Education Department with evidence of the need for funds to cover post-secondary education expenses that exceed any FAFSA oriented grants or other scholarships they receive. This shall be done by providing a list of all other scholarships and grants obtained compared to the students list of expenses/ charges. Students in STEM based programs will have priority in receiving funding.

A maximum disbursement of \$2500 per academic year will be equally distributed between either two semesters (Fall, Spring) or three trimesters (Fall, Winter, Spring) per each student who demonstrates the need and qualifies until the funds have been depleted. There is a maximum of 20 applications allowed per academic year.

To apply for this scholarship, the student must fill out the Aristocrat Gaming Scholarship application and provide supporting listed documents. Funding will begin each Spring semester for the academic year. Deadline to apply for each academic year will be March 1st. A selection committee of three people will evaluate the applications for approval.

As stated, the deadline will generally be March 1st however, for this first academic year disbursal, an allowance will be made to accept applications beginning now until filled for this year. Please note students in stem-based programs will have first priority and must demonstrate a need for the additional funding.

April showers bring May thistles? The days are getting warmer and hopefully April brings plenty of showers, but with the warmer weather and the April showers those pesky thistles will be sprouting up and blooming. So how can you control this obnoxious weed and keep it from spreading across the country side? There are five invasive thistles of immediate concern in Oklahoma according to Oklahoma State University. They are bull thistle, musk thistle, scotch thistle, distaff thistle, and Canada thistle. These five thistles were introduced from Europe and Eurasia where diseases and insects do not present in the United States kept their populations at tolerable levels. Oklahoma Thistle Law declares musk, scotch, and Canada thistles to be noxious weeds and public nuisances in all counties of the state and a "Plan of Action" for control by all landowners whose land is infested should be developed or already developed by the State. It is important to properly identify and control the five introduced invasive thistle species.

Thistles spread by the movement of seed-contaminated hay and wind or water dispersion into uninfested areas. Preventing the spread of thistles requires cooperation among all landowners. The use of feed and hay from infested areas should be avoided if invasive thistles are not present. Do not allow thistles to seed out around your area. If you find thistles, destroy them immediately by cutting off their root system below ground or spraying them with herbicide before they produce seed. One plant can produce up to 10,000 seeds with some seeds continuing to germinate for as long as nine years.

There are a few methods that can be used to control thistles. The first method is Mechanical Control, which is the usage of tillage implement, hoe, or spade to cut the thistles below the crown area. Also mowing can prevent seed production, but should be done as close to the ground surface as possible. The next control method is Chemical Control. The best time to apply herbicide is in the spring. The most common herbicides are 2, 4-D; Transline; Grazon P+D; Weedmaster; and Cimarron just to name a few. Some of these chemicals can be found at your local feed stores. Some chemicals require special license for purchase.

It is a lot of time and work to keep thistles out of fields, but if everyone does their part, we can get the thistle population down to where they are more controllable. If you need more information you can check out The Oklahoma State University web site in their division of Agricultural Sciences and Natural Resources.

"Recovering Ohio's Indigenous Voices" is an Ohio-America 250 event encouraging public engagement with invited artists from Ohio's Removed Tribes, Native American peoples forcibly removed by the government in the 1800's. This event is intended to enhance the visibility of contemporary indigenous artists from the Removed Tribes and raise awareness of the Native American presence in Ohio—a state where tribal communities once flourished but struggle today to attain visibility and agency. Artists will present and discuss their artwork, reflecting their indigenous values and tribal traditions. The artists will also tour the Hopewell Ceremonial Earthworks for an opportunity to connect with the monumental sites created by the ancestors of their ancestors.

Event Date: October 9 - 16, 2024

Submission deadline: July 1, 2024

Program Summary:

The program invites participation from artists connected through ancestry to Ohio's Removed Tribes, including Shawnee, Potawatomi, Wyandot, Delaware, Miami, Seneca-Cayuga, Ojibway, Peoria, Ottawa, and other tribes, nations and bands from the Ohio River Valley.

How to make a submission and submission deadline?

Supply the five requests listed below, following all the guidelines and submitting the information prior to midnight ET on July 1, 2024. Where to submit? Send applications to belinda@greatcirclealliance.com

How does it work? A panel of four art professionals, both Native and non-Native, will assess applications and select three artists for the project.

Applications will include

1. Your resume or Curriculum Vitae. (Please note formal art school training is not required.)
2. Artist's Statement including a brief summary about how your work expresses indigenous values and your tribal traditions.
3. Formal enrollment in a federally recognized tribe is not a requirement, but each artist should be recognized by their community, be able to articulate traditional tribal values and world view, and demonstrate a developed artistic practice. Please include a letter of support from one Community Member.
4. Portfolio: 5-10 images of past work. Artwork can be in any medium (painting, drawing, sculpture, printmaking, mixed media, literary art, performance art, video, etc.). Submit high-quality .jpg files for still images & .mp3, .mp4, or .mov files for videos.
5. For each item please include: • your name • title of work • materials • dimensions • date created. If files are too large to send as email attachments, please send them at no charge through [WeTransfer.com](https://www.wetransfer.com) to belinda@greatcirclealliance.com and send an email to the same address telling us when they were sent.

What happens if you are selected?

1. Artists will be invited to travel to Ohio on October 10 for six days (five nights) and return home on October 15, 2024. The Great Circle Alliance will make flight reservations if the artist does not live within easy driving distance of Columbus, Ohio. Accommodation and a per diem (\$ amount) for meals are provided.
2. During the stay artists will tour the Hopewell Ceremonial Earthworks, recently designated as World Heritage sites.
3. The artists will be asked to present an Artist Talk on October 14, 2024 (Indigenous Peoples Day) showing examples of their artwork, using slides or a display of small artworks, and discuss their content as expressions of indigenous values and tribal traditions. The artists may choose to publicly reflect on their experience of returning to the Ohio River Valley, the ancestral homeland of their tribe or nation, and also viewing the Earthworks built by the "ancestors of their ancestors" (Chief Glenna Wallace, Eastern Shawnee).
4. Each artist will receive a stipend of \$1,000 in addition to travel, accommodations, and per diem for participating in the program. The stipend covers any artwork shipping expenses for the public program as well as a fee for presenting the talk on October 14.
5. After returning to their home studio on October 15, and if the artists agree to participate in an exhibition in Ohio in 2025, each artist will receive an additional stipend of \$1,000, producing at least three artworks for the exhibition, reflecting on their experience in Ohio during their visit (10/10/24 - 10/15/24). Additional funding will be available in 2025 to further support the artists work, to ship artwork, and to return to Ohio for the exhibition opening and at least one public event.

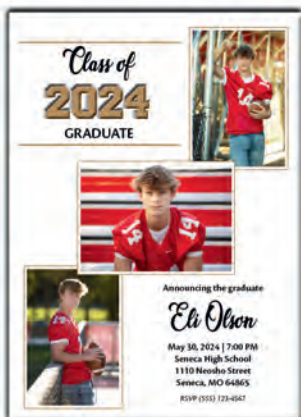

BUSINESS COMMITTEE MINUTES FOR JANUARY 2024

CALL TO ORDER, ROLL CALL, DECLARATION OF QUORUM:

The Business Committee Meeting was called to order at 5:33 p.m. by 2nd Chief Chris Samples, with the following answering roll call: 1st Council Clint Kisse, 2nd Council Shawn Daugherty, 3rd Council Norma Kraus, Secretary Kathie Kent, Treasurer Justin Barrett, and 2nd Chief Chris Samples were present. A quorum was declared by 2nd Chief Samples. Chief Glenna J. Wallace was also present.

NEW ENROLLEES:

No new enrollees.

MOTION: To approve the January 24, 2024, Business Committee Meeting Minutes. The motion was made by Treasurer Barrett, with second by 3rd Council Kraus.

REPORTS:

Chief's Report.

Habitat for Humanity sent a thank you for the \$5000.00 in donations to help build a house.

Director's reports were sent out.

Here is an update on the 110 Rd. project, that began work the 2nd week in January. They seem to be ahead of schedule. They are having some groundwork issues with all the mud. The cost estimate with the company that did the review and design for the road was \$3.6M Eastern Shawnee Tribe of Oklahoma bid out the work, low bid came in \$4.1M. The work was then rebid, to see if the cost of materials and such came down any, the low bid then came in at \$4.7M. The \$4.7M is the budget we are trying to work with. So, Eastern Shawnee Tribe of Oklahoma has identified about \$4,441,436.75 cash to pay. With that we are about \$300,000.00 short. We are still trying to come up with this money through Grants, the BIA, and any other resources. If at that time we don't come up with the money from other resources, it will come from ARPA funds. The reason for the odd figure \$4,441,436.75 is because we have \$2,441,000.00 in cash as Karen Allen identified.

Two things we need at the next meeting are Fiscal year 2024 Roads money \$140,000.00 maybe short of that amount just a little. We have not received that yet. We have a full-time BIA Supervisor working for us, he is out there onsite daily working full-time with the roads project. He will need to be paid \$50,000.00 out of this \$140,000.00.

We will need paperwork completed and ready for review by the Business Committee to take care of this matter. Then we will need a Resolution to borrow future Tribal Transportation program funds for the next five years, 2025, 2026, 2027, 2028 and 2029. No specific amounts but looking at an estimated amount of \$725,000.00 which will be the amount we will request in our Resolution. So, we can borrow from future Transportation payments or General fund. If we choose to borrow from the General fund. we can set an Interest rate. Chief is willing to listen to the Business Committee thoughts or take the advice of Karen Allen and whatever she recommends. If there is a preference or take recommendations of Karen, will that be satisfactory. The 2nd Chief Chris Samples explains the issue of funding being slow as discussed in previous meeting, in that case we will need to borrow from the General Fund.

Chief Glenna J. Wallace has a letter from Barry Hughes, Transportation Director from the Muskogee BIA office, about how to go about charging interest rates and how to handle this process.

The road construction, Chief Glenna J. Wallace would like to see it completed by the Eastern Shawnee Pow-Wow, not sure if it can be done but she has expressed this to the Contractors. That way maybe we can do a ribbon cutting ceremony during this time so the people can drive the road and see it. The road will consist of 1 major bridge and 2 smaller ones. Still a lot of work to be done down on the bottom, had to remove 11 of the maple trees planted 5 years ago for cultural purposes. Still a lot of work to be done but hopefully it can be done by Pow-Wow time.

Honoring our Youth event, JR Conrad, Wanda Stovall and Ceremonial Chief Shawn King were responsible for the February 3, event. They did a fantastic job. Several people were honored during the event, all those that spoke including the athletes, JR Conrad, Wanda Stovall for their outstanding work, and some of the Business Committee members. Those honored were blanketed, with highest honor. We hope to carry this on and get more young people involved in the future. Congratulations to all those that worked on that event and made it our print shop we advertised a vacancy there. As you all know Lora Nuckolls chose to take the Director of Cultural Preservation position. We had two excellent finalists, out of the applications received, and Tina Witten was selected. She will be starting her position February 20th. She brings a lot of experience and knowledge with her, and we are happy she accepted the offer.

The Director of Benefits, Sharon Farris, who has been with Eastern Shawnee Tribe of Oklahoma for 16 years has put in her time and says it is now time for her to retire. We wish Sharon all the best and so thankful for her time and hard work at Eastern Shawnee Tribe of Oklahoma. At the "All Staff Day" February 29th we will be honoring Sharon, her last day will be March 1st.

Congratulations to Justin Barrett for being in the "40 Under 40" it's a national honor. Chief Glenna J. Wallace pointed out that 2nd Chief Chris Samples was also a "40 Under 40" member. We are privileged to have them both as members of the Business Committee.

Eastern Shawnee Tribe of Oklahoma will be closed on President's Day.

The last 6 months the Eastern Shawnee Tribe of Oklahoma has been working on a "477 Program". We will be given \$25,000.00 for startup funding for training and conferences and to visit with other 477 tribes and writing a plan. The 477 will give the tribe more flexibility with program funding. Once the plan is complete, we will be sharing it with you.

The Chief received a letter that the McKiebbin properties are now in trust, which was 112.32 acres. That makes a total land in trust 1365.486 acres. The total land for the Eastern Shawnee Tribe of Oklahoma is 2,745 acres.
